## Executive Summary

### Financial

- **Crorepati Candidates:** Out of the 10 candidates analysed, 4 (40%) are crorepatis.
- **Average Assets:** The average assets per candidate contesting from Outer Manipur constituency is Rs.66.15 lakhs.
- **Candidates with liabilities:** Mani Charenamei, Independent candidate has declared liabilities worth Rs. 11.08 lakhs while Thangso Baite of INC has declared liabilities of Rs. 8.80 lakhs.
- **Candidates who have declared income:** Mani Charenamei, an Independent candidate has shown a total income of Rs 1.40 lakhs for the FY 2013-14
- **Undeclared PAN:** 2 (20%) out of 10 contesting candidates have not declared their PAN details.
- **Candidates who have not declared ITR\*:** 9 (90%) out of 10 contesting candidates have not declared their Income Tax Returns.

*\*Some candidates may be exempted from filing Income Tax Returns*
