## **Analysis of Financial Background and other Details of Candidates from Mizoram for Lok Sabha 2014 Elections**

### **Executive Summary**

Association for Democratic Reforms (ADR) and Mizoram Election Watch (MEW) have analyzed the self-sworn affidavits of all 3 candidates (as given by the ECI) who are contesting the Lok Sabha 2014 elections from Mizoram.

## Financial

- **Crorepati Candidates:** All the **3** candidates are crorepatis. **M. Lalmanzuala** of **AAP** has assets worth **Rs. 6.38 crores**, **C.L. Ruala** of **INC** has assets worth **Rs. 2.57 crores** while **Robert Romawia Royte**, an independent candidate has assets worth **Rs. 34.64 crores**.
- **Average Assets:** The average assets per candidate contesting in the Lok Sabha Elections of 2014 from Mizoram is **Rs. 14.53 crores**.
- **Undeclared PAN:** **1 (33%)** out of 3 candidates analysed, has not declared their PAN details.  
**Candidates who have not declared ITR:** All **3 (100%)** contesting candidates have not declared their Income Tax Returns.

\* Candidates may be exempted from filing Income Tax Returns
