Analysis of Total Income of Political Parties (Assessment Year 2006-2007 to 2011-2012)

- For the 6 assessment years considered, INC has the maximum total income of Rs. 1786.63 crore followed by BJP with Rs. 890.65 crore
- For 5 assessment years considered for BSP, its declared total income stands at Rs. 434.20 crore.
- CPI (M) has a total income of Rs. 377.38 crore followed by SP with Rs. 250.01 crore for the 6 assessment years.
- NCPs total income for the 6 assessment years stands at Rs. 148.73 crore.

- For the 6 assessment years considered, INC has the maximum total assets of Rs. 2471.45 crore followed by BSP with Rs. 1270.57 crore and BJP with Rs. 1221.57 crore.
- CPI (M) has total assets worth Rs. 988.56 crore followed by SP with Rs. 896.85 crore for the 6 assessment years.
- NCPs total assets for the 6 assessment years stands at Rs. 76.24 crore.
