

**विधायकों द्वारा घोषित वित्तीय, आपराधिक एवं अन्य विवरणों के आधार पर विश्लेषण
(छत्तीसगढ़ विधानसभा चुनाव 2013)**

छत्तीसगढ़ इलेक्शन वॉच (सी.ई.डब्ल्यू) और एसोसिएशन फॉर डेमोक्रेटिक रिफॉम्स (ए.डी.आर) ने 90 नवनिर्वाचित विधायकों के शपथपत्रों का विश्लेषण किया है जो छत्तीसगढ़ विधानसभा चुनाव 2013 में विजयी रहे हैं।

सारांश और मुख्य बिन्दु:

पुनः निर्वाचित विधायकों के आपराधिक पृष्ठभूमि और संपत्ति का तुलनात्मक अध्ययन

पुनः निर्वाचित विधायक:— छत्तीसगढ़ इलेक्शन वॉच (सी.ई.डब्ल्यू) और एसोसिएशन फॉर डेमोक्रेटिक रिफॉम्स ने पुनः निर्वाचित 22 विधायकों के शपथपत्रों का विश्लेषण किया।

पुनः निर्वाचित विधायकों द्वारा घोषित आपराधिक मामलें:— 2013 में पुनः निर्वाचित 3 विधायकों ने अपने ऊपर आपराधिक मामलें घोषित किये हैं। इन तीनों विधायकों ने 2008 विधानसभा में भी आपराधिक मामलें घोषित किये थे।

पुनः निर्वाचित विधायकों द्वारा 2013 चुनाव में घोषित औसतन संपत्ति वृद्धि:— पुनः निर्वाचित 22 विधायकों की औसत संपत्ति विधानसभा चुनाव 2013 में ₹ 3.16 करोड़ है। 2008 में इन विधायकों की औसतन संपत्ति ₹ 1.27 करोड़ थी। पुनः निर्वाचित 22 विधायकों की संपत्ति में 147 प्रतिशत (₹ 1.88 करोड़) की वृद्धि हुई।

औसतन संपत्ति वृद्धि, दलवार:— भाजपा के पुनः निर्वाचित 15 विधायकों ने 216 प्रतिशत (₹ 1.74 करोड़) की वृद्धि घोषित की है, इसके बाद कांग्रेस के पुनः निर्वाचित 7 विधायकों ने 96 प्रतिशत (₹ 2.18 करोड़) की वृद्धि घोषित की है।

अधिकतम संपत्ति वृद्धि—रूपयों में (2008 से 2013):— निर्वाचन क्षेत्र धमतरी से कांग्रेस विधायक गुरुमुख सिंह होरा ने अपनी सम्पत्ति में सबसे ज्यादा ₹ 5.66 करोड़ (94 प्रतिशत) की वृद्धि घोषित की है (2008 में ₹ 6.02 करोड़ से बढ़कर 2013 में ₹ 11.68 करोड़)। इसके बाद निर्वाचन क्षेत्र राजनांदगांव से भाजपा विधायक रमन सिंह की सम्पत्ति में ₹ 4.56 करोड़ (436 प्रतिशत) की वृद्धि हुई (2008 में ₹ 1.04 करोड़ से

बढ़कर 2013 में ₹ 5.61 करोड़) और निर्वाचन क्षेत्र धरसिवा से भाजपा विधायक देवजी भाई पटेल की सम्पत्ति में ₹ 4.15 करोड़ (709 प्रतिशत) की वृद्धि हुई (2008 में ₹ 58.60 लाख से बढ़कर 2013 में ₹ 4.73 करोड़)।

नोट:- गुरुमुख सिंह होरा (कांग्रेस) ने 2008 में एल.आई.सी पॉलिसी की कीमत घोषित नहीं की थी और देवजी भाई पटेल (भाजपा) ने 2008 में दो मोटर वाहन और दो एल.आई.सी पॉलिसी का मूल्य और धर्म देव सोलंकी (भाजपा) ने एक मोटर वाहन और एल.आई.सी पॉलिसी का मूल्य घोषित नहीं किया था।

- ☞ दलवार करोड़पति विधायक:- भाजपा के 49 में से 35 (71 प्रतिशत) विधायक, कांग्रेस के 39 में से 30 (77 प्रतिशत) विधायक और 1 विधायक बसपा से करोड़पति हैं। 1 निर्दलीय विधायक भी करोड़पति है।
- ☞ औसतन संपत्ति:- छत्तीसगढ़ विधानसभा चुनाव 2013 के विधायकों की प्रति औसतन संपत्ति ₹ 8.88 करोड़ है जबकि 2008 में विश्लेषित किये गये 85 विधायकों की प्रति औसतन संपत्ति ₹ 1.45 करोड़ थी।

- ☞ न्यूनतम संपत्ति घोषित करने वाले विधायक:— 1— निर्वाचन क्षेत्र मस्तूरी से कांग्रेस विधायक **दिलीप लहरिया** ने अपनी संपत्ति सबसे कम ₹ 5.23 लाख 2— निर्वाचन क्षेत्र भटगांव से कांग्रेस विधायक **पारसनाथ राजवाड़े** ने अपनी संपत्ति ₹ 9.46 लाख और 3— निर्वाचन क्षेत्र चित्रकोट से कांग्रेस विधायक **दीपक कुमार बैज** ने अपनी संपत्ति ₹ 10.53 लाख घोषित की है।
- ☞ अधिकतम देनदारिया घोषित करने वाले शीर्ष 3 विधायक:— कुल 11 विधायकों ने अपनी देनदारियां 50 लाख और इससे ज्यादा घोषित की है उनमें 1— निर्वाचन क्षेत्र कुरुद से **भाजपा विधायक अजय चन्द्राकर**—₹ 2.50 करोड़। 2— निर्वाचन क्षेत्र मनेन्द्रगढ़ से **भाजपा विधायक श्याम बिहारी जयसवाल**—₹ 1.16 करोड़ और 3— निर्वाचन क्षेत्र रायपूर सिटी उत्तर से **भाजपा विधायक श्रीचन्द्र सुन्दरानी**—₹ 87.37 लाख
- ☞ पैन विवरण घोषित ना करने वाले विधायक:— 90 में से 10 विधायकों ने अपने आयकर विवरण घोषित नहीं किये हैं।
- ☞ अधिकतम आय घोषित करने वाले विधायक:— निर्वाचन क्षेत्र कुरुद से **भाजपा विधायक अजय चन्द्राकर** ने अपने आयकर में सबसे ज्यादा ₹ 67.06 लाख वार्षिक आय घोषित की है। इसके बाद निर्वाचन क्षेत्र कसदौल से **भाजपा विधायक गौरी शंकर अग्रवाल** ने अपने आयकर में ₹ 45.64 लाख और निर्वाचन क्षेत्र राजनांदगांव से **भाजपा विधायक रमन सिंह** ने अपने आयकर में ₹ 32.26 लाख वार्षिक आय घोषित की है।

आपराधिक पृष्ठभूमि:

- ☞ विधायकों द्वारा घोषित आपराधिक मामले:— 90 में से 15 (17 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। विधानसभा चुनाव 2008 में 13 प्रतिशत विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये थे।
- ☞ विधायकों द्वारा घोषित आपराधिक मामले—दलवार:— भाजपा के 49 में से 6 (12 प्रतिशत) और कांग्रेस के 39 में से 9 (23 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।

- ☞ विधायकों द्वारा घोषित गंभीर आपराधिक मामले:- 15 में से 8 विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं। जैसे हत्या और अपहरण इत्यादि।
- ☞ गंभीर आपराधिक मामलों वाले उम्मीदवार जो पराजित रहें- :- गंभीर आपराधिक मामले घोषित करने वाले 66 विधायकों में से 58 चुनाव में पराजित रहें।

- ☞ हत्या से सम्बन्धित मामले:- निर्वाचन क्षेत्र मारवाही से कांग्रेस विधायक अमित ऐशवरी जोगी और निर्वाचन क्षेत्र बीजापूर से भाजपा विधायक महेश कुमार गगडा ने अपने ऊपर हत्या से सम्बन्धित मामला घोषित किया है।
- ☞ भ्रष्टाचार अधिनियम से सम्बन्धित अपराध:- निर्वाचन क्षेत्र मारवाही से कांग्रेस विधायक अमित ऐशवरी जोगी और निर्वाचन क्षेत्र वैशाली नगर से भाजपा विधायक विद्या रतन भसीन ने अपने ऊपर भ्रष्टाचार अधिनियम से सम्बन्धित मामला घोषित किया है।

अन्य विवरण (शिक्षा, महिला उम्मीदवार, आयु)

- ☞ विधायकों की शैक्षिक योग्यता: कुल 53 (59%) विधायक (90 विश्लेषित विधायकों में से) स्नातक अथवा इससे अधिक शिक्षित हैं। 36 (40%) विधायक 12वीं पास अथवा इससे कम शिक्षित हैं।
- ☞ आयु के आधार पर विधायक: विश्लेषित 90 में से 17 (19%) विधायकों ने अपनी आयु 40 वर्ष और इससे कम घोषित की है जबकि 27 (30%) विधायकों ने अपनी आयु 41 से 50 वर्ष के बीच घोषित की है। 13 (14 प्रतिशत) विधायकों ने अपनी आयु 60 वर्ष घोषित की है।

☞ **महिला विधायक:** छत्तीसगढ़ विधानसभा चुनाव 2013 में 90 में से कुल 10 (11%) महिला विधायक है।
