विधायकों द्वारा घोषित वित्तीय, आपराधिक एंव अन्य विवरणों के आधार पर विश्लेषण (दिल्ली विधानसभा चुनाव 2013)

सारांश और मुख्य बिन्दु:

दिल्ली इलेक्शन वॉच (डी.ई.डब्ल्यू) और एसोसिएशन फॉर डेमोक्रेटिक रिफोर्म्स (ए.डी.आर) ने 70 नवनिर्वाचित विधायकों के शपथपत्रों का विश्लेषण किया है जो दिल्ली विधानसभा चुनाव 2013 में विजयी रहे हैं।

नोटा: नोटा के बटन का इस विधानसभा में प्रयोग किया गया है। जिसमें नोटा को 49892 वोट मिले जिसमें नोटा को निर्वाचन क्षेत्र विकासपूरी से सबसे ज्यादा 1426 वोट मिले और सबसे कम वोट 296 निर्वाचन क्षेत्र मटिया महल से मिले।

पुनः निर्वाचित विधायकों के आपराधिक पृष्ठभूमि और संपत्ति का तुलनात्मक अध्ययन

पुनः निर्वाचित विधायकः— दिल्ली इलेक्शन वॉच (डी.ई.डब्ल्यू) और एसोसिएशन फॉर डेमोक्रेटिक रिफोर्म्स ने पुनः निर्वाचित 22 विधायकों के शपथपत्रों का विश्लेषण किया।

पुनः निर्वाचित विधायकों द्वारा घोषित आपराधिक मामले— 2013 में पुनः निर्वाचित 15 विधायकों ने अपने ऊपर आपराधिक मामलों घोषित किये हैं। इनमें से 10 विधायकों ने 2008 विधानसभा में भी आपराधिक मामले घोषित किये थे।

पुनः निर्वाचित विधायकों द्वारा 2013 चुनाव में घोषित औसतन संपत्ति वृद्धि— पुनः निर्वाचित 22 विधायकों की औसत संपत्ति विधानसभा चुनाव 2013 में ₹ 14.22 करोड़ है। 2008 में इन विधायकों की औसतन संपत्ति ₹ 3.24 करोड़ थी। पुनः निर्वाचित 22 विधायकों की संपत्ति में 338 प्रतिशत (₹ 10.97 करोड़) की वृद्धि हुई।

औसतन संपत्ति वृद्धि, दलवारः— भाजपा के पुनः निर्वाचित 13 विधायकों ने 392 प्रतिशत (₹ 14.10 करोड़) की वृद्धि घोषित की है, इसके बाद कांग्रेस के पुनः निर्वाचित 8 विधायकों ने 237 प्रतिशत (₹ 7.20 करोड़) और जेडीयू के नवनिर्वाचित 1 विधायक ने 164 प्रतिशत (₹ 45.89 लाख) की वृद्धि घोषित की है।

अधिकतम संपत्ति वृद्धि-रूपयों में (2008 से 2013):— निर्वाचन क्षेत्र विजवासन से भाजपा विधायक सतप्रकाश राणा ने अपनी सम्पत्ति में सबसे ज्यादा ₹ 105.51 करोड़ की वृद्धि घोषित की है (2008 में ₹ 6.38 करोड़ से बढ़कर 2013 में ₹ 111.89 करोड़)। इसके बाद निर्वाचन क्षेत्र बदली से कांग्रेस विधायक देवेन्द्र यादव की संपत्ति में ₹ 20.04 करोड़ (271 प्रतिशत) की वृद्धि हुई (2008 में ₹ 7.38 करोड़ से बढ़कर 2013 में ₹ 27.43 करोड़) और निर्वाचन क्षेत्र पालम से भाजपा विधायक धर्म देव सोलंकी की सम्पत्ति में ₹ 18.01 करोड़ (191 प्रतिशत) की वृद्धि हुई (2008 में ₹ 9.42 करोड़ से बढ़कर 2013 में ₹ 27.43 करोड़)।

नोट:— सतप्रकाश राणा (भाजपा) ने 2008 में दो मोटर वाहन की कीमत घोषित नहीं की थी। देवेन्द्र यादव (कांग्रेस) ने 2008 में दो मोटर वाहन और दो एल.आई.सी पॉलिसी का मूल्य और धर्म देव सोलंकी (भाजपा) ने दो मोटर वाहन और एल.आई.सी पॉलिसी का मूल्य घोषित नहीं किया था।

- ☞ **अधिकतम संपत्ति घोषित करने वाले शीर्ष 3 विधायक:**— 1— निर्वाचन क्षेत्र राजौरी गार्डन से शिरोमणि अकाली दल विधायक मनजिंदर सिंह सिरसा की ₹ 235.51 करोड़। 2— निर्वाचन क्षेत्र बिजवासन से भाजपा विधायक सतप्रकाश राणा की ₹ 111.89 करोड़ और 3— निर्वाचन क्षेत्र पालम से भाजपा विधायक धर्म देव सोलंकी की ₹ 27.43 करोड़।

- ☞ संपत्ति के आधार पर जीतने की संभावनाएँ: करोड़पति उम्मीदवारों के जीतने की संभावनाएँ 26 प्रतिशत हैं जबकि कम संपत्ति वाले उम्मीदवारों की संभावना 7 प्रतिशत है।

- ☞ **न्यूनतम संपत्ति घोषित करने वाले विधायक:**— 1— निर्वाचन क्षेत्र सीमापूरी से आम आदमी पार्टी विधायक धर्मेन्द्र सिंह कौली ने अपनी संपत्ति सबसे कम ₹ 20,800, 2— निर्वाचन क्षेत्र मंगोलपूरी से आम आदमी पार्टी विधायक राखी बिरला ने अपनी संपत्ति सबसे कम ₹ 51,150 और 3— निर्वाचन क्षेत्र मोडल टाउन से आम आदमी पार्टी विधायक अखिलेख पती त्रिपाठी ने अपनी संपत्ति सबसे कम ₹ 1.59 लाख घोषित की है।
- ☞ **अधिकतम देनदारिया घोषित करने वाले शीर्ष 3 विधायक:**— कुल 12 विधायकों ने अपनी देनदारियां 1 करोड़ और इससे ज्यादा घोषित की है उनमें 1— निर्वाचन क्षेत्र राजौरी गार्डन से शिरोमणि अकाली

दल उम्मीदवार मनजिंदर सिंह सिरसा—₹ 32.01 करोड़। 2— निर्वाचन क्षेत्र पटेल नगर से आम आदमी पार्टी विधायक वीना आनन्द—₹ 7.60 करोड़ और 3— निर्वाचन क्षेत्र त्रिनगर से भाजपा विधायक नन्द किशारे गर्ग—₹ 5.59 करोड़

- ☞ निर्वाचन क्षेत्र सीमापूरी से आम आदमी पार्टी विधायक धर्मेन्द्र सिंह कौली ने अपना पैन विवरण घोषित नहीं किया है।
- ☞ आयकर घोषित ना करने वाले उम्मीदवार:— 7 विधायकों ने अपने आयकर विवरण घोषित नहीं किये हैं।
- ☞ अधिकतम आय घोषित करने वाले उम्मीदवार:— निर्वाचन क्षेत्र राजौरी गार्डन से शिरोमणि अकाली दल विधायक मनजिंदर सिंह सिरसा ने अपने आयकर (वित्तीय वर्ष 2012–13) में सबसे ज्यादा ₹ 1.50 करोड़ वार्षिक आय घोषित की है। इसके बाद निर्वाचन क्षेत्र बिजवासन से भाजपा विधायक सत प्रकाश राणा ने अपने आयकर (वित्तीय वर्ष 2012–13) में ₹ 83.45 लाख और निर्वाचन क्षेत्र नांगलौई से भाजपा विधायक मनोज कुमार शौकीन ने अपने आयकर (वित्तीय वर्ष 2012–13) में ₹ 63.68 लाख वार्षिक आय घोषित की है।

आपराधिक पृष्ठभूमि:

- ☞ विधायकों द्वारा घोषित आपराधिक मामले:— 70 में से 25 (36 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। विधानसभा चुनाव 2008 में 43 प्रतिशत विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये थे।
- ☞ विधायकों द्वारा घोषित आपराधिक मामले—दलवार:— भाजपा के 31 में से 17 (55 प्रतिशत), आम आदमी पार्टी के 28 में से 3 (11 प्रतिशत) और कांग्रेस के 8 में से 2 (25 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। आपराधिक मामले घोषित करने वालों में शिरोमणि एकाली दल और जेडीयू के 1 विधायक भी शामिल हैं।
- ☞ विधायकों द्वारा घोषित गंभीर आपराधिक मामले:— 20 विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं। जैसे हत्या का प्रयास, डकैती, और महिलाओं के ऊपर अत्याचार से सम्बन्धित।
- ☞ गंभीर आपराधिक मामलों वाले उम्मीदवार जो पराजित रहें—— गंभीर आपराधिक मामले घोषित करने वाले 94 उम्मीदवारों में से 74 चुनाव में पराजित रहें।

- ☞ **हत्या का प्रयास से सम्बन्धित मामले:**— निर्वाचन क्षेत्र ओखला से कांग्रेस विधायक आसिफ मौहम्मद खांन ने अपने ऊपर हत्या का प्रयास से सम्बन्धित मामला घोषित किया है।
- ☞ **महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध:**— 3 विधायकों ने अपने ऊपर महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं। निर्वाचन क्षेत्र कृष्णा नगर से भाजपा विधायक हर्ष वर्धन ने अपने ऊपर आईपीसी की धारा 509 के तहत “शब्द, अंगविक्षेप या कार्य जो स्त्री की लज्जा का अनादर करने के लिए आशयित है” से सम्बन्धित मामला, निर्वाचन क्षेत्र करावल नगर से भाजपा विधायक मोहन सिंह बिष्ट और निर्वाचन क्षेत्र माजरा से कांग्रेस विधायक जय किशन ने अपने ऊपर आईपीसी की धारा 354 के तहत “स्त्री की लज्जा भंग करने के आशय से उस पर हमला या आपराधिक बल का प्रयोग” करने से सम्बन्धित मामला घोषित किया है।

अन्य विवरण (शिक्षा, महिला उम्मीदवार, आयु)

- ☞ **विधायकों की शैक्षिक योग्यता:** कुल 36 (51%) विधायक (70 विश्लेषित विधायकों में से) स्नातक अथवा इससे अधिक शिक्षित हैं। 33 (47%) विधायक 12वीं पास अथवा इससे कम शिक्षित हैं।
- ☞ **आयु के आधार पर विधायक:** विश्लेषित 70 में से 18 (26%) विधायकों ने अपनी आयु 40 वर्ष और इससे कम घोषित की है जबकि 22 (31%) विधायकों ने अपनी आयु 41 से 50 वर्ष के बीच घोषित की है। 28 (40 प्रतिशत) विधायकों ने अपनी आयु 51 से 70 वर्ष के अन्तर्गत घोषित की है।
- ☞ **महिला विधायक:** दिल्ली विधानसभा चुनाव 2013 में 70 में से कुल 3 (4%) महिला विधायक है। विधानसभा चुनाव 2008 में भी 3 विधायक महिला थीं।
