Analysis of Financial, Criminal Background and Other Details of Newly Elected MLAs in the Madhya Pradesh Assembly Elections, 2013

Association of Democratic Reforms (ADR) and Madhya Pradesh Election Watch (MPEW) have analyzed the self-sworn affidavits of all 230 newly elected MLAs in the Madhya Pradesh 2013 Assembly Elections.

Summary and Highlights:

Asset and Criminal background Comparison of Re-elected MLAs:

- **Number of Re-elected MLAs:** Madhya Pradesh Election Watch had analysed the affidavits of all 65 re-elected MLAs.
- **Re-elected Winners with Criminal Cases:** There are **20** re-elected MLAs who have **declared criminal cases in 2013**. Out of these 20 re-elected MLAs, **10 had declared criminal cases in the last assembly elections too**.
- **Average Asset growth of Re-elected MLAs in 2013 Elections:** The average asset of these 65 re-elected MLAs now in 2013 is **Rs 7.51 Crores**. The average assets of these 65 MLAs in 2008 was **Rs. 1.92 Crores**. The average asset growth of these 65 re-elected MLAs is **290%** or by **Rs. 5.59 Crores**.
- **Party Wise Average Asset Increase:** **55** re-elected MLAs of **BJP** have shown an average asset increase of **279%** or **Rs 3.26 Crores**. Assets of **10 INC** MLAs grew by **302%** or **Rs 18.39 Crores**.
- **Highest growth In Assets in 5 years (2008-2013):** The maximum growth in assets has been for **Sanjay Pathak of INC** from **Vijayraghogarh constituency**. He has declared an increase of **Rs. 87.15 Crores (255%)** i.e from **Rs. 34.17 Crores** in 2008 to **Rs. 121.32 Crores** in 2013. Assets of **K.P.Singh Kakkajoo of INC** from **Pichhore Constituency** have increased by **Rs 49.23 Crores (429%)**, i.e. from **Rs. 11.48 Crores** in 2008 to **Rs 60.72 Crores** in 2013. Assets of **Surendra**

Patawa of BJP from Bhojpur Constituency have risen by **Rs 31.32 Crores (468%)**, from Rs 6.69 Crores in 2008 to Rs 38.02 Crores in 2013.

- **Decline in assets:** 3 BJP MLAs have declared decrease in assets compared to their 2008 declarations. **Kailash Vijayvarghiya** from Dr.Ambedkar Nagar Mhow constituency has declared a decrease of 28% in his assets i.e from Rs. 2.55 Crores in 2008 to Rs.1.83 Crores in 2013. **Deepak Joshi** from Hatpipliya constituency has declared 10% decrease in his assets (Rs.40.94 Lakhs in 2008 to Rs. 36.82 Lakhs in 2013). **Balakrishna Patidar** of BJP from Khargone constituency has declared 9% decrease in assets from Rs. 3.84 Crores in 2008 to Rs. 3.51 Crores in 2013.

Financial:

- **Crorepati MLAs:** **161 (70%)** out of 230 MLAs are crorepatis. In 2008, out of 219 MLAs analysed, 87 (40%) MLAs were crorepatis.
- **Party Wise Crorepati MLAs:** **118 (72%)** out of 165 **BJP** MLAs are crorepatis while **40 (69%)** out of 58 MLAs of **INC** are crorepatis.
- **Average Assets:** The average asset per MLA in the Madhya Pradesh 2013 Assembly Elections is **Rs. 5.24 Crores**. In 2008, it was **Rs. 1.49 Crores**

- **Party-wise Average Assets:** The average asset per MLA for BJP is **Rs.4.61 Crores** and for INC it is **Rs 7.11 Crores**. BSP MLAs have an average assets of **Rs.3.22 Crores**.
- **Highest Asset MLAs:** Top 3 MLAs with highest declared assets are **Sanjay Pathak** of INC from Vijayraghavgarh constituency with declared assets of **Rs.121.32 Crores** followed by **Chetan Kashyap** of BJP from Ratlam City constituency with assets worth Rs. **120.29 Crores** and **Sanjay Sharma** of BJP from Tendukheda constituency with declared assets worth **Rs.65.42 Crores**.
- **Relationship between Asset Rank of Winners and their Chances of Winning:** **217** MLAs (**94%**) occupy top three highest asset positions in their respective constituency. **107(47%)** MLAs have the highest declared assets in their constituency. **87(38%)** MLAs have the second highest declared assets in their constituency
- **Low Asset MLAs:** **Usha Thakur Didi** of BJP from Indore-3 constituency has declared lowest assets worth **1.38 Lakhs** followed by **Shantilal Bhilwal** of BJP from Jhabua constituency with assets worth **4.88 Lakhs** and **Dinesh Ahirwar** of INC from Jatara has declared assets worth **Rs. 6.02 Lakhs**.
- **High Liability MLAs:** A total of 25 MLAs have declared liabilities of Rs. 1 Crore and above. The top three MLAs with highest declared liabilities are **Sanjay Pathak** of INC from Vijayraghavgarh Constituency with declared liabilities worth **Rs. 48.70 Crores**, followed by **Surendra Patawa** of BJP from Bhojpur Constituency with liabilities of Rs. **34.49 Crores** and **Dr. Mohan Yadav** of BJP from Ujjain South Constituency with declared liabilities of **Rs. 5.11 Crores**.
- **Undeclared PAN :** 18 MLAs have not declared their PAN details.
- **MLAs who have not declared their ITR:** 53 (23%) MLAs declared that they have not filed their Income Tax Returns.
- **Highest Income declared in their last ITR:** **Sanjay Pathak** of INC from Vijayraghavgarh constituency has declared the highest income in his ITR of **Rs.8.94 Crores** followed by

Sanjay Sharma of BJP from Tendukheda constituency with an income of **Rs. 3.44 Crores** and **Jayant Malaiya** of BJP from Damoh constituency has declared an income of **Rs. 88.93 Lakhs**.

Criminal:

- **MLAs with Criminal Cases:** 32% or 73 of the 230 MLAs have **declared criminal cases** against them. In 2008, 26% or 58 MLAs had declared criminal cases out of 219 MLAs analysed.

Note: Case details of Kailash Vijayvargiya of BJP is not provided as the annexure pages of his 2013 affidavit is not available on CEO website. In 2008 he had declared six cases against him.

- **Party-Wise MLAs with Declared Criminal Cases:** BJP has 48 out of 165 (29%), INC has 22 out of 58 (38%) MLAs who have declared criminal cases. 1 (25%) MLA from BSP out of 4 and 2 independent MLAs have declared criminal cases against them.
- **MLAs with Serious Criminal Cases:** Out of the 73 MLAs with criminal cases, **45 MLAs have declared serious criminal cases** like kidnapping, dacoity, extortion and assault against women etc.

Candidates with serious criminal cases who lost the election: Out of 120 candidates (Only from 3 major parties – INC, BJP and BSP) who contested with serious criminal cases in Madhya Pradesh Assembly Elections, **77 lost the elections**.

- **MLAs who have declared Crimes against Women:** 2 MLAs have declared crimes against women. **Bahadur Singh** of BJP from Mahidpur Constituency has a charge related to **word, gesture or act intended to insult the modesty of a woman (IPC Section-509).** **Rushtam Singh** of BJP from Morena constituency declared a case of **Husband or relative of husband of a woman subjecting her to cruelty (IPC section 498A).**

- **Prevention of Corruption Act:** 3 BJP MLAs Bhanwar Singh Shekhawat, Ramesh Mendola, Om Prakash Dhurve and one INC MLA Rajendra Kumar Singh Dadabhai have declared cases under Prevention of Corruption Act.

Other Background details (Education, Gender, Age):

- **MLAs' Education** A total of **155 (67%)** MLAs have educational qualifications equivalent to **graduate or above**. A total of **73 (32%)** MLAs have educational qualification of **12th pass or below**.
- **MLAs' Age:** Only **39 (17%)** MLAs are **aged 40 or less** while **157(68%)** MLAs have declared their age to be between 41 and 60 years. **34 (15%)** MLAs are aged above 60 years.
- **Women MLAs:** Out of the 230 MLAs only **30 (13%) are women**. In 2008 elections, 25 (11%) women were elected to the Madhya Pradesh legislative assembly.

Analysis based on assets

Party Wise Crorepatis

118 (72%) out of 165 **BJP** MLAs are crorepatis while **40 (69%)** out of 58 MLAs of **INC** are crorepatis ans **1 (25%)** out of 4 **BSP** MLAs were also crorepatis. The table below provides the party wise crorepati winners:
