# Analysis of Background of Candidates Contesting in the Bye-Election To Surat West Assembly Constituency (Gujarat)

## **Summary and Highlights**

Gujarat Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **all 12 candidates** contesting in the Bye-election to Surat West Assembly constituency in Gujarat.

- <u>Candidates with Criminal Cases:</u>. Out of the 12 contesting candidates, BJP candidate Purneshkumar Ishwar lal Modi has declared serious criminal charges against himself.
- <u>Crorepati Candidates:</u> 2 candidates out of the 12 contesting candidates are crorepatis. These two candidates belong to INC and BJP parties.
- Average Assets: The average asset of 12 contesting candidates is Rs.58.44 Lakhs.
- <u>High Asset Candidates:</u> The top three candidates with high declared assets are Dalpatbhai Laxmanbhai Patel of INC with declared assets worth Rs.5.12 Crores followed by Purneshkumar Ishwarlal Modi of BJP with assets worth Rs.1.46 Crores. Independent candidate Godil Nazir Hanif has declared assets of Rs.24.06 Lakhs.
- <u>Low Asset Candidates:</u> Shaikh Asifmiya Mohamdhusain has declared the lowest assets of Rs.20000 while Shaikh Abdul Rashid Abdul razak and Saiyed Nasruddin Moiyuddin has declared assets of Rs.25,000 and Rs.65,000 repectively. All the above 3 candidates are contesting as independents.
- <u>Zero asset candidate:</u> Independent candidate, **Pathan Shabbirkhan Ahmadkhan** has declared zero assets in his affidavit.
- High Liability Candidates: The top three candidates with highest declared liabilities are Purneshkumar Ishwarlal Modi of BJP with declared liabilities worth Rs.28.87 Lakhs followed by Dalpatbhai Laxmanbhai Patel of INC with declared liabilities worth Rs.9.37 Lakhs. Independent candidate Godil Nazir Hanif has declared liabilities worth Rs.2.05 Lakhs.
- Undeclared PAN: 2 out of 12 candidates have not declared their PAN details.
- Candidates who have not declared ITR: 8 out of 12 candidates have not declared their ITR.
- Other Background details (Education, Gender, Age):
- <u>Candidates' Education</u>: A total of 3 candidates out of 12 are graduates or have higher degrees. 9 candidates have educational qualification of 12th pass and below
- <u>Candidates' Age:</u> A total of 5 candidates have declared their age to be between 25 and 40 years. 6 candidates declared their age to be between 41 and 60 years while one candidate is in the age group of 61 and 70 years.





• <u>Women Candidates</u>: **No women candidate** is contesting in the bye elections to Surat West constituency
