Summary and Highlights

Gujarat Election Watch and Association for Democratic Reforms have analysed the self-sworn affidavits of all **20 ministers including the Chief Minister** from Gujarat State Assembly 2017.

Criminal Background

- **Ministers with Criminal Cases:** 3 (15%) ministers have declared criminal cases against themselves.

Financial Background

- **Crorepati Ministers:** Out of the 20 ministers, 18 (90%) are crorepatis.
- **Average Assets:** The average assets of 20 ministers is **Rs 13.34 crores**.
- **Ministers with Highest Assets:** The minister with the highest declared total assets is **Saurabh Yashvantbhai Dalal Patel** from Botad constituency with assets worth **Rs.123.78 crores**. The top three ministers with highest declared assets are:

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
