## Summary and Highlights

Himachal Pradesh Election Watch and Association for Democratic Reforms have analysed the self-sworn affidavits of all **12 ministers including the Chief Minister** from Himachal Pradesh State Assembly 2017.

### Criminal Background

- **Ministers with Criminal Cases:** 5 (42%) ministers have declared criminal cases against themselves.

### Financial Background

- **Cronepati Ministers:** Out of the 12 ministers, 8 (67%) are crorepati.
- **Average Assets:** The average assets of 12 ministers is **Rs.7.17 crores**.
- **Ministers with Highest Assets:** The minister with the highest declared total assets is **Anil Sharma** from Mandi constituency with assets worth **Rs.40.24 crores**. The top three ministers with highest declared assets are:

**Criteria for serious criminal cases**

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

### Other Background details (Education, Gender, Age)

- ***Ministers' Education*** 3 (25%) ministers have declared their educational qualification to be 12<sup>th</sup> pass while 8(67%) are graduates or have higher degrees. 1(8%) minister has declared his educational qualification as doctorate.
- ***Ministers' Age:*** A total of 2 (17%) ministers have declared their age to be between 41-50 years while 6(50%) ministers have declared their age to be between 51-60 years. There are 4 (33%) ministers who have their age to be between 61 to 70 years.
- ***Women Ministers:*** Out of 12 Ministers, only 1 is a woman.
