Analysis of Election Expenditure Statements of MLAs **Maharashtra Assembly Elections, 2014**

According to Section 78 of the Representation of the People Act, 1951, every contesting candidate has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories. Maharashtra Election Watch (MEW) and Association for Democratic Reforms (ADR) have analyzed the election expense statements submitted after the Maharashtra Assembly Elections of 2014 for all 288 MLAs. The expenditure limit for the candidates during the Maharashtra Assembly elections was Rs. 28 lakhs. These election expense documents include details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.

Recommendations:

1. Each candidate is required to file his election expenditure statement within 30 days of the results of the elections. The results of the Maharashtra elections came out on the 19th of October, 2014 and the deadline for submitting the election expenditure statements for Maharashtra Assembly Elections 2014 was the 18th of November, 2014. The statements are then uploaded on the CEO website within 72 hours of the receipt of the statement. It was observed that the election expenditure statements of the candidates were not uploaded on the CEO website till significantly after the deadline. It is recommended that the Abstract Expenditure Statement (Annexure 15) of the candidates is uploaded on the CEO website within 72 hours of the receipt of the statement.
2. The deadline for filing an election petition against any candidate is 45 days after the declaration of the results. Generally, candidates submit their election expenditure statements towards the end of the 30 days given for submission of the statements. This leaves 15 days for any common citizen to file an election petition against any candidate. The deadline for filing an election petition should be increased in order to give the citizens time to scrutinize the election expenditure statements of the candidates and gather the relevant documents/proof etc for the election petition.
3. As has been instated in the filing of affidavits during the elections, the candidates should not be allowed to keep any field blank on the Abstract Election Expenditure statement (Annexure 15) and Schedule 1 to 9. The statements must be filled in a legible format and overwriting of amounts in the statement should be discouraged.

Summary and Highlights of Election Expenses of MLAs from the Maharashtra Assembly 2014 Elections

1. **Less than 50% of the Limit:** Candidates have constantly claimed that the election expenditure limit set is very low. However, based on the election expense declarations of 288 MLAs analysed from the 2014 Maharashtra Assembly Elections to the ECI, **120 MLAs (42%) have declared election expenses of less than 50% of the expense limit** in their constituency.
2. **Average Election Expenses:** Based on the election expense declarations of 288 MLAs from Maharashtra Assembly to the ECI, the **average amount of money spent by them in the elections is only about Rs 15.18 lakhs, which is 54% of the expense limit.**
3. **Party-wise Average Election Expenses:** The party wise average election expenses shows that the average spending for **122 MLAs from BJP is Rs 15.32 lakhs** (55% of the expense limit), for **42 MLAs from INC is Rs 15.25 lakhs** (54% of the expense limit), for **63 MLAs from Shiv Sena is Rs 13.42 Lakhs** (48% of the expense limit) and for **41 MLAs from NCP is Rs. 17.77 Lakhs** (63% of the expense limit).

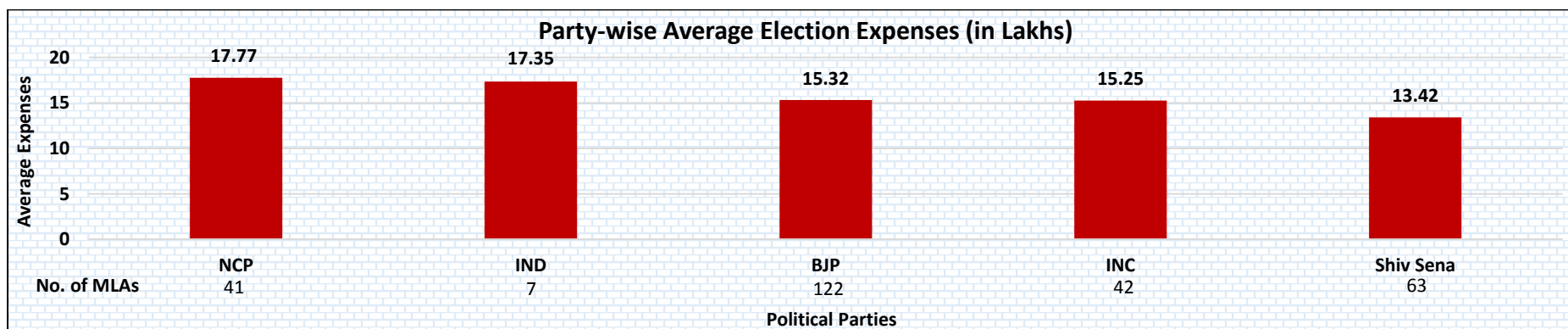


Figure 1: Party-wise Average Election Expenses (in lakhs)

4. **Top 3 MLAs with highest Election Expenses:** The maximum expense of about **Rs 26.19 lakhs** (94% of the expense limit) has been declared by **Bacchu Alias Omprakash Babarao Kadu an Independent** from Achalpur constituency followed by **Pratap Baburao Sarnaik of Shiv Sena** from Ovala Majiwada constituency with an expense of **Rs 25.61 lakhs** (or 91% of the expense limit) and **Kolhe Snehalata Bipindada of BJP** from Kopergaon constituency with an expense of **Rs 24.86 lakhs** (or 89% of the expense limit).

5. **MLAs with lowest Election Expenses:** Advocate Waris Yusuf Pathan of All India Majlis-E-Ittehadul Muslimeen from Byculla constituency has declared election expenditure of Rs. 2.76 lakhs followed by Gopaldas Shankarlal Agrawal of INC from Gondia Constituency with election expenses of Rs. 5.46 lakhs and Dhairsheel Mohan Patil of Peasants And Workers Party of India from Pen Constituency with election expenses of Rs. 5.65 lakhs.
6. **Expense on Public Meeting, Rally, and Processions with Star Campaigners:** Out of the 288 MLAs analyzed, 78 (27%) MLAs have declared that they have not spent ANY amount on public meetings, processions etc with Star Campaigners.
7. **Expense on Public Meetings, Rally, and Processions other than the ones with Star Campaigners:** Out of the 288 MLAs analyzed, 8 (3%) MLAs have declared that they have not spent ANY amount on public meetings, processions etc other than the ones with star campaigners.
8. **Expense on Campaigning through electronic/print media:** 49 (17%) MLAs have declared that they have not spent ANY amount on campaigning through electronic/print media.
9. **Expense on Campaign Workers:** 48 (17%) MLAs have declared that they have not spent ANY amount on campaign workers.
10. **Expense on Vehicles used:** 4 (1%) MLAs have declared that they have not spent ANY amount on Vehicles Used.
11. **Expense on Campaign Materials:** 20 (7%) MLAs have declared that they have not spent ANY amount on Campaign Materials

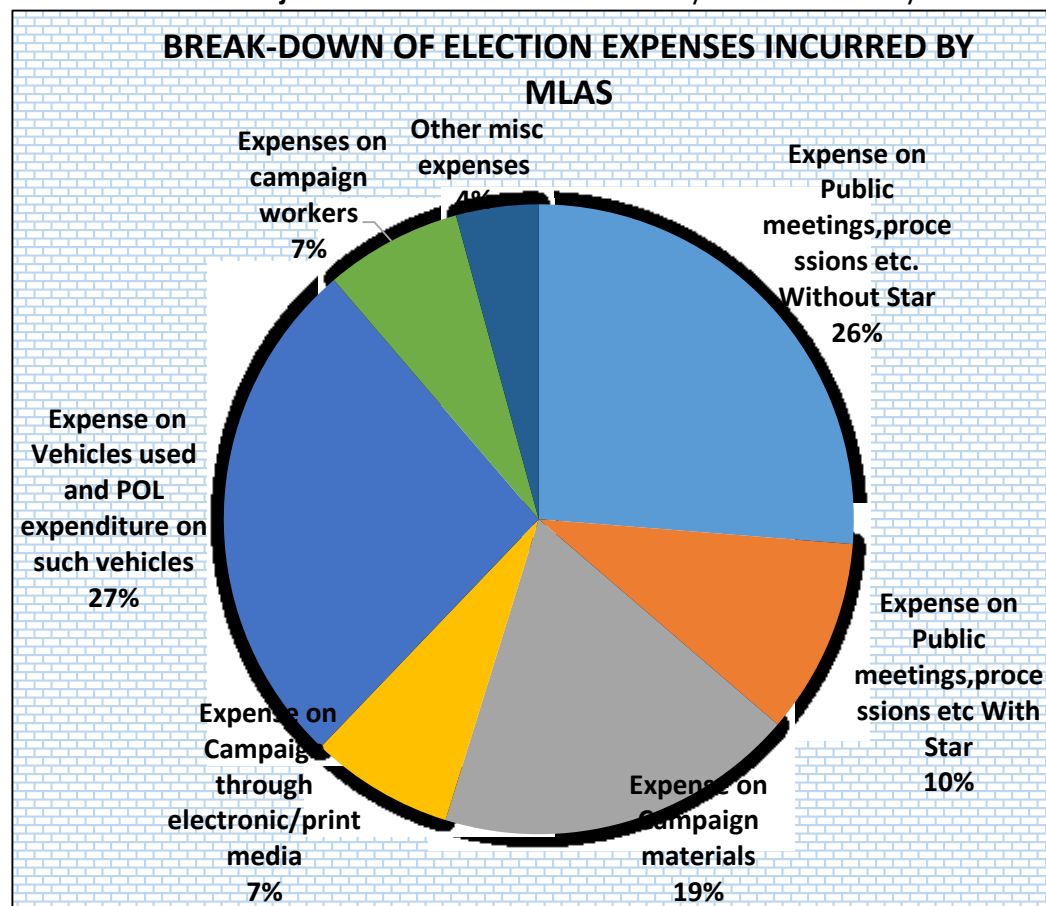


Figure 2: Break-down of Election Expenses Incurred by MLAs

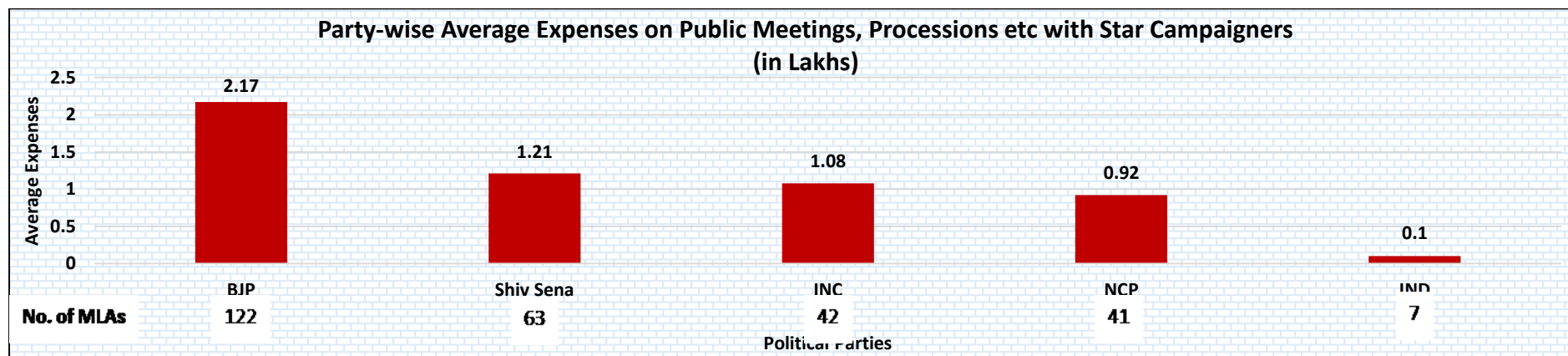


Figure 3: Party-wise Average Expenses on Public Meetings, Processions etc with Star Campaigners (in lakhs)

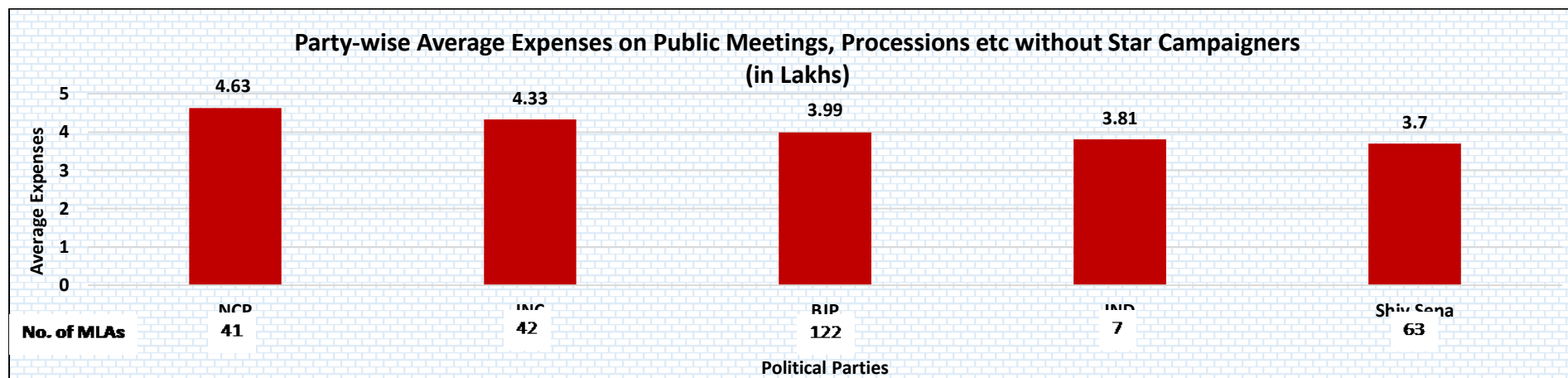


Figure 4: Party-wise Average Expenses on Public Meetings, Processions etc without Star Campaigners (in lakhs)

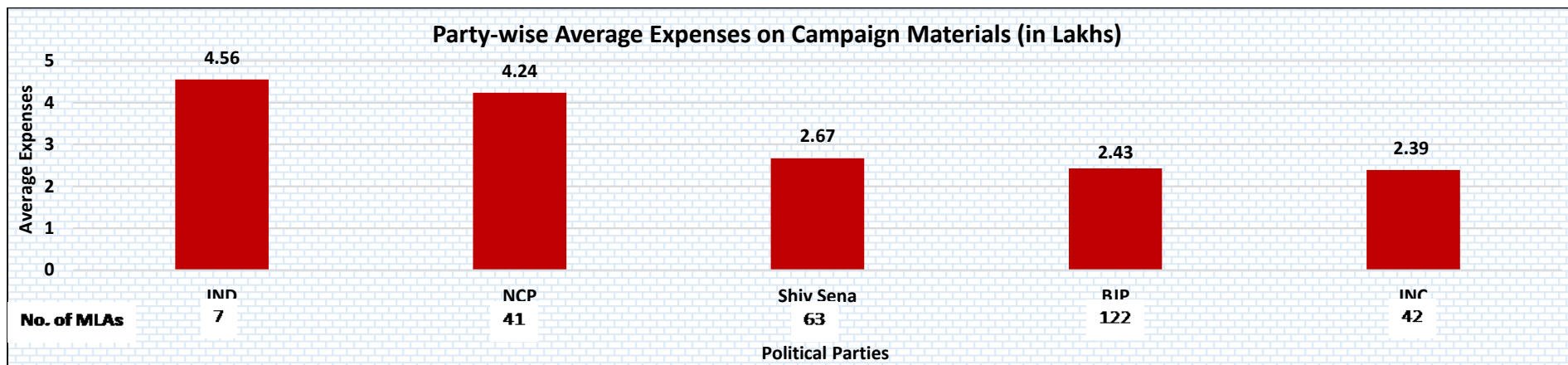


Figure 5: Party-wise Average Expenses on Campaign Materials

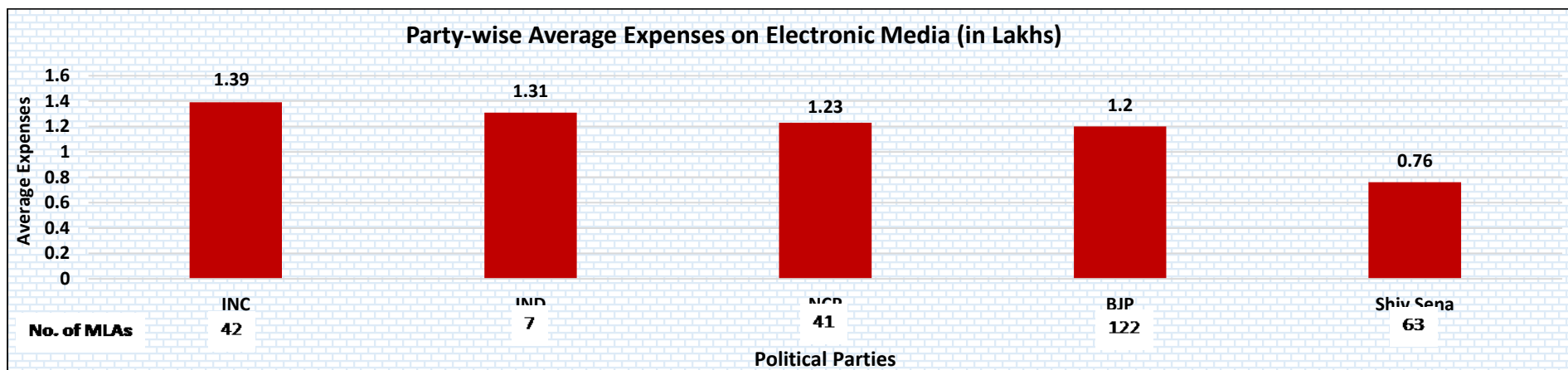


Figure 6: Party-wise Average Expenses on Electronic Media (in lakhs)

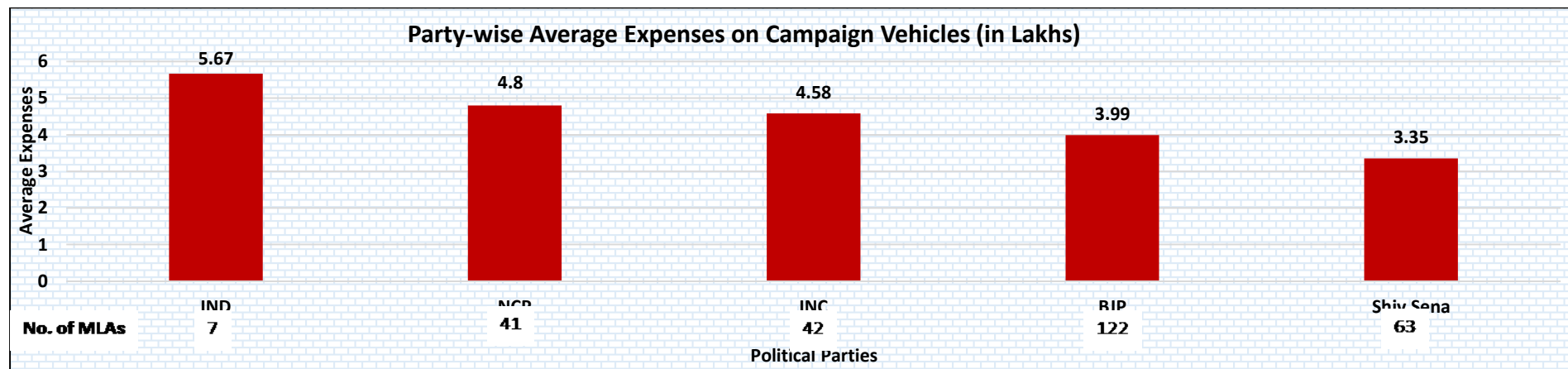


Figure 7: Party-wise Average Expenses on Campaign Materials

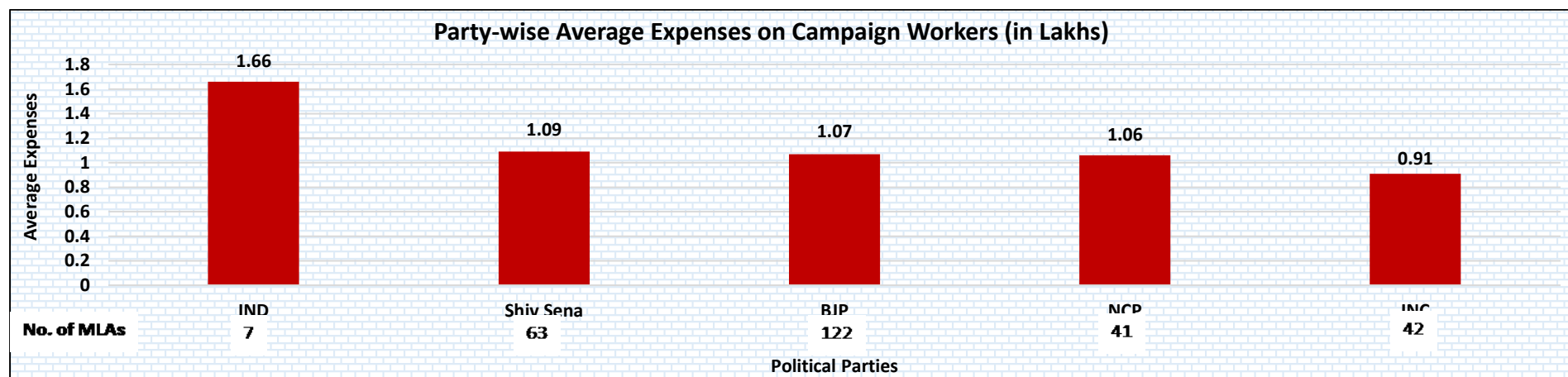


Figure 8: Party-wise Average Expenses on Campaign Workers (in lakhs)

18. Funds Raised from Political Party: Out of the 288 MLAs analyzed, 226 (78%) MLAs have declared that they have not received any funds from political parties.

19. Funds Raised through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc: Out of the 288 MLAs analyzed, 120(42%) MLAs have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.

20. Self funds used for election campaign: Out of the 288 MLAs analyzed, 12 (4%) MLAs have declared that they have not used any of their own funds for their election campaign

21. Average funds raised from Political Parties (Party-wise): On an average an MLA from BJP raised 16% of his/her election expense funds from the political party. Similarly, an MLA from INC raised 24% of his/her election expense funds, an NCP MLA raised 9% and a Shiv Sena MLA raised 1% of their election expense funds from the political party.

22. Average funds raised through any person/company/firm/associations/body of persons etc as loan, gift or donation etc (Party-wise): On an average an MLA from BJP raised 26% of his/her election expense funds from any person/company/firm/associations/body of persons etc as loan, gift or donation. Similarly, an MLA from Shiv Sena raised 43% of his/her election expense funds, an INC MLA raised on an average 18% of their election expense funds and an NCP MLA raised on an average 19% of their expense funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation.

23. Average self funds used (Party-wise): On an average an MLA from BJP raised 44% of his/her election expense funds from their self funds. Similarly, an MLA from Shiv Sena raised 57% of his/her election expense funds from their own self funds, an INC MLA raised 59%, and an NCP Mla raised 72% of their election expense funds from their self funds.

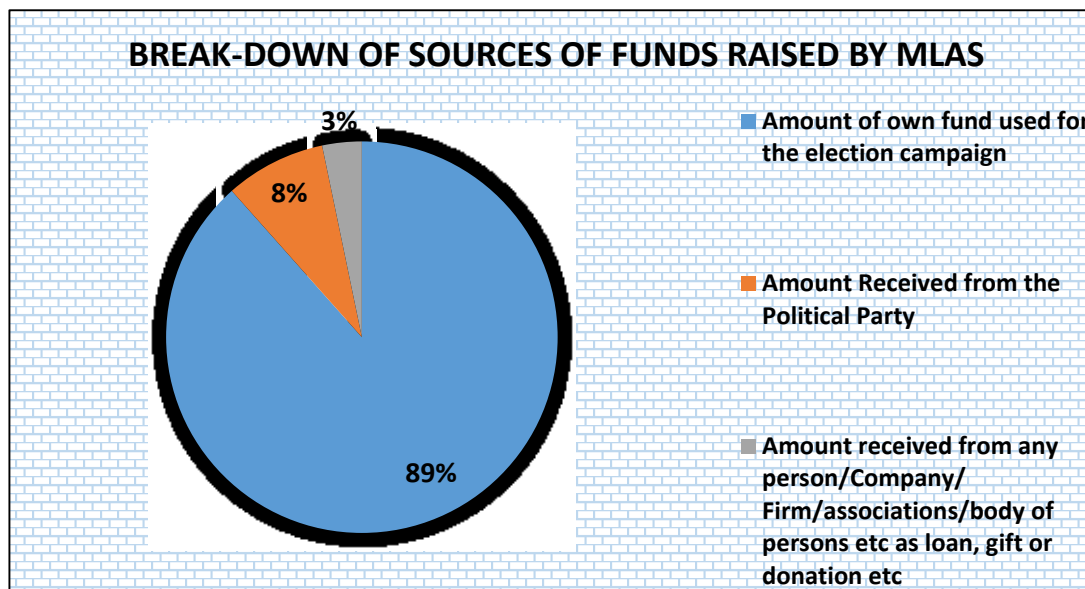


Figure 9: Break-down of Sources of Funds Raised by MLAs

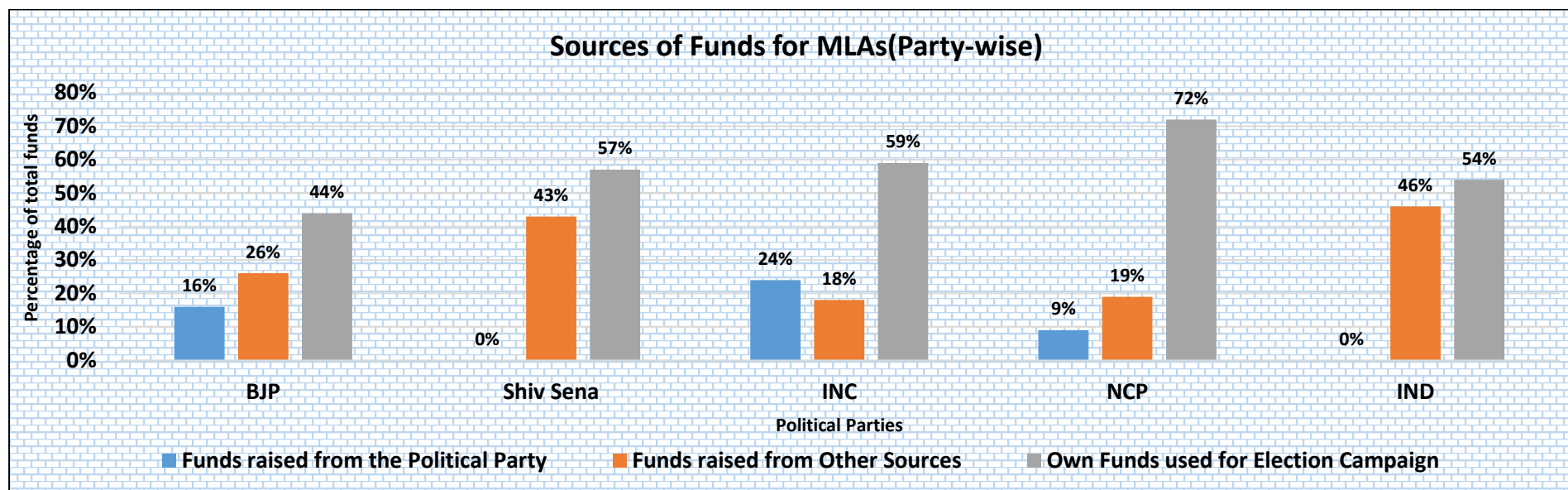


Figure 10: Sources of Funds for MLAs (Party-wise)

Summary and Highlights of Election Expenses of Ministers from the Maharashtra Assembly Elections, 2014

1. **Less than 50% of the Limit:** Based on the election expense declarations of 22 Ministers analysed from Maharashtra Assembly, 2014 to the ECI, **10 Ministers (45%) have declared election expenses of less than 50% of the expense limit** in their constituency.
2. **Average Election Expenses:** Based on the election expense declarations of 22 Ministers from Maharashtra Assembly 2014 to the ECI, the **average amount of money spent** by them in the elections is only about **Rs 14.90 lakhs, which is 53% of the expense limit**.
3. **Top 3 Ministers with highest Election Expenses:** The maximum expense of about **Rs 24.05 Lakhs** (86% of the expense limit) has been declared by **Ambrishrao Raje Satyavanrao Atram of BJP** from Aheri constituency followed by **Sudhir Mungantiwar of BJP** from Ballarpur constituency with an expense of **Rs 22.99 lakhs** (or 82% of the expense limit) and **Eknath Sambhaji Shinde of Shiv Sena** from Kopri-Pachpakhadi constituency with an expense of **Rs 20.76 Lakhs** (or 74% of the expense limit)
4. **Ministers with lowest Election Expenses:** **Dadaji Dagadu Bhuse of Shiv Sena** from Malegaon Constituency has declared an election expenditure of **Rs. 8.78 lakhs** (31% of the expense limit). He is followed by **Savara Vishnu Rama of BJP** from Vikramgad constituency who has declared election expenditure of **Rs. 9.07 lakhs** (32% of the expense limit), **Rathod Sanjay Dulichand of Shiv Sena** from Digras Constituency with election expenses of **Rs. 11.02 lakhs** (39% of the expense limit) and **Devendra Fadnavis of BJP** from Nagpur South West Constituency with election expenses of **Rs. 11.41 lakhs** (41% of the expense limit).

5. **Expense on Public Meeting, Rally, and Processions with Star Campaigners:** Out of the 22 Ministers analyzed, 3 (14%) Ministers have declared that they have not spent ANY amount on public meetings, processions etc with Star Campaigners.
6. **Expense on Public Meetings, Rally, and Processions other than the ones with Star Campaigners:** Out of the 22 Ministers analyzed, 1 Minister, Rathod Sanjay Dulichand of Digras Constituency declared that he had not spent ANY amount on public meetings, processions etc other than the ones with star campaigners.
7. **Expense on Campaigning through electronic/print media:** 6 (27%) Ministers have declared that they have not spent ANY amount on campaigning through electronic/print media.
8. **Expense on Campaign Workers:** 4 (18%) Ministers have declared that they have not spent ANY amount on campaign workers.
9. **Expense on Vehicles used:** All ministers have declared expenses on Vehicles Used. Ravindra Dattaram Waikar of Shiv Sena from Jogeshwari (East) Constituency declared the lowest amount of Rs. 50,098 (4% of his total expense declared) on vehicles.
10. **Expense on Campaign Materials:** 3 (14%) Ministers have declared that they have not spent ANY amount on Campaign Materials.

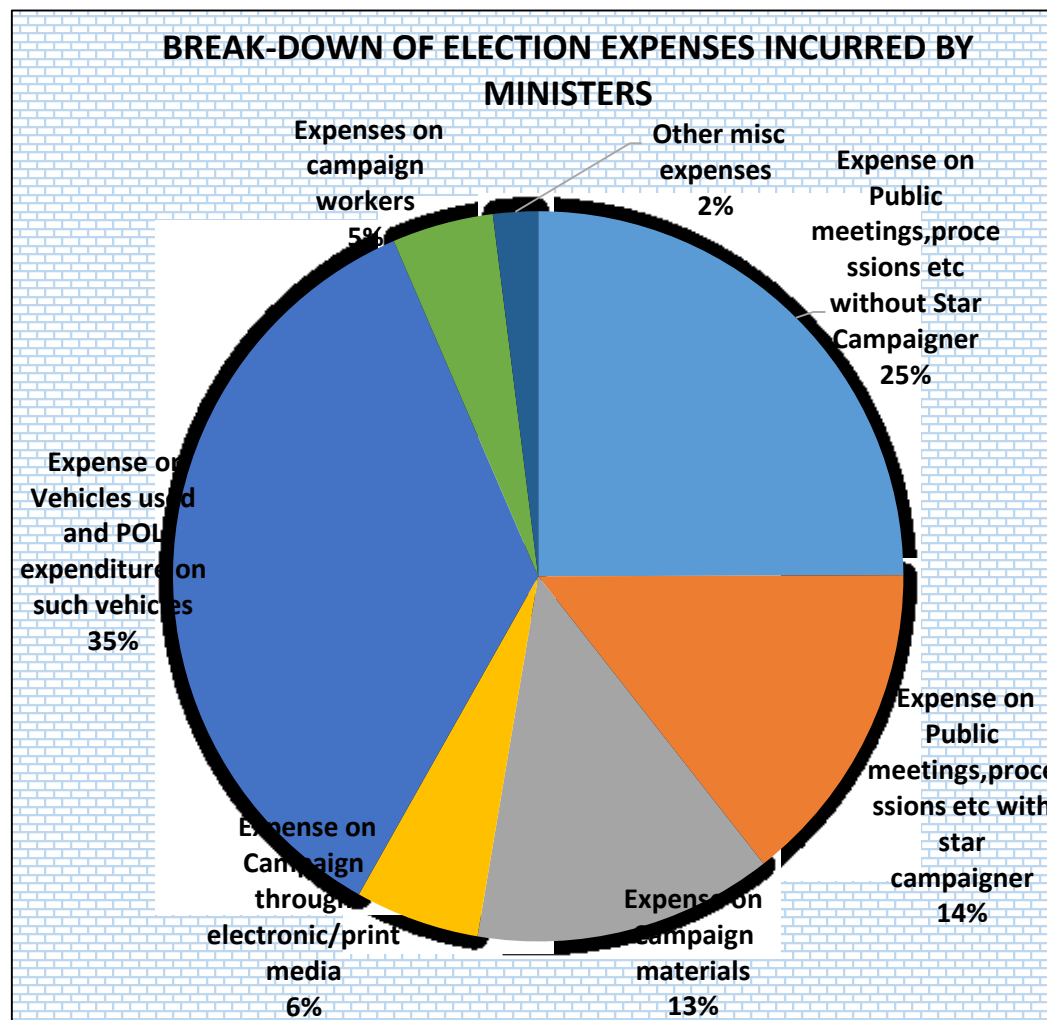


Figure 11: Break-down of Election Expenses Incurred by Ministers

11. **Funds Raised from Political Party:** Out of the 22 Ministers analyzed, 12 (55%) Ministers have declared that they have not received any funds from political parties.
12. **Funds Raised through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:** Out of the 22 Ministers analyzed, 11 (50%) Ministers have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.
13. **Self funds used for election campaign:** Out of the 22 Ministers analyzed, 1 Minister, Dilip Kamble of Pune Cantonment had declared that he had not used any of their own funds for their election campaign

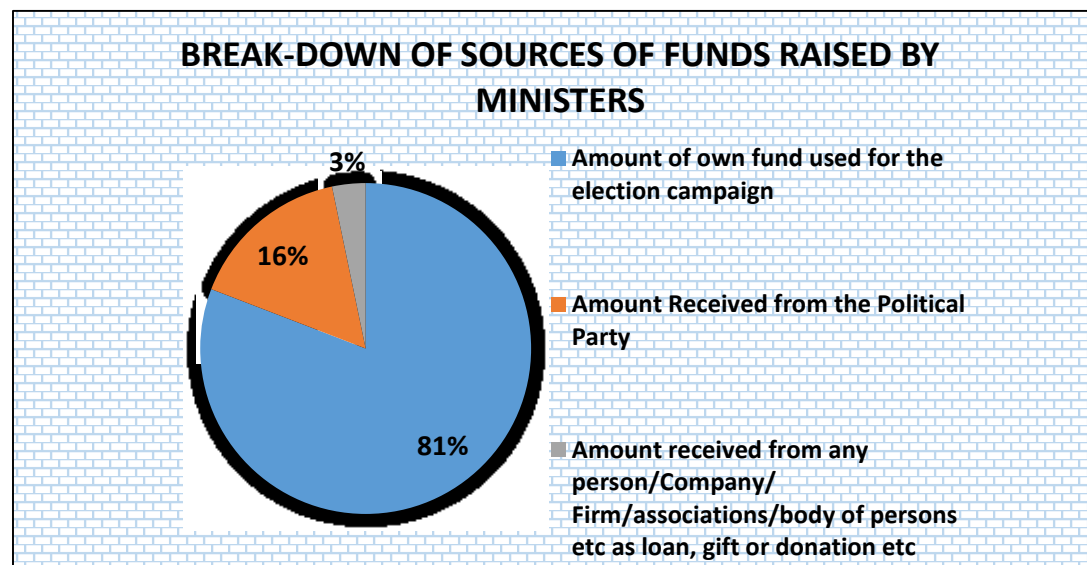


Figure 12: Break-down of Sources of Funds Raised by Ministers
