# Analysis of Election Expenditure Statements of MLAs Kerala Assembly Elections, 2016

According to Section 78 of the Representation of the People Act, 1951, every contesting candidate has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories. Kerala Election Watch and Association for Democratic Reforms (ADR) have analyzed the election expenditure statements submitted after the Kerala 2016 Assembly for 137 out of 140 MLAs. The expenditure limit for the candidates during the Kerala Assembly elections was Rs. 28 lakhs. These election expense documents include details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.

#### **Recommendations:**

- 1. Each candidate is required to file his election expenditure statement within 30 days of the results of the elections, the deadline in case of the Kerala Assembly Elections being the 18<sup>th</sup> of June, 2016. However, it was observed that the election expenditure statements of the candidates were not uploaded on the CEO website till significantly after the deadline. it is therefore recommended that the Abstract Expenditure Statement (Annexure 15) of the candidates is uploaded on the website of the CEO within 72 hours of the receipt of the statement.
- 2. The deadline for filing an election petition against any candidate is 45 days after the declaration of the results. Generally, candidates submit their election expenditure statements towards the end of the 30 days given for submission of the statements. This leaves 15 days for any common citizen to file an election petition against any candidate. The deadline for filing an election petition should be increased in order to give the citizens time to scrutinize the election expenditure statements of the candidates and gather the relevant documents/proof etc for the election petition.
- 3. As has been instated in the filing of affidavits during the elections, the candidates should not be allowed to keep any field blank on the Abstract Election Expenditure statement (Annexure 15) and Schedule 1 to 9. The statements must be filled in a legible format and overwriting of amounts in the statement should be discouraged.

## Summary and Highlights of Election Expenses of MLAs from the Kerala Assembly 2016 Elections

\*Please find below list of MLAs whose expenditure affidavits were not analyzed due to unavailability on the CEO's website.

- 1. <u>Less than 50% of the Limit:</u> Candidates have constantly claimed that the election expenditure limit set is very low. However, based on the election expense declarations of 137 MLAs out of 140 analysed from the 2016 Kerala Assembly elections, 14 MLAs (10%) have declared election expenses of less than 50% of the expense limit in their constituency.
- 2. <u>Average Election Expenses:</u> Based on the election expense declarations of 137 MLAs from Kerala Assembly, the average amount of money spent by them in the elections is only about Rs 19.64 lakhs, which is 70% of the expense limit.
- 3. <u>Party-wise Average Election Expenses:</u> The party wise average election expenses shows that the average spending for 55 MLAs from CPI(M) is Rs 19.02 lakhs (68% of the expense limit), for 22 MLAs from INC is Rs 19.26 lakhs (69% of the expense limit), for 19 MLAs from CPI is Rs





20.19 Lakhs (72% of the expense limit), for 18 MLAs from IUML is Rs 20.27 Lakhs (72% of the expense limit), and for 6 MLAs from Kerala Congress (M) is Rs 20.09 Lakhs (72% of the expense limit).




Figure 1: Party-wise Average Election Expenses (Rs. in lakhs)





- 4. <u>Top 3 MLAs with highest Election Expenses:</u> The maximum expense of about Rs 27.82 lakhs (99% of the expense limit) has been declared by G. Sudhakaran of CPI(M) from Ambalapuzha constituency followed by Ramesh Chennithala of INC from Haripad constituency with an expense of Rs 27.77 lakhs (or 99% of the expense limit) and K Muraleedharan of INC from Vattiyoorkavu constituency with an expense of Rs 27.73 lakhs (or 99% of the expense limit).
- 5. <u>MLAs with lowest Election Expenses</u>: Vijaydas of CPI(M) from Kongad constituency has declared election expenditure of Rs. 7.85 lakhs followed by Anoop Jacob of kerala Congress (Jacob) from Piravom Constituency with election expenses of Rs. 10.25 lakhs and Achuthanandan of CPI(M) from Malampuzha Constituency with election expenses of Rs. 11.13 lakhs.
- 6. Expense on Public Meeting, Rally, and Processions with Star Campaigners: Out of the 137 MLAs analyzed, 48 (35%) MLAs have declared that they have not spent ANY amount on public meetings, processions etc with Star Campaigners.
- 7. Expense on Public Meetings, Rally, and Processions other than the ones with Star Campaigners: Out of the 137 MLAs analyzed, 4 (3%) MLAs have declared that they have not spent ANY amount on public meetings, processions etc other than the ones with star campaigners.
- 8. Expense on Campaigning through electronic/print media: 26 (19%) MLAs have declared that they have not spent ANY amount on campaigning through electronic/print media.
- Expense on Campaign Workers: 34 (25%) MLAs have declared that they have not spent ANY amount on campaign workers.




Figure 2: Break-down of Election Expenses Incurred by MLAs




Figure 3: Party-wise Average Expenses on Public Meetings, Processions etc with Star Campaigners (Rs. in lakhs)




Figure 4: Party-wise Average Expenses on Public Meetings, Processions etc without Star Campaigners (Rs. in lakhs)




Figure 5: Party-wise Average Expenses on Campaign Materials (Rs. in lakhs)




Figure 6: Party-wise Average Expenses on Electronic Media (Rs. in lakhs)




Figure 7: Party-wise Average Expenses on Campaign Vehicles (Rs. in lakhs)




Figure 8: Party-wise Average Expenses on Campaign Workers (Rs. in lakhs)





## Summary and Highlights of Funds Raised by MLAs in the Kerala Assembly 2016 Elections

- <u>Percentage break-down of funds received</u> <u>by MLAs:</u> Out of the total funds received by MLAs, 42% funds were raised from political parties, 14% were raised by MLAs themselves and 44% funds were raised from other sources.
- 2. MLAs Who Raised Funds from Political Parties: Out of the 137 MLAs analyzed, 40(29%) MLAs have declared that they have not received any funds from political parties.
- 3. MLAs Who Raised Funds through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc: Out of the 137 MLAs analyzed, 24(18%) MLAs have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.
- 4. Self funds used for election campaign: Out of the 137 MLAs analyzed, 48(35%) MLAs have declared that they have not used any of their own funds for their election campaign.




Figure 9: Percentage Break-down of Funds Raised by MLAs

5. <u>Average funds raised from Political Parties (Party-wise):</u> On an average an MLA from CPI(M) raised 43 % of his/her election expense funds from the political party. Similarly, an MLA from INC raised 49% of his/her election expense funds, an CPI MLA raised 50 %, an IUML MLA raised 46 % and a Kerala Congress (M) MLA raised 8 % of their election expense funds from the political party.





6. Average funds raised through any person/company/firm/associations/body of persons etc as loan, gift or donation etc (Partywise): On an average an MLA from CPI(M) raised 52% of his/her election expense funds from any person/company/firm/associations/body of persons etc as loan, gift or donation. Similarly, an MLA from INC raised 31% of his/her election expense funds, an MLA from IUML raised 36% of his/her election expense funds and an Kerala Congress (M) MLA raised on an average 72% of their expense funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation.

## Summary and Highlights of Election Expenses of Ministers from the Kerala Assembly Elections, 2016

- 1. <u>Less than 50% of the Limit:</u> Based on the election expense declarations of 17 analysed Ministers from Kerala Assembly 2016, 2 Ministers (12%) have declared election expenses of less than 50% of the expense limit in their constituency.
- 2. <u>Average Election Expenses:</u> Based on the election expense declarations of 17 analysed Ministers from Kerala Assembly 2016, the average amount of money spent by them in the elections is only about Rs 19.61 lakhs, which is 70% of the expense limit.
- 3. <u>Top 3 Ministers with highest Election Expenses:</u> The maximum expense of about Rs 27.82 Lakhs (99% of the expense limit) has been declared by G.Sudhakaran of CPI(M) from Ambalapuzha constituency followed by Thilothaman of CPI from Cherthala constituency with an expense of Rs 27.67 lakhs (or 99% of the expense limit) and Kadakampally Surendran of CPI(M) from Kazhakkottam constituency with an expense of Rs 24.46 Lakhs (or 87% of the expense limit)
- 4. <u>Ministers with lowest Election Expenses</u>: T P Ramakrishnan of CPI(M) from Perambra Constituency has declared an election expenditure of Rs. 11.63 lakhs (42% of the expense limit). He is followed by C Raveendranathan of CPI(M) from Puthukkad constituency who has declared election expenditure of Rs. 13.32 lakhs (48% of the expense limit), and E. Chandrashekaran of CPI from Kanhangad Constituency with election expenses of Rs. 15.07 lakhs (54% of the expense limit).





- 5. Expense on Public Meeting, Rally, and Processions with Star Campaigners: 4 (24%) Ministers have declared that they have not spent ANY amount on public meetings, processions etc with star campaigners.
- 6. Expense on Public Meetings, Rally, and Processions other than the ones with Star Campaigners: All Ministers have declared expenses on public meetings, processions etc other than the ones with star campaigners.
- Expense on Campaigning through electronic/print media: 4 (24%) Ministers have declared that they have not spent ANY amount on campaigning through electronic/print media.
- 8. <u>Expense on Campaign Workers:</u> 2 (12%) Ministers have declared that they have not spent ANY amount on campaign workers.
- Expense on Vehicles used: All ministers have declared expenses on Vehicles Used. T P Ramakrishnan of CPI(M) from Perambra Constituency declared the lowest amount of Rs. 72,200 (6% of his total expense declared) on vehicles.
- Expense on Campaign Materials: 2 (12%) Ministers have declared that they have not spent ANY amount on Campaign Materials.




Figure 10: Break-down of Election Expenses Incurred by Ministers





## Summary and Highlights of Funds Raised by Ministers in the Kerala Assembly 2016 Elections

- Percentage break-down of funds received by <u>Ministers</u>: Out of the total funds received by Ministers, 39% funds were raised from political parties, 19% were raised by Ministers themselves and 42% funds were raised from other sources.
- Ministers Who Raised Funds from Political
   Party: Out of the 17 analyzed Ministers, 8 (47%)
   Ministers have declared that they have not received any funds from political parties.
- 3. Ministers Who Raised Funds through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:
  Out of the 17 analyzed Ministers, 2 (12%) Ministers have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.




Figure 11: Percentage Break-down of Funds Raised by Ministers
