## Executive Summary

Association for Democratic Reforms (ADR) and National Election Watch have analyzed **4852 out of 4896 affidavits**. It includes **774 out of 776** affidavits of MPs and **4078 out of 4120 MLAs** from all the states of India. They collectively form the Electoral College, who will be voting for the Presidential Elections **on 17<sup>th</sup> July, 2017** to elect the new President of India. Based on the number of votes these 4852 MPs/MLAs can cast, NEW and ADR have analysed **1091472 out of 1098903 votes**.

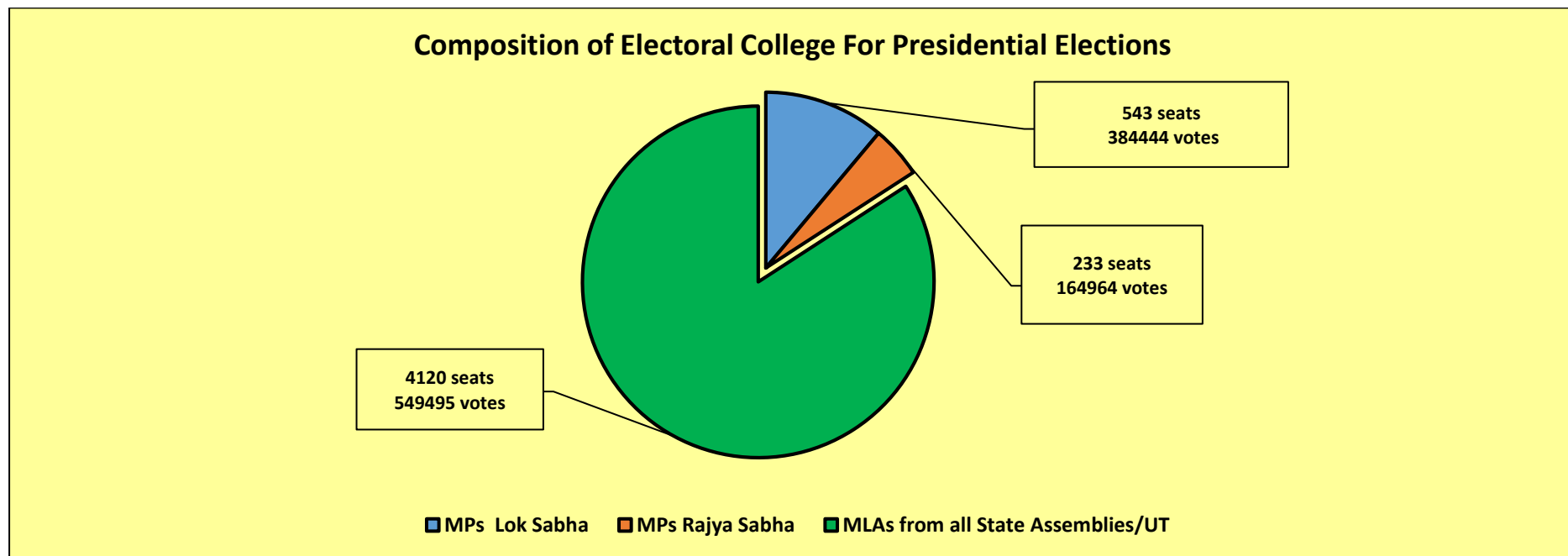


Figure 1: Composition of Electoral College for Presidential Elections

### Votes of MPs/MLAs Who Have Declared Criminal Cases

**MPs/ MLAs with Criminal Cases:** Out of the 4852 MPs/MLAs analysed, **1581(33%)** members have declared criminal cases against themselves in a self-sworn affidavit filed with the ECI before their most recent elections. **184 (34%)** out of 543 **Lok Sabha MPs**, **44(19%)** out of 231 **Rajya Sabha MPs** and **1353(33%)** out of 4078 **MLAs** (all state assemblies / UTs) analysed have declared criminal cases against themselves.

**MPs/ MLAs with Serious Criminal Cases:** Out of the 4852 MPs/MLAs analysed, **993(20%)** members have declared serious criminal cases against themselves in a self-sworn affidavit filed with the ECI before their most recent elections. **117 (22%)** out of 543 **Lok Sabha MPs**, **16(7%)** out of 231 **Rajya Sabha MPs** and **860(21%)** out of 4078 **MLAs** (all state assemblies / UTs) analysed have declared serious criminal cases against themselves.

**Votes by MPs/MLAs who have declared criminal cases:** Based on the number of votes that MPs / MLAs who have declared criminal cases, are entitled to cast, a total of **367393 votes (34%)** out of 1091472 votes analysed are of MPs/MLAs who have declared criminal cases against themselves.

### Votes of MPs/MLAs Based on Financial Details

**Crorepati MPs/MLAs:** **3460 (71%)** out of 4852 MPs/ MLAs analysed are crorepatas as per their self-sworn affidavits submitted to the ECI at the time of nomination for contesting elections. **445(82%)** out of 543 **Lok Sabha MPs**, **194 (84%)** out of 231 **Rajya Sabha MPs**, **2821(69%)** out of 4078 **MLAs** from all State / UT assemblies are crorepatas.

**Votes by crorepati MPs/MLAs:** Based on the number of votes these crorepatas MPs/MLAs are entitled to cast, a total of **75% or 818703** out of 1091472 votes analysed are of MPs/MLAs who are crorepatas. Amongst state assemblies, **Karnataka** has the maximum number of votes by crorepati MPs/MLAs with **30400(93%)** out of 32680 votes analysed.

## Women Representation

- Out of the total 4852 MPs/MLAs who are entitled to vote in the upcoming Presidential Elections, only **451(9%) are women**.
- Based on the number of votes the MPs/MLAs are entitled to vote, **109708 (10%)** out of 1091472 are women votes.
- Among MPs, **Lok Sabha has 46020 (12%) votes** out of 384444 from **65 women MPs** and **Rajya Sabha has 16284(10%)** out of 163548 votes analysed from **23 women MPs**.
- **All State / UT assemblies** combined have **51383(9%)** votes out of 543480 votes from **363 women MLAs**.
- Among State assemblies, **Uttar Pradesh** has the maximum amount of women votes with **8320 votes out of 83616(40 out of 402 MLAs)** followed by **West Bengal** with **6191 votes out of 44243 (41 out of 293 MLAs)** and **Madhya Pradesh** with **4192 votes out of 30130(32 out of 230 MLAs)**.

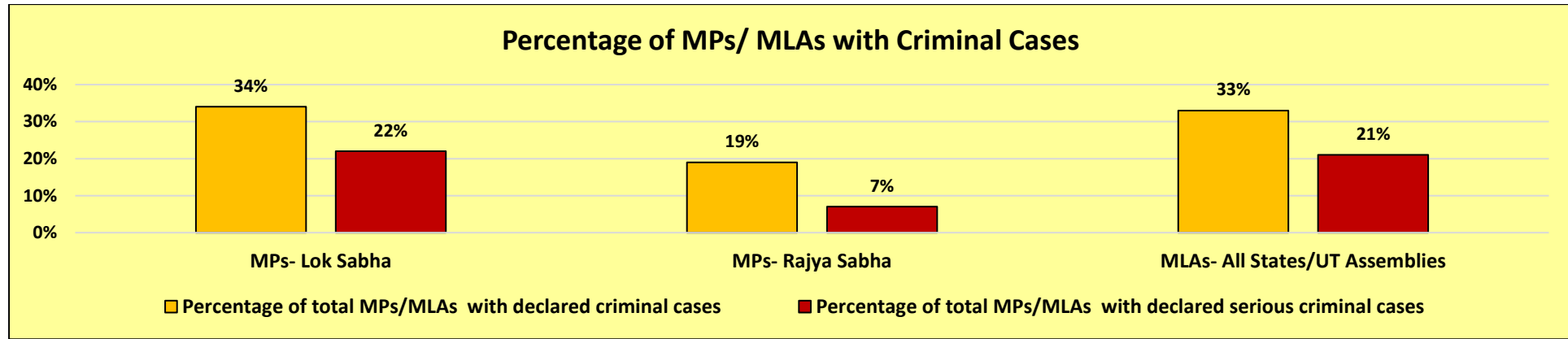


Figure 2: Percentage of MPs/ MLAs with criminal cases

**MPs/ MLAs with Criminal Cases:** Out of the 4852 MPs/MLAs analysed, 1581(33%) members have declared criminal cases against themselves in a self-sworn affidavit filed with the ECI before their most recent elections. 184 (34%) out of 543 Lok Sabha MPs, 44(19%) out of 231 Rajya Sabha MPs and 1353(33%) out of 4078 MLAs analysed from all states have declared criminal cases against themselves.



**MPs/ MLAs with Serious Criminal Cases:** Out of the 4852 MPs/MLAs analysed, 993(20%) members have declared serious criminal cases against themselves in a self-sworn affidavit filed with the ECI before their most recent elections. 117 (22%) out of 543 Lok Sabha MPs, 16(7%) out of 231 Rajya Sabha MPs and 860(21%) out of 4078 MLAs analysed from all states have declared serious criminal cases against themselves.

**MPs/MLAs who have declared cases related to murder:** 87 out of 4852 MPs / MLAs analysed have declared cases related to murder ( IPC Section - 302, 304A,306) against themselves. Out of 543 Lok Sabha MPs, 13 MPs have declared cases related to murder against themselves.

**MPs/MLAs who have declared cases related to attempt to murder:** 190 out of 4852 MPs/ MLAs analysed have declared cases related to attempt to murder (IPC Section- 307). Out of 543 Lok Sabha MPs analysed, 17 MPs have declared cases related to attempt to murder. Out of 231 Rajya Sabha MPs analysed, 15 MPs have declared cases related to attempt to murder.

**MPs/MLAs who have declared cases related to kidnapping:** 64 out of 4852 MPs/MLAs analysed have declared cases related to kidnapping (IPC Section 360,363, 363A, 364, 364A, 365, 366) against themselves. 5 out of 543 Lok Sabha MPs have declared cases related to kidnapping against themselves.

**MPs/MLAs who have declared cases of crime against women:** 52 out of 4852 MPs/MLAs analysed have declared cases of crime against women such as rape, dowry death, Assault or criminal force to woman with intent to outrage her modesty etc. (IPC Section 354, 498A, 509, 376). 2 out of 543 Lok Sabha MPs have declared cases related of crime against women against themselves.

**Votes by MPs/MLAs who have declared criminal cases:** Based on the number of votes that MPs / MLAs who have declared criminal cases, are entitled to cast, a total of 367393 votes (34%) out of 1091472 votes analysed are of MPs/MLAs who have declared criminal cases against themselves.

- For Lok Sabha, 130272 (34%) out of 384444 votes analysed are of members who have declared criminal cases against themselves.
- For Rajya Sabha, 31152(19%) out of 163548 votes analysed are of members who have declared criminal cases against themselves.
- For all State/UT Assemblies combined, 205969 (38%) out of 543480 votes analysed are of members who have declared criminal cases against themselves.
- Among the state assemblies, based on the number of MLAs who have declared criminal cases against themselves, the maximum number of votes are from Uttar Pradesh which has 29744 out of 83616 votes analysed, of the members who have declared criminal cases against themselves.

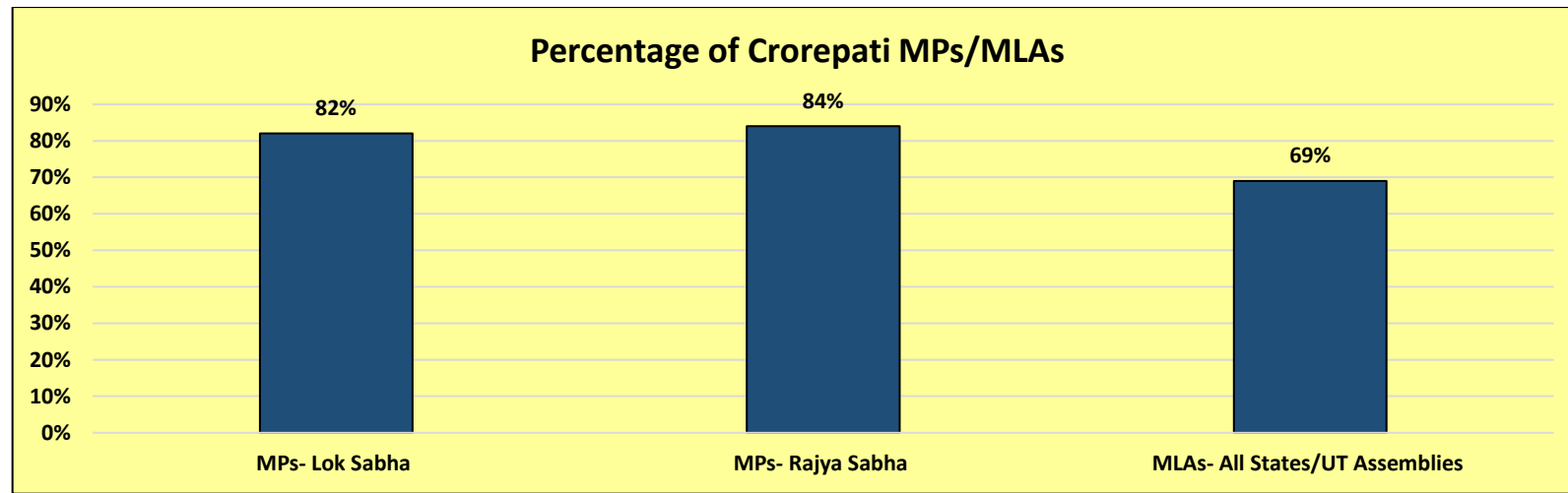


Figure 3: Percentage of Crorepati MPs/MLAs

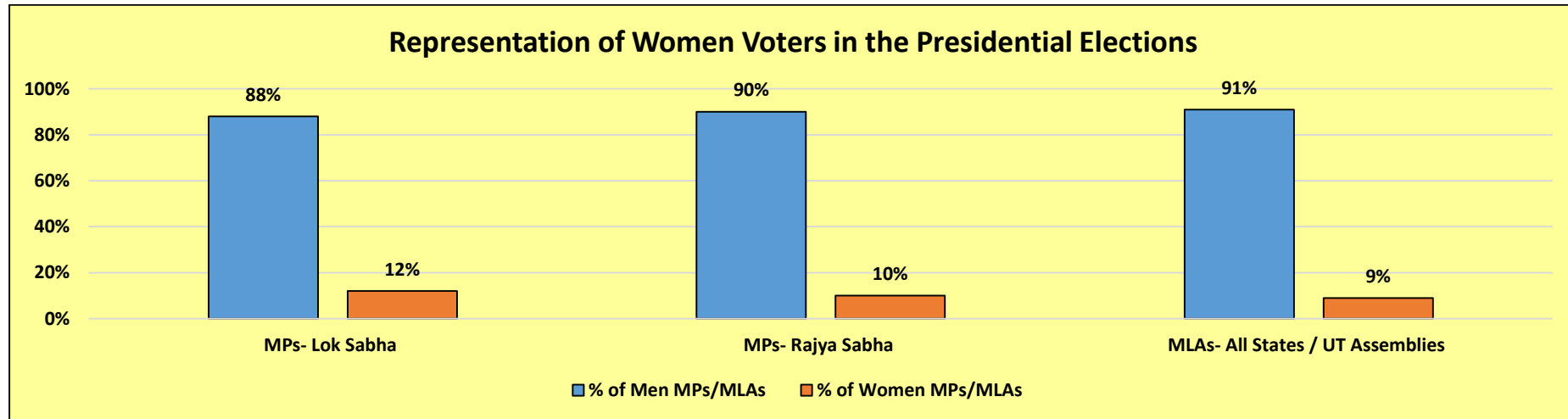


Figure 4: Representation of Women Voters in Presidential Election

- Out of the total 4852 MPs/MLAs who are entitled to vote in the upcoming Presidential Elections, only 451(9%) are women.
- Based on the number of votes the MPs/MLAs are entitled to vote, 113687 (10%) out of 1091472 are women votes.



- Among MPs, Lok Sabha has 12% or 46020 votes out of 384444 from 65 women MPs and Rajya Sabha has 10% or 16284 out of 163548 votes analysed from 23 women MPs.
- All State / UT assemblies combined have 51383(9%) votes out of 543480 votes from 363 women MLAs.
- Among State assemblies, Uttar Pradesh has the maximum amount of women votes with 8320 votes out of 83616(40 out of 402 MLAs) followed by West Bengal with 6191 votes out of 44243 (41 out of 293 MLAs) and Madhya Pradesh with 4192 votes out of 30130(32 out of 230 MLAs).
