Analysis of Donations declared by Regional Political Parties – FY 2018-19

This report, prepared by **Association for Democratic Reforms** (ADR) focuses on donations declared by Regional Political Parties, during the Financial Year 2018-19, as submitted by the parties to the Election Commission of India (ECI).

Executive Summary

The **executive summary** below lists the key observations drawn from the report:

I. Status of submission of Contribution Reports by Regional Parties to ECI (FY 2018-19)

Out of 52 regional parties analyzed, **only 15** had submitted their donations reports to the ECI in the stipulated time period. 10 other regional parties have delayed their submission by a maximum of 34 days to 4 days. There are **26 regional political parties who have defaulted** in the submission of their donations reports to the ECI during FY 2018-19, till date, 6th May, 2020. The **contribution report of Shiv Sena available for FY 2018-19 on the ECI website is incomplete; hence, it has not been analyzed in this report.**

II. <u>Donations to Regional Parties as declared to the ECI (FY 2018-19)</u>

- a. Under Section 29C (1) of the Representation of People's Act, 1951, political parties are required to prepare a report providing details of contributions in excess of twenty thousand rupees from any person in a particular financial year to avail 100% tax exemption. However, in FY 2018-19, we see that 6 regional parties (AAP, GFP, DMK, SP, MNS and NPF) have also provided details of donations received below Rs 20,000 in their contribution reports.
- b. The total amount of donations declared by 25 regional parties analysed, including both above and below Rs 20,000, was **Rs 230.45** cr, from **4046** donations.
- c. No donations have been declared by **JVM-P** and **AIADMK** for FY 2018-19.
- d. With regard to the total amount of donations, YSR-C leads with Rs 80.575 cr from 142 donations followed by TRS, which has declared receiving Rs 41.275 cr from 62 donations. BJD declared receiving Rs 29.317 cr that is the third highest amongst all regional parties.
- e. **65.60%** or **Rs 151.167** cr of the total donations received by regional parties have been received solely by top three regional parties.




Chart: Top 10 Regional Parties to declare maximum donations for FY 2018-19

III. Comparison of donations received by Regional Parties between FY 2017-18 and FY 2018-19

- a. YSR-C, TRS, TDP and PMK saw the maximum percentage increase in their income from donations between FY 2017-18 and 2018-19.
- b. Donations to **PMK** increased by **9106%**, followed by **TDP** for which it was **1407%**, **TRS** for which it was **1148%**, and **YSR-C** that saw an increase of **865%**.
- c. YSR-C, TRS, TDP, BJD and AAP declared the highest increase in the amount of donations received between FY 2017-18 and 2018-19, of Rs 72.225 cr, Rs 37.968 cr, Rs 24.442 cr, Rs 16.277 cr and Rs 6.284 cr respectively.








Chart: Comparison of donations received by top 5 Regional Parties between FY 2017-18 & 2018-19

IV. Cash donations declared by the Regional Parties – FY 2018-19

- a. Out of the total donations of **Rs 230.45 cr** declared by the regional parties, **Rs 3.20 cr** from **450 donations** was received in cash during FY 2018-19. This formed **1.39%** of the **total donations** to the parties.
- b. **Maximum donations in cash** was declared by **DMK**, which collected a total of **Rs 2.978 cr**, followed by **PMK** with **Rs 10.60 lakhs**, **NPF** with **Rs 7.90 lakhs**, **RLD** with **Rs 3 lakhs** and **DMDK** with **Rs 1 lakh**.
- c. Among all the states, donors from **Tamil Nadu** made the highest donations of **Rs 1.58 cr** in cash followed by donors from **Uttar Pradesh** who donated a total of **Rs 3 lakhs** in cash.
- d. Donations worth **Rs 1.59 cr in cash did not have address details.** 2 Regional Parties **(NPF and DMK)** have received such donations in FY 2018-19. (Refer: Annexure 1)




Chart: Donations received in cash by Regional Parties for FY 2018-19





V. <u>State-wise donations to Regional Parties</u>

- a. **Segregation of donations according to location** was made by **ADR** based on the **addresses** provided by the parties in their donations report to the ECI.
- b. <u>Donations declared by the regional parties contained details of donations received from 27 States/Union Territories/common capitals and 16 countries according to the declared address of donors.</u> Only AAP declared donations from abroad.
- c. Regional parties have declared receiving the highest amount of **Rs 77.215 cr** from **Delhi**, followed by **Rs 45.227 cr** from **Telangana** and **Rs 43.918 cr** from **Maharashtra**.




Chart: Top 5 states from where Regional Parties received the highest donations for FY 2018-19

- d. **3.90%** or **Rs 0.57 cr** of the total donations above Rs 20,000 to **AAP** was received from **abroad**. (Annexure- 2)
- e. A total of **Rs 6.85 cr**, (2.97% of total donations received by the regional parties, FY 2018-19), **could not be** attributed to any State/Union Territory due to incomplete or lack of information provided by the parties.




Chart: Donations classified based on address as declared by Regional Parties for FY 2018-19





VI. <u>Donors from Corporates/ business sectors Vs. Individual donors</u>

- a. **292** donations from **corporate/business** sectors amounting to **Rs 188.42 cr** were made to the regional parties while **3414** individual donors donated **Rs 39.97 cr** to the parties during FY 2018-19.
- b. In case of <u>National Parties</u>, **1776** donations were made by corporate/business sectors amounting to **Rs 876.11** cr (92.06% of total donations) while **3509** individual donors donated **Rs 71.407** cr (7.50% of total donations) during FY 2018-19.
- c. With the maximum number of donations during FY 2018-19, YSR-C has declared 43 donations from corporate/business sectors amounting to Rs 70.61 cr while 78 individual donors donated Rs 9.74 cr to the party.

VII. <u>Disclosure of PAN details in donations</u>

- a. Out of 23 regional parties who had declared receiving donations, **16 parties**, have **declared donations of donors without their PAN details.**
- b. Rs 40.42 cr or 17.54% of the total amount of donations received by regional parties do not have PAN details.
- c. It is to be noted that parties like **PMK**, **NDPP**, **NPF**, **DMDK** and **JMM have not provided PAN details of even a single donor** in their donations statement.




Chart: Status of declaration of PAN by Regional Parties for FY 2018-19





Observations

- a. ECI notification dated 29th August,'14 stated that "...no tax deduction shall be allowed on the contributions made in cash by any person or company to a political party. Accordingly, the political party shall maintain name and address of all such individuals, companies or entities making donation to it, excepting petty sums, donated by the public only during its public rallies". This notification was applicable for donations made from FY 2014-15 onwards. 2 regional parties DMK (Rs 1.513 cr) and NPF (Rs 7.90 lakhs) have received cash donations worth a total of Rs 1.59 cr that do not have address details.
- b. For FY 2018-19, address details for **516** donations worth **Rs 6.85** cr (**2.97**% of total donations received by the regional parties) were not declared by parties.
- c. Out of 23 Regional Parties who had declared receiving donations, **16 parties**, have **declared receiving 728 donations worth Rs 40.42 cr without PAN details.**
- d. For a large number of donations, **regional parties have mentioned 'Online/RTGS/Cheque no.**' as mode of contribution without providing any further information such as bank details. This makes it difficult to verify whether the information given is accurate or not.
- e. Out of a total of **4046** donations, mode of contribution for **776 donations** worth **Rs 56.87 cr** is incomplete/undeclared. Of these, mode of payment for **59 donations** worth **Rs 39.775 cr** received by **TRS** is incomplete/undeclared.
- f. Three regional parties namely TRS, SHS and BJD declared receiving donations via Electoral Bonds worth Rs 141.50 cr, Rs 60.40 cr and Rs 211.50 cr, respectively. The donations to these parties through Electoral Bonds have not been accounted for in this report, since they were accounted for in the <u>analysis of audit reports</u> of these parties for FY 2018-19, as per the format.
- g. Shiv Sena's contribution report available on the ECI website for FY 2018-19 is incomplete at the time of preparation of this report. Hence, it has not been considered for analysis in this report.

Recommendations

- a. The Supreme Court gave a judgment on September 13, 2013 declaring that no part of a candidate's affidavit should be left blank. Similarly, no part of the Form 24A submitted by political parties providing details of donations above Rs 20,000 should be blank.
- b. The National and Regional Parties should, ideally, **lead by example** by filing **complete and correct statements** of donations to the ECI **well in time** for public scrutiny so as to encourage financial transparency.
- c. It is suggested that the ECI publicizes on its website details of the action taken (if any) against political parties that fail to provide required details (such as name and address) of individuals, companies or entities making donations in cash.
- d. Parties **not adhering** to the deadline fixed by the Election Commission of India should be **penalized** by making them **liable to pay tax on 100% of their income** from various sources.
- e. **Incomplete contributions reports** having missing or incorrect PAN/mode of payment details must **be returned to the parties** by the ECI, to deter them from providing incomplete information.
- f. The National and Regional political parties must provide all information on their finances under the Right to **Information Act.** This will go a long way in strengthening political parties, elections and democracy.





Detailed Report

Political parties rely heavily on donations for contesting elections and running their daily affairs. They receive huge sums of money in the form of donations/ contributions from corporates or business houses, trusts and individuals. Section 29C of the Representation of People Act, 1951 mandates that political parties submit their contribution details in excess of Rs 20,000 received from any person or a company to the ECI annually, in order to enjoy 100% tax exemption.

This report, prepared by **Association for Democratic Reforms** (ADR) focuses on donations received by 25 Regional Political Parties, during the Financial Year 2018-19, as submitted by the parties to the Election Commission of India (ECI).

I. Donations declared by Regional Parties to the ECI (FY 2018-19)

- a. Under Section 29C(1) of the Representation of People's Act, 1951, political parties are required to prepare a report providing details of contributions in excess of twenty thousand rupees from any person in a particular financial year to avail 100% tax exemption. However, in FY 2018-19, we see that 6 regional parties (AAP, DMK, GFP, SP, MNS and NPF) have also provided details of donations received below Rs 20,000 in their contributions report, amounting to Rs 7 lakhs.
- b. The total amount of donations declared by regional parties, including both above and below Rs 20,000, was **Rs 230.45 cr**, from **4046 donations**.
- c. With regard to the total amount of donations, YSR-C leads with Rs 80.575 cr from 142 donations followed by TRS, which has declared receiving Rs 41.275 cr from 62 donations. BJD declared receiving Rs 29.317 cr that is the third highest amongst all regional parties.
- d. **65.60%** or **Rs 151.167 cr** of the total donations received by regional parties have been received solely by top three regional parties.
- e. No donations have been declared by JVM-P and AIADMK for FY 2018-19.




Chart: Top 10 Regional Parties to declare maximum donations for FY 2018-19

II. Comparison of donations received by Regional Parties between FY 2017-18 and FY 2018-19

- a. **3 regional parties** considered for this report did not submit their one year contribution report in the two financial years: **GFP, INLD and NDPP.** While **Shiv Sena's** contribution report available on the ECI website for FY 2018-19 is incomplete.
- b. **SAD and NPF** are the **two regional parties**, which have declared a **decrease** in the amount of donations received between FY 2017-18 and 2018-19.
- c. The overall donations of **15 regional parties** saw **an increase** in the current financial year, 2018-19 from the previous financial year, 2017-18.





d. The highest percentage increase in the donations received between FY 2017-18 and 2018-19 was declared **PMK**, **TDP**, **TRS** and **YSR-C** of **9106%**, **1407%**, **1148%** and **865%** respectively.




Chart: Comparison of donations received by top 5 Regional Parties between FY 2017-18 & 2018-19

III. Cash donations declared by Regional Parties in FY 2018-19

- a. Out of the total donations of **Rs 230.45 cr** declared by the regional parties, **Rs 3.20 cr** from **450 donations** was received in **cash** during FY 2018-19. This formed **1.39%** of the **total donations** to the parties.
- b. Maximum donations in cash was declared by DMK, which collected a total of Rs 2.978 cr, followed by PMK with Rs 10.6 lakhs, NPF with Rs 7.90 lakhs, and RLD with Rs 3 lakhs and DMDK with Rs 1 lakh.
- c. Among all the states, donors from **Tamil Nadu** made the highest donations of **Rs 1.58 cr** in cash followed by donors from **Uttar Pradesh** who donated a total of **Rs 3 lakhs** in cash.
- d. 2 regional parties (NPF and DMK) have received cash donations worth a total of Rs 1.59 cr that do not have address details.




Chart: Donations received in cash by Regional Parties for FY 2018-19

IV. State-wise donations to Regional Parties in FY 2018-19

- a. **Segregation of donations according to State and sectors** was made by **ADR** based on the **names** and **address** provided by the parties in their donations report to the ECI.
- b. Donations declared by the regional parties contained details of donations received from **27 States/Union**Territories/common capitals and **16 countries** according to the declared address of donors. Only AAP declared donations from abroad. (Refer Annexure 5)
- c. Amongst all the states/UTs/common capitals, the highest amount of **Rs 77.215 cr** was donated to the regional parties from **Delhi**, followed by **Rs 45.227 cr** from **Telangana** and **Rs 43.918 cr** from **Maharashtra**.

- d. **AAP** has received **Rs 0.57 cr** worth of donations from outside India, becoming the **only regional party** that has **received donations from across 16 countries outside India** (Refer Annexure 2 for complete details of top 50 donations from abroad).
- e. Top 5 countries from where AAP has received donations are United States, UAE, Singapore, Canada and Australia.








Chart: Top 5 countries from where AAP received donations in FY 2018-19




Chart: Donations classified based on address as declared by Regional Parties for FY 2018-19

V. Mode of contribution to Regional Parties in FY 2018-19

- a. Regional parties declared receiving a total of Rs 105.955 cr through Cheque/DD from a total of 400 donations where complete contribution details were provided, forming 45.98% of the total donations received. While 2420 donations, amounting to Rs 64.42 cr was received in the form of Bank Transfer, forming 27.95% of the total donations received.
- b. Mode of contribution details for donations worth Rs 56.84 cr or 24.67% of the total amount were incomplete.
- c. **450 donations** amounting to **Rs 3.20 cr** was received in cash.




Chart: Mode of contribution declare by Regional Parties for FY 2018-19

- c. With the maximum number of donations during FY 2018-19, YSR-C has declared 43 donations from corporate/business sectors amounting to **Rs 70.61 cr** while 78 individual donors donated **Rs 9.74 cr** to the party.




Chart: Sector-wise donations to Regional Parties for FY 2018-19

- b. Parties like **PMK**, **NDPP**, **NPF**, **DMDK** and **JMM** who have declared 100 percent donations above Rs 20,000, have not provided **PAN** details of even a single donor in its donations statement.
- c. **BJD** has received the maximum amount, **Rs 27 cr** from donations without PAN details, followed by **PMK**, which received an amount of **Rs 4.198 cr**, and **YSR-C** that received **Rs 3.227 cr** from such similar donations.
