Summary and Highlights

Association for Democratic Reforms (ADR) and **Andhra Pradesh Election Watch** have analyzed the criminal, financial and other background details of **165** out of **175** sitting MLAs. In the current assembly 10 seats are vacant.

This analysis is based on the affidavits submitted by the candidates prior to the 2019 Assembly elections and bye elections conducted thereafter.

The following 10 constituencies are vacant:



CRIMINAL BACKGROUND

- MLAs with criminal cases: Out of 165 sitting MLAs analysed, 90 (55%) Sitting MLAs have declared criminal cases against themselves.
- MLAs with serious criminal cases: 50 (30%) Sitting MLAs have declared serious criminal cases.
- MLAs with declared cases related to murder: 1 Sitting MLA has declared cases related to murder (IPC section 302).
- MLAs with declared cases related to attempt to murder: 9 Sitting MLAs have declared cases related to attempt to murder (IPC section 307).
- MLAs with declared cases related to Crime Against Women: 5 Sitting MLAs have declared cases related to crimes against women.
- Party wise sitting MLAs with criminal cases: 79 (56%) out of 140 MLAs from YSRCP, 6 (33%) out of 18 MLAs from TDP and 5 (71%) out of 7 Independent MLAs have declared criminal cases against themselves in their affidavits.
- Party wise sitting MLAs with serious criminal cases: 45 (32%) out of 140 MLAs from YSRCP, 1 (6%) out of 18 MLAs from TDP and 4 (57%) out of 7 Independent MLAs have declared serious criminal cases against themselves in their affidavits.



Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- 3. If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- 6. Offences that are mentioned in Representation of the

People Act (Section 8)

- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.








Figure: Party wise percentage of MLAs with declared criminal cases





FINANCIAL BACKGROUND

- Crorepati MLAs: Out of 165 sitting MLAs analysed, 154 (93%) are crorepatis.
- Party wise crorepati MLAs: 132 (94%) out of 140 MLAs from YSRCP, 17 (94%) out of 18 MLAs from TDP and 5 (71%) out of 7 Independent MLAs have declared assets valued more than Rs 1 crore.




Figure: Party Wise Percentage of Crorepati MLAs

- Average assets: The average of assets per sitting MLA is Rs.28.34 crore.
- <u>Party wise average assets:</u> The average assets per MLA for **140 YSRCP** MLAs analysed is **Rs.22.59 crores**, **18 TDP** MLAs analysed is **Rs.71.44 crores** and **7 Independent** MLAs have average assets of **Rs.32.36 crores**.

OTHER BACKGROUND DETAILS

- <u>Education Details of MLAs</u>: 56(34%) MLAs have declared their educational qualification to be between 5th and 12th standard while 106 (64%) MLAs have declared having an educational qualification of graduate or above. 1 MLA is Diploma holder. 1 MLA has declared himself to be just literate and 1 MLA has declared himself Illiterate.
- Age details of MLAs: 71 (43%) MLAs have declared their age to be between 25 and 50 years while 94 (57%) MLAs have declared their age to be between 51 and 80 years.
- Gender details of MLAs: Out of 165 MLAs analysed, 14 (8%) MLAs are women.




Figure: Analysis of MLAs on the basis of education




Figure: Analysis of MLAs on the basis of age groups


