# Assam Legislative Assembly: Bye -Elections 30 October, 2021 Criminal Background, Financial, Education, Gender and other details of Candidates

Association for Democratic Reforms and Assam Election Watch have analyzed affidavits for all **31** candidates contesting in Assam Assembly Bye-election to be held in **5** constituencies namely Bhabanipur, Tamulpur, Gossaigaon, Thowra and Mariani on 30th October, **2021**.

- There are 5 (16%) candidates who have declared criminal cases against themselves. Out of these, 4 (13%) have declared serious criminal cases against themselves.
- > 9 (29%) candidates are crorepati.
- > The average assets per candidate contesting in the bye election from Assam is Rs. 1.35 Crore.
- > There are 8 candidates who have declared liabilities.
- > All **31** candidates are men, there are no women candidates.


