

Assam Legislative Assembly: Bye Election 2019

Criminal Background, Financial, Education, Gender and other details of Candidates

Association for Democratic Reforms and Assam Election Watch have analyzed affidavits for all **20 candidates** contesting in Assam Assembly Bye-election to be held in 4 constituencies namely **Jania, Rangpara, Ratabari(SC) and Sonari on 21st October, 2019.**

- There are **3 (15%)** candidates who have declared criminal cases against themselves. Out of these, 2 have declared serious criminal cases against themselves.
- **4(20%)** candidates are crorepati.
- The average assets per candidate contesting in the bye election from Assam is **Rs. 42.82 Lacs.**
- There are 7 candidates who have declared liabilities.
- Only one-woman candidate is contesting in Assam bye election 2019.
