Assam Election Watch Lok Sabha elections 2009

Lok Sabha 2009 elections were held in two phases in Assam on April 16, 2009 and April 23, 2009. This chapter includes the analysis of voting trend, criminalization, money power, gender etc in these elections. Information provided by ECI and details from the affidavits filed by contesting candidates have been used for above analysis.

Growth of political parties

In Lok Sabha 2004, 17 parties contested which rose to 25 in Lok Sabha 2009 elections. This reflects a rise of 47 % in the number of parties from Lok Sabha 2004 Elections to Lok Sabha 2009 Elections.

Growth in number of candidates

158 candidates contested Lok Sabha 2009 elections from Assam as compared to 116 candidates in Lok Sabha 2004. There was a jump of 36% in number of candidates contesting in 2009.

Executive summary for <u>candidates</u> and <u>MPs</u>

Summary for candidates

- Affidavits of 155 candidates out of 158 contesting Lok Sabha 2009 elections were analyzed by Assam Election Watch*.
- Out of these 155 candidates, 12 candidates or 8% declared pending criminal cases against them. BJP had 2 out of 7 (29%) candidates with pending criminal cases.
- Out of these 12 candidates with pending criminal cases, 4 had pending serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc.
- There were 26 candidates of three main parties (INC, BJP & AGP) and out of these 26 candidates 4 (15%) had pending criminal cases against them. Comparing this to Lok Sabha 2004 elections, there were 38 candidates

of the same three major parties. Out of these 38 candidates 3 (8%) had pending criminal cases against them.

- There were 6 IPC charges of heinous nature on the candidates which included murder, kidnapping, extortion, etc.
- There was 1 Red Alert constituency, Nowgong, where 3 contesting candidates had pending criminal cases.
- A total of 14 candidates out of 155 i.e. 9% were crorepatis.
- A total of 13 candidates declared liabilities above 5 lakhs.
- Among major parties, the approximate average asset per candidate for ADUF was Rs. 16 crores, for INC was Rs 6 crores.
- 48% of candidates (75 of 155) had not furnished PAN card details.
- Number of women candidates was just 11(7%) as compared to 147 of men (93%).
- 59% candidates (92 of 155) were graduates & above.
- None of the parties managed to get votes anywhere near 50%. The highest votes polled were approx 35% by INC which was about 24% of the total registered voters. BJP and AUDF managed to get approximately 16% of the total votes polled.

Summary for MPs

- All 4 candidates with serious criminal cases pending against them were rejected by the voters.
- The number of crorepati MPs has increased from 2 in Lok Sabha 2004 to 5 in Lok Sabha 2009.
- Among major parties, the approximate average asset per MP for INC was Rs. 2 crores and for BJP was Rs. 55 lacs.
- Average asset for a MP from Assam was Rs 3.23 crores.
- All 14 MPs, declared their PAN details.
- Out of 11 women candidates, only 2 managed to win. Hence only 14% of MPs from Assam in current Lok Sabha are women.

Voting and winning trend

The % of votes polled by major parties

The % of votes cast by four major parties clearly shows that none of the parties got anywhere close to the 50% mark. Total voting in the state was only 69%. INC managed approx 35 % of the votes cast and only 24% of the registered voters. BJP managed just 16% votes cast and 11% registered voters. The total electorate in Assam was 1,74,70,161 and the total votes cast were 1,21,41,171.





Analysis based on pending criminal cases

Pending criminal cases- analysis for <u>candidates</u>

Total 155 affidavits were analyzed by Assam Election Watch for Lok Sabha 2009 elections. Out of these 155 candidates, 12 candidates or 8% declared pending criminal cases against them. Out of these 12 candidates with pending criminal cases, 4 had pending serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc.


Party wise break up for candidates with pending criminal cases

A total of 12 candidates contesting elections from ASSAM had pending criminal cases against them. Out of 7 candidates of BJP, 2 (29%) had pending criminal cases.

For all 3 major parties- INC, BJP & AGP which contested in the Lok Sabha 2004 and Lok Sabha 2009 elections, the number of candidates with pending criminal cases has increased in 2009 elections as compared to 2004 elections. A detailed analysis is provided below.






Analysis based on assets- for MPs

Out of 14 MPs from Assam 5 are crorepatis as compared to 2 crorepatis in Lok Sabha 2004. There has been an increase of 150% in number of crorepati MPs from Lok Sabha 2004. The average asset of a MP in Lok Sabha 2004 was Rs 167 lakhs which rose to Rs 323 lakhs in 2009. Between Lok Sabha 2004 & Lok Sabha 2009 there has been an average asset increase of 93% for MPs.

Chances of winning based on assets

As can be seen from the table, the higher the assets the more are the chances of winning of a candidate. In the Lok Sabha 2009 elections, 25% of the candidates who declared assets more than 5 crore and above won and 35% of the candidates who declared assets in between 50 lakhs to 5 crore won. On the other hand there was just 1 MP out of 89 candidates who declared assets of less than 10 lakhs. The election results seemed to be highly influenced by the money power of the candidates



Figure: Comparison average assets for candidates & MPs in Lok Sabha 2009




Asset position in constituency among candidates and chances of winning

The following table gives an analysis of asset position in constituency among candidates (highest asset to lowest asset) and their chances of winning. From 8 or 57% constituencies, candidates with highest declared assets according to their own self sworn affidavits emerged as MPs. From 14% constituencies candidates with second highest declared assets won. The number of MPs kept decreasing according to their position based on assets in the constituency as per their self declared affidavits.


Female representation in Lok Sabha 2009 elections
