

## Analysis of Criminal, Financial and Other Background details of Candidates from Bihar (Phase-6) for Lok Sabha 2014

Association for Democratic Reforms (ADR) and Bihar Election Watch have analyzed the self-sworn affidavits of 89 candidates out of 90 candidates from Bihar (Phase-6) for Lok Sabha Elections 2014 as given by the ECI. The affidavit of MD.HASIB from Vaishali constituency of Rashtriya Samanta Dal was not analysed due to incomplete affidavit uploaded on the ECI website.

## Executive Summary

### Criminal Background

- **Candidates with Criminal Cases:** Out of the 89 candidates analysed, **30 candidates (34%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **23 candidates (26%)** have declared serious criminal cases relating murder, to attempt to murder, robbery, dacoity kidnapping etc.
- **Party wise Candidates with Criminal Cases:** **1 (50%)** out of 2 candidates fielded by INC, **4 (80%)** out of 5 candidates from BJP, **4 (67%) out of 6** candidates from JD(U), **4 (67%) out of 6** candidates from BSP and **1 (25%) out of 4** candidates from RJD have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **1 (50%)** out of 2 candidates fielded by INC, **3 (60%)** out of 5 candidates from BJP, **3 (50%) out of 6** candidates from JD(U) and **3 (50%) out of 6** candidates from BSP have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Murder:** 6 candidates have declared **cases related to murder (IPC Section 302)**
- **Candidates with cases related to Attempt to Murder:** 7 candidates contesting from Bihar (Phase-6) in the Lok Sabha elections, 2014 have declared **cases related to attempt to murder**.
- **Candidates with cases related to Robbery and Dacoity:** 2 candidates, **Satish Dubey** of BJP from Valmiki Nagar constituency and **Vijay Kumar Sahni** of JD(U) from Vaishali constituency have cases related to **robbery and dacoity**.
- **Candidates with cases related to Kidnapping:** 3 candidates, **Amar Nath Yadav** from Siwan constituency of CPI(ML)(L), **Virendra Prasad Gupta** also of CPI(ML)(L) from Valmiki Nagar constituency and **Rama Kishore Singh** of LJP from Vaishali constituency have declared cases related to **Kidnapping**.
- **Red Alert Constituencies\*:** **5 out of 6 constituencies** in Bihar (Phase-6) have at least 3 candidates with declared criminal cases. Vaishali constituency has the most number of candidates with criminal cases, i.e. 10 candidates with declared criminal cases.

**Criteria for serious criminal cases**

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

## Financial Background

- **Crorepatis:** Out of the 89 candidates, **37 (42%)** are crorepatis.
- **Party-wise Crorepatis:** Both candidates from **INC**, **3** candidates (**60%**) out of 5 from **BJP**, all **6** candidates of **JD(U)**, all **4** candidates from **RJD** and **3 (60%)** out of 5 candidates from **AAP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting from Bihar (Phase-6) in Lok Sabha 2014 elections is **Rs. 2.74 crores**.
- **Party-wise Average Assets:** Among major parties, the average asset of **2 INC** candidates is **Rs 3.55 crores**, **6 JD(U)** candidates have average asset of **Rs. 18.97 crores**, **5 BJP** candidates have average assets of **Rs 1.54 crores**, **4 RJD** candidates have average asset of **Rs 4.43 crores** and **5 AAP** candidates have **Rs 1.25 crores**
- **High Asset Candidates:** **4** candidates have declared more than **Rs. 10 crore worth of assets**. Total assets include Self Assets and Others' Assets. These four candidates are given below:

- **Candidates who have not declared Income Tax Details\*:** 50 (56%) candidates out of 89 analyzed have not declared income tax details.\* *Some candidates may be exempted from filing Income Tax Returns*
- **Candidates with High Assets who have not declared Income Tax Details:** 9 candidates out of 89 candidates have declared total assets worth more than Rs 1 crore but have not declared Income Tax Details. The top three candidates with high assets who have not declared income tax details are as following:

- **Undeclared PAN:** 30 (34%) out of 89 candidates analysed have not declared their PAN details.
- **Cronepati Candidates who have not declared PAN details:** 2 candidates with total assets worth more than Rs. 1 crore have not declared their PAN details.

### Other Background details (Education, Gender, Age)

- **Candidates Education:** 45 (51%) out of 89 candidates are **12<sup>th</sup> pass or below**. 44 (49%) out of 89 candidates are **graduates or above**.
- **Candidates' Age:** 63 (71%) out of 89 candidates have declared their age to be between **25 to 50 years** of age. 24 (27%) out of 89 candidates have declared their age to be between **51 to 70 years** of age.
- **Women Candidates:** 5 (6%) out of 89 candidates are women.

## Executive Summary – Upto Phase 6

- **Total candidates analyzed:** 605 candidates
- **Candidates with declared Criminal Cases so far:** 187 (31%) out of 605 candidates
- **Candidates with declared Serious Criminal Cases:** 132 (22%) out of 605 candidates
- **Red Alert Constituencies:** 35 out of 40 constituencies in Bihar have more than 3 candidates who have declared criminal cases against themselves.




