### Summary and Highlights

Consequent to the expansion of the cabinet, Bihar Election Watch and Association for Democratic Reforms have analysed the self-sworn affidavits of **28 out of 31 Ministers** including Chief Minister from Bihar State Assembly 2020. A **Bharatiya Janata Party** Minister namely **Ram Surat Kumar** has not been analysed due to the unavailability of his complete and properly scanned affidavit on the ECI website while making the report. The details of **Ashok Chaudhary** and **Janak Ram** were not analysed as they are not currently members of either any house, state assembly or legislative council.

The information is based on the affidavits submitted by the candidates prior to 2020 Bihar Assembly Elections and Bihar Legislative Council Elections.

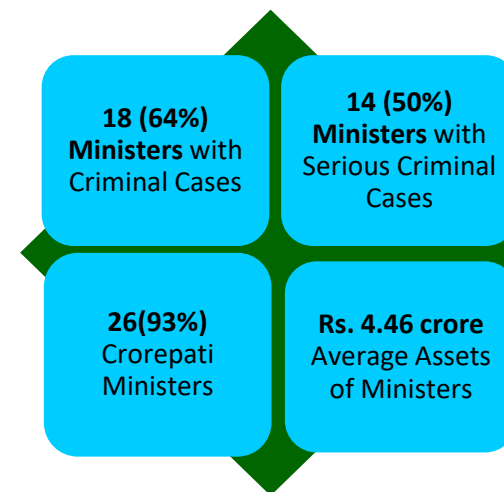

### **Criteria for serious criminal cases**

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Average Assets:** The average assets of **28** ministers analysed is **Rs 4.46 crores**.
- **Minister with Highest Assets:** The minister with the highest declared total assets is Sanjay Kumar Jha Elected from Bihar Legislative Assembly with assets worth Rs. 22.37 crores.
- **Minister with Lowest Assets:** The minister with the lowest declared total assets is Mohd. Zama khan of Chainpur constituency with assets worth Rs. 30.04 lakhs.
- **Liabilities:** A total of 20 ministers have declared liabilities out of which the minister with the highest liabilities is Mukesh Sahani Elected from Bihar Legislative Assembly with Rs. 1.54 crores of liabilities.

### **Other Background details (Education, Gender, Age)**

- **Ministers' Education:** **11 (39%)** ministers have declared their educational qualification to be between **8<sup>th</sup> and 12<sup>th</sup>** standard while **16 (57%)** ministers have declared having an educational qualification of **graduate or above** and one minister, Syed Shahnawaz Hussain has declared that he has a Diploma in national trade certificate in electronics .
- **Ministers' Age:** A total of **11(39%)** ministers have declared their age to be between **35-50 years** while **17(61%)** ministers have declared their age to be between **51-75 years**.
- **Women Ministers:** Out of 28 ministers, **3** are women.
