बिहार इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने बिहार लोक सभा चुनाव के पांचवें चरण में **82 में से 81** उम्मीदवारों के शपथपत्रों का विश्लेषण किया। जो निम्नलिखित निर्वाचन क्षेत्र से चुनाव लड़ रहे हैं।
