Summary and Highlights

Consequent to the reconstitution of the Bihar state cabinet on **16 August 2022**, **Association for Democratic Reforms** and **Bihar Election Watch** have analysed the self-sworn affidavits of **32** out of **33** Ministers including Chief Minister from Bihar State Assembly 2020. A nominated minister namely Ashok Chaudhary of JD (U) is not required to submit his affidavit, hence his information on criminal, financial and other details are not available in the public domain.

This analysis is based on the affidavits submitted by the candidates prior to the 2020 Assembly elections, Bihar legislative council elections and bye elections conducted thereafter.

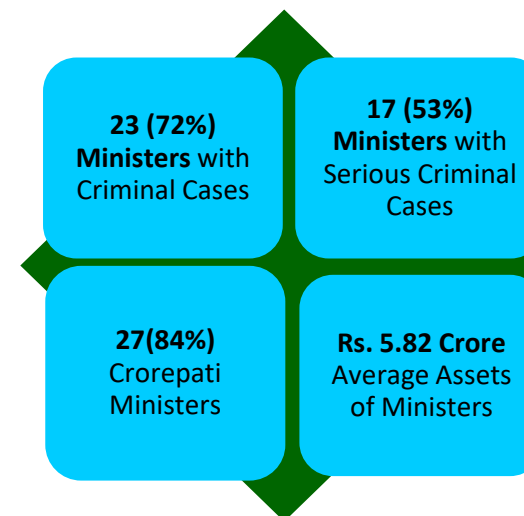

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Minister with Highest Assets:** The minister with the highest declared total assets is **Samir Kumar Mahaseth** from **Madhubani** constituency with assets worth **Rs. 24.45 crores**.
- **Minister with Lowest Assets:** The minister with the lowest declared total assets is **Murari Prasad Gautam** from **Chenari (SC)** constituency with assets worth **Rs. 17.66 lakhs**.
- **Liabilities:** A total of **23(72%)** ministers have declared liabilities out of which the minister with the highest liabilities is **Lalit Kumar Yadav** of **Darbhanga Rural** constituency with **Rs. 2.35 crores** of liabilities.

Other Background details (Education, Gender, Age)

- **Ministers' Education:** **8 (25%)** ministers have declared their educational qualification to be between **8th and 12th** standard while **24 (75%)** ministers have declared having an educational qualification of **graduate or above**.
- **Ministers' Age:** A total of **17(53%)** ministers have declared their age to be between **30-50 years** while **15(47%)** ministers have declared their age to be between **51- 75 years**.
- **Women Ministers:** Out of 32 Ministers, 3 (9%) Ministers are women.
