Association for Democratic Reforms (ADR) and Chhattisgarh Election Watch (CEW) have analyzed the criminal, financial and other background details of all sitting MLAs. This analysis is based on the affidavit submitted by the candidates prior to the last elections.

CRIMINAL BACKGROUND

- **MLAs with criminal cases:** Out of 90 sitting MLAs, **14(16%)** MLAs have declared criminal cases against themselves. Out of 85 MLAs analysed during Chhattisgarh Assembly elections in 2008, **11 (13%)** MLAs had **declared criminal cases** against themselves.
- **MLAs with serious criminal cases:** **7(8%)** MLAs have declared serious criminal cases. Out of **85** MLAs analysed during **Chhattisgarh Assembly elections in 2008**, **8 (9%)** MLAs had **declared serious criminal cases** against themselves.




Figure: Comparison of MLAs with declared criminal cases in 2008 and 2013

- **Party wise sitting MLAs with criminal cases:** 8 (21%) out of 39 MLAs from **INC** and 6(12%) out of 49 MLAs from **BJP** have declared criminal cases against themselves in their affidavits.
- **Party wise sitting MLAs with serious criminal cases:** 5(13%) out of 39 MLAs from **INC** and 2 (4%) out of 49 MLAs from **BJP** have declared serious criminal cases against themselves in their affidavits




Figure: Party wise percentage of MLAs with declared criminal cases in 2008 and 2013

FINANCIAL BACKGROUND

- **Crorepatis**: Out of **90** sitting MLAs , **66(73%)** are crorepatis. Out of **85** MLAs analysed during **Chhattisgarh 2008 assembly elections**, **30 (35%)** MLAs were crorepatis.




Figure: Comparison of crorepati MLAs: 2008 and 2013




Figure: Party wise Comparison of Crorepati MLAs in 2008 and 2013




Figure: Comparison of Average Assets (Rs. in Crores): 2008 and 2013
