Analysis of Criminal, Financial, Education, Gender and other details of Candidates contesting in the First Phase of Chhattisgarh 2013 Assembly Elections

Summary and Highlights

Association for Democratic Reforms and Chhattisgarh Election Watch (CEW) have analysed the self-sworn affidavits of all **143 candidates** who are contesting in **18 constituencies** during the first phase of Chhattisgarh State Assembly Elections.

Criminal:

- <u>Candidates with Criminal Cases:</u> Out of the 143 candidates contesting in the first phase of 2013 Chhattisgarh Assembly Elections, **15 candidates (or 10 %)** have declared criminal cases against them.
- <u>Candidates with Serious Criminal Cases</u>: Out of the 15 candidates who have declared criminal cases,
 6 have declared serious criminal cases. These include murder, kidnapping, criminal intimidation and crime against women.
- Party wise Candidates with Criminal Cases: 2 out of 18 (11%) candidates fielded by INC have declared criminal cases against them while 3 out of 18 (17%) candidates from BJP, 2 out of 18 (11%) candidates from BSP, 1 out of 5 (20%) candidates from SP and have declared criminal cases in their affidavits.
- Murder Related Cases: Mahesh Kumar Gagda of BJP from Bijapur constituency has declared murder charges against him.

Financial:

- Crorepati Candidates: Out of the 143 contesting candidates, 25 (17%) are crorepatis.
- <u>Average Assets:</u> The average asset per candidate contesting in the first phase of 2013 Chhattisgarh Assembly Elections is Rs.57.84 lakhs.
- <u>Party-wise Average Assets:</u> The average asset per candidate for INC (18 candidates) is Rs.1.75 Crores, for 18 BJP candidates the average is Rs.1.34 Crores, for BSP (18 candidates) it is Rs.10.11 Lakhs and the average assets of Samajwadi party (5 candidates) is Rs.9.42 Lakhs.
- <u>High Asset Candidates:</u> The top three candidates with highest declared assets are Mohan Lal Makram of INC from Kondagaon Constituency with declared assets worth Rs.12.63 Crores followed by Raman Singh of BJP from Rajnandgaon Constituency with assets worth Rs.5.61 Crores and Devti Karma of INC from Dantewada Constituency with assets worth Rs 4.63 Crores.
- Low Asset Candidates: Out of 143 candidates analysed, a total of 31 candidates have declared assets less than Rs.5 Lakhs. Bhisham Lal Urvasha, an independent candidate from Khujji constituency has declared assets worth Rs.4000 followed by Ramesh Netam of CPI (M) from Kanker constituency with declared assets worth Rs.5223. Among BJP candidates, Satish Kumar Latiya of BJP from Bhanupratappur





constituency has declared lowest assets worth **Rs.10.43 Lakhs** and **Deepak Kumar Baij** from Chitrakot constituency with declared assets of **Rs.10.53 Lakhs** has the lowest declared assets among INC candidates.

- Liabilities: A total of 18 candidates out of 143 analyzed have declared liabilities of Rs.10 Lakhs and above.
- <u>High Liability Candidates:</u> The top three candidates with highest declared liabilities are Lakheshwar Baghel of INC from Bastar constituency has declared the highest liabilities worth Rs.71.69 Lakhs followed by Santosh Bafna of BJP from Jagdalpur constituency with liabilities worth Rs.69.98 Lakhs and Alka Mudliyar of INC from Rajnandgaon constituency with Rs.49.51 Lakhs worth of liabilities.
- **Undeclared PAN:** 60 out of 143 (42%) candidates contesting in the first phase of 2013 Chhattisgarh Assembly Elections have not declared their PAN details.
- **Candidates who have not declared ITR:** 90 out of 143 candidates (63%) have not declared annual income in their ITR. (Most of the candidates have claimed to be exempted from paying Income Tax)
- <u>High Income Candidates:</u> Raman Singh of BJP from Rajnandgaon constituency has declared the highest income of Rs.32.26 Lakhs in the last Income Tax Returns (ITR) filed for the year 2012-13 followed by Dinesh Gandhi of BJP from Dongargaon constituency with total income of Rs.13.66 Lakhs and Jhadu Ram Nareti of Chhattisgarh Swabhiman Manch (CSM) from Kanker with an income of Rs.13.14 Lakhs for the financial year 2011-12. (Most of the candidates have claimed to be exempted from paying Income Tax)

Other Background details (Education, Gender, Age):

- <u>Candidates' Education:</u> A total of **54 (38%)** candidates out of **143** analyzed are graduates or have higher degrees. **88 (62%)** candidates have educational qualification of **12**th pass and below.
- **Candidates' Age:** A total of **104 (73%)** candidates out of the 143 analyzed, have declared their age to be between 25 and 50 years. **36(25%)** candidates declared their age to be between 51 and 70 years.
- <u>Women Candidates:</u> Out of 143 candidates analyzed, only **11 (8%) women** are contesting in the first phase of Chhattisgarh 2013 Assembly Elections. Among the major political parties, INC has fielded 3 women candidates while 2 women are contesting under BJP ticket.





Analysis based on declared criminal cases

Out of the 143 candidates analysed, 15 candidates have declared criminal cases against them. Out of these 15 candidates, 6 have declared serious criminal cases.

Party-wise break up of candidates with declared criminal cases

A total of 15 candidates contesting in the first phase of 2013 Chhattisgarh Assembly Elections have declared criminal cases against them. 3 out of 18 (17%) candidates fielded by BJP have declared criminal cases against them while 2 out of 18 (11%) candidates from INC, 2 out of 18 (11%) candidates from BSP and 1 out of 5 (20%) from SP have declared cases against themselves. The following table provides the party wise details of candidates with self-declared criminal cases:


