Analysis of Criminal, Financial, Education, Gender and other details of Candidates contesting in the Arunachal Pradesh 2014 Assembly Elections

Summary and Highlights

Arunachal Pradesh Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **152 candidates out of 155** who are contesting in **60 constituencies** during the Arunachal Pradesh State Assembly Elections.

Affidavits of following 3 candidates are not analysed as their affidavits available in the website of CEO, Arunachal Pradesh are incomplete or badly scanned:

Criminal Background

- **Candidates with Criminal Cases:** Out of the 152 candidates analysed, **11 candidates (7%)** have declared criminal cases against them. In 2009 assembly elections, 4 candidates with pending criminal cases contested the elections.
- **Candidates with Serious Criminal Cases:** Out of the 11 candidates who have declared criminal cases, **9 have declared serious criminal cases**. These include **dacoity, theft and crimes against women**.
- **Party wise Candidates with Criminal Cases:** **7** out of **58 (12%)** candidates fielded from **INC** have declared criminal cases against them while **1 out of 42(2%)** candidates from **BJP**, **2 out of 16 (13%)** candidates from **PPA** and **one** candidate from **AAP** has declared criminal cases in their affidavits.
- **Candidate with Crimes against Women:** Jabring Venia of PPA from East Kameng Constituency has declared a case related to **assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)**
- **Candidates with cases related to Prevention of Corruption Act:** 6 candidates have declared cases related to Prevention of Corruption Act.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepati Candidates:** Out of the **152** candidates analysed, **91 (60%)** are crorepaties. In 2009 **61(41%)** crorepati candidates contested the elections
- **Party-wise Crorepati Candidates:** **51 (88%)** out of 58 candidates from **INC**, **24 (57%)** out of 42 candidates from **BJP**, **5 (50%)** out of 10 candidates from **NCP** and **4 (25%)** out of 16 candidates from **PPA** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the 2014 Arunachal Pradesh Assembly Elections is **Rs. 6.30 crores**. In 2009 Assembly elections the average assets was **Rs. 3.51** crores.

- **Party-wise Average Assets:** The average assets per candidate for 58 INC candidates is **Rs. 11.89 crores**, for 42 BJP candidates is **Rs.2.52 crores**, for 16 PPA candidates is **Rs.1.50 crores** and for 10 NCP candidates it is **Rs. 2.02 crores**. For 14 independent candidates analysed, the average assets per candidates is **Rs. 8.05 crores**.
- **High Asset Candidates:** The top three candidates with highest declared assets are **Takam Pario of INC** from Palin Constituency with declared assets worth **Rs.187.56 crores** followed by **Pema Khandu of INC** from Mukto Constituency with assets worth **Rs.129.57 crores** and **Tsering Tashi** an **Independent** candidate from Tawang Constituency with assets worth **Rs. 96.43 Crores**.
- **Low Asset Candidates:** A total of **15** candidates have declared **assets worth less than Rs. 10 lakhs**.
- **Candidates with lowest assets:** **Bida Taku** of **PPA** from Lekang constituency has declared the lowest value of assets worth **Rs. 3,540**, followed by **Debia Tara** of **BJP** from Yachuli constituency with total assets worth **Rs. 5,000** and **Holai Wangsa** of **BJP** from **Pongchau-Wakka** constituency with total assets worth **Rs. 50,000**.
- **Liabilities:** A total of 29 candidates have declared liabilities out of which **12** candidates have declared liabilities of **Rs.10 Lakhs** and above. **7** candidates have declared liabilities of **Rs 50 lakhs** or more.
- **High Liability Candidates:** The top three candidates with highest declared liabilities are **Nikh Kamin** of **PPA** from Bordumsa constituency has declared the highest liabilities worth **Rs.3 crores** followed by **Lokam Tassar** of **INC** from Koloriang constituency with liabilities worth **Rs.2.30 crores** and **Nabam Tuki** of **INC** from Sagalee constituency with **Rs.2.23 crores** worth of liabilities.
- **Undeclared PAN:** 27 out of 152 (18%) candidates contesting in the 2014 Arunachal Pradesh Assembly Elections have not declared their PAN details.
- **Candidates who have not declared ITR*:** 150 candidates have not declared their Income Tax Returns in their affidavits.
**Some candidates may be exempted from filing Income Tax Returns*
- **High Income Candidates:** **Likha Saaya** of **INC** from Yachuli constituency has declared the highest income of **Rs.25.95 lakhs** in last Income Tax Returns (ITR) filed for the year 2012-13.

Other Background details (Education, Gender, Age)

- **Candidates' Education:** A total of **87 (57%)** candidates out of 152 analyzed are graduates or have higher degrees. **59 (39%)** candidates have educational qualification of 12th pass or below. One candidate has declared that he is illiterate.
- **Candidates' Age:** A total of **106 (70%)** candidates have declared their age to be between 25 and 50 years. **44(30%)** candidates declared their age to be between 51 and 70 years. One candidate has declared his age to be more than 70 years.
- **Women Candidates:** Only **4 (3%)** women candidates are contesting Arunachal Pradesh 2014 assembly elections out of 152 candidates. In 2009 Assembly elections, there were 9 women candidates.

Analysis based on declared criminal cases

Out of the 152 candidates analysed, **11 candidates (7%)** have declared criminal cases against them. Out of the 11 candidates who have declared criminal cases, **9 have declared serious criminal cases**

Analysis of Asset Comparison of Re-Contesting MLAs Contesting in the Arunachal Pradesh 2014 Assembly Elections

Summary of asset comparison of re-contesting MLAs

- **MLAs Contesting Again:** Arunachal Pradesh Election Watch and Association for Democratic Reforms (ADR) have analyzed the affidavits of 43 outgoing MLAs who are contesting again in the 2014 Assembly Elections.
- **Average Assets in 2009 Elections:** The average asset of these 43 re-contesting MLAs fielded by various parties in 2009 was **Rs. 2.37 crores.**
- **Average Assets in 2014 Elections:** The average asset of these 43 re-contesting MLAs in 2014 is **Rs. 6.54 crores.**
- **Average Asset growth in 5 years (2009-2014):** The average asset growth for these 43 re-contesting MLAs is **Rs. 4.17 crores.**
- **Percentage growth in 5 years (2009-2014):** Average percentage growth in assets for these 43 re-contesting MLAs is **176%.**

Average asset increase of re-contesting MLAs: Party-Wise

The table below provides the party-wise categorization of average asset increase of re-contesting MLAs. Financial details of 43 re-contesting MLAs fielded by various political parties have been taken from the recently filed affidavits by these MLAs and the values of these financial assets have been compared to the corresponding values of the assets that the MLAs showed in their affidavits in 2009.
