Lok Sabha elections 2009

Lok Sabha 2009 elections in Dadra & Nagar Haveli were held on April 30, 2009 for one parliamentary constituency. This report includes analysis of voting trend, criminalization and money power in these elections.

Political Parties and Candidates

In Lok Sabha 2004, 8 parties contested. This went down to 3 parties in Lok Sabha 2009 elections. In Lok Sabha 2004 elections 10 candidates contested. This went down to 5 candidates in Lok Sabha 2009 elections.

Executive summary

- Affidavits of all 5 candidates contesting the Lok Sabha 2009 elections were analyzed by the Dadra & Nagar Haveli Election Watch.
- 3 of these 5 candidates had pending criminal cases.
- Average asset for a candidate from Dadra & Nagar Haveli was 3.7 crores.
- The constituency was won by Patel Natubhai Gomanbhai of BJP.
- The winner, Patel Natubhai Gomanbhai from BJP had 3 pending criminal cases and assets in excess of 8 crores.
- There were no female candidates from Dadra & Nagar Haveli.

Voting and winning trend

The % of votes polled by major parties

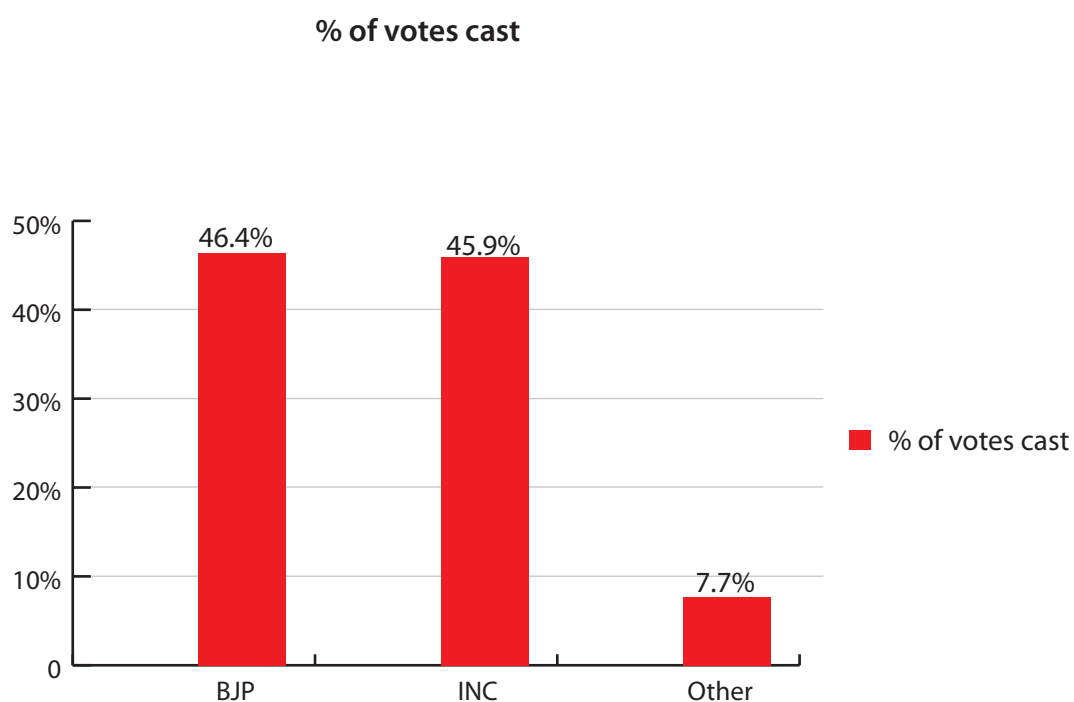
BJP managed to get 46.4% of the votes cast. This was 33.2% of the electorate. The total votes cast by INC were less than one thousand of those polled by BJP. The total electorate in Dadra & Nagar Haveli was 1,54,212 and the total votes cast were 1,10,363.
