




## **Summary and Highlights**

**Association for Democratic Reforms (ADR)** and **Delhi Election Watch** have analysed the self-sworn affidavits of **7** Ministers including Chief Minister, sworn in on 20 February 2025 for the **Delhi State Assembly.** 

The information is based on the affidavits submitted by the ministers prior to 2025 Delhi Assembly Elections.

## **Criminal Background**

- Ministers with Criminal Cases: Out of the 7 ministers analysed, 5 (71%) ministers have declared criminal cases against themselves.
- Ministers with Serious Criminal Cases: 1(14%) minister has declared serious criminal case against himself.

## **Financial Background**

- Billionaire Ministers: Out of the 7 ministers analysed, 2(29%) are Billionaire.
- Average Assets: The average assets of 7 ministers analysed is Rs 56.03 crores.
- Minister with Highest Assets: The minister with the highest declared total assets is Manjinder Singh Sirsa from Rajouri Garden constituency with assets worth Rs. 248.85 crores.
- Minister with Lowest Assets: The minister with the lowest declared total assets is Kapil Mishra from Karawal Nagar constituency with assets worth Rs. 1.06 crores.
- Liabilities: All 7 ministers have declared liabilities out of which the minister with the highest liabilities is Parvesh Sahib Singh of New Delhi constituency with Rs. 74.36 crores of liabilities.

### Other Background details (Education, Gender, Age)

- Ministers' Education: 1 Minister has declared his educational qualification 12<sup>th</sup> standard while 6 Ministers have declared having an educational qualification of graduate and above.
- Ministers' Age: 5 (71%) ministers have declared their age to be between 41 and 50 years while 2 (29%) ministers have declared their age to be between 51 and 60 years.
- Women Ministers: Out of 7 ministers, 1 is a woman.
