## Summary and Highlights

The Goa Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **all 16** candidates, who are contesting in the **Mandrem, Siroda and Mapusa constituencies in the bye- elections for Goa assembly.**

### Criminal Background

- **Candidates with Criminal Cases:** Out of **12** candidates analyzed, **3** candidates have declared criminal cases against himself. Among these 3 candidates, 2 candidates have declared serious criminal cases against themselves. The details of these 3 candidates are given below :

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
