गुजरात विधानसभा 2012 में नवनिर्वाचित विधायकों का आपराधिक, वित्तीय और अन्य विवरणों के आधार पर विश्लेषण

सारांश—

- ☞ गुजरात इलेक्शन वॉच ने 182 विधायकों का विश्लेषण किया है जो गुजरात विधानसभा 2012 में नवनिर्वाचित हुए हैं।
- ☞ 182 में से 57 यानी 31 प्रतिशत विधायकों ने अपने विरुद्ध आपराधिक मामले घोषित किये हैं। गुजरात विधानसभा 2007 में 26 प्रतिशत विधायकों ने अपने विरुद्ध आपराधिक मामले घोषित किये थे।
- ☞ आपराधिक मामले घोषित करने वाले 57 में से 24 विधायकों ने अपने विरुद्ध गंभीर आपराधिक मामले घोषित किये हैं।
- ☞ आपराधिक मामले घोषित करने वाले 57 में से 35 विधायक ऐसे हैं जिन पर विभिन्न तरह के आपराधिक मामलों पर आरोप तय किये गये हैं।
- ☞ गंभीर आपराधिक मामले (हत्या, अपहरण और चोरी) घोषित करने वालों की श्रेणी में प्रथम स्थान में निर्वाचन क्षेत्र झागडिया (एस.टी.) से जे.डी.यू विधायक वसावा छोटूभाई अमरसिंह (9 मामले डकैती / 7 मामले चोरी / 3 मामले हत्या) हैं। इसके बाद निर्वाचन क्षेत्र नारनपूरा से भाजपा विधायक अमित अनिल चन्द्र शाह (2 मामले हत्या / 2 मामले अपहरण), निर्वाचन क्षेत्र वाव से भाजपा विधायक चौधरी शंकरभाई लगधीरभाई (3 मामले हत्या का प्रयास), निर्वाचन क्षेत्र शेहरा से भाजपा विधायक जेठाभाई जी आहिर (1 मामला बलात्कार / 1 मामला अपहरण) और निर्वाचन क्षेत्र तलाला से कांग्रेस उम्मीदवार बारड जाशूभाई धनाभाई (1 मामला हत्या) हैं।
- ☞ 182 में से 134 यानी 74 प्रतिशत विधायक करोड़पति हैं। 2007 में 57 यानी 31 प्रतिशत विधायक करोड़पति थे।
- ☞ अधिकतम सम्पत्ति रखने वाले विधायक हैं— (1) सिधपूर निर्वाचन क्षेत्र से कांग्रेस के उम्मीदवार बलवंतसिंह चंदनसिंह राजपूत (रु० 268 करोड़)। (2) राजकोट ईस्ट निर्वाचन क्षेत्र से कांग्रेस के उम्मीदवार राजगुरु इन्द्रानिल संजयभाई (रु० 122 करोड़) और (3) निर्वाचन क्षेत्र मानवदार से कांग्रेस के उम्मीदवार छावड़ा जवाहरभाई पिठालाजीभाई (रु० 82.90 करोड़)।
- ☞ 3 विधायकों ने अपनी सम्पत्ति 10 लाख से कम घोषित की है।

- ☞ निर्वाचन क्षेत्र फतेहपुरा “एसटी” से भाजपा विधायक रमेशभाई भूराभाई कटारा ने सबसे कम ₹0 6 लाख की सम्पत्ति घोषित की है। इसके बाद निर्वाचन क्षेत्र वडौदरा सिटी “एससी” से भाजपा विधायक वकील मनीषा राजीवभाई ने ₹0 7.12 लाख और निर्वाचन क्षेत्र पलिटाना से कांग्रेस विधायक परवीनभाई जिनाभाई राठोड ने ₹0 7.50 लाख की संपत्ति घोषित की है।
- ☞ 182 में से कुल 44 यानि 24 प्रतिशत विधायकों ने 40 लाख और इससे अधिक की देनदारियों की घोषणा की है।
- ☞ निर्वाचन क्षेत्र सिधपुर से कांग्रेस के उम्मीदवार बलवंतसिंह चंदनसिंह राजपूत ने सबसे ज्यादा ₹0 52.33 करोड़ की देनदारी घोषित की है इसके बाद निर्वाचन क्षेत्र राजकोट ईस्ट से कांग्रेस के उम्मीदवार राजगुरु इन्द्रेल संजयभाई ने ₹0 27.14 करोड़ और निर्वाचन क्षेत्र वडगाम “एससी” से कांग्रेस विधायक मनीभाई जे वघेला ने ₹0 13.98 करोड़ की देनदारी घोषित की है।
- ☞ मुख्य दलों में विधायकों की प्रति औसत सम्पत्ति इस प्रकार है— कांग्रेस की 12.36 करोड़, भाजपा की लगभग 5.82 करोड़, एन.सी.पी की 15.61 करोड़, जे.डी.यू की 2.70 करोड़, और जी.पी.पी की 1.52 करोड़ है।
- ☞ अधिकतम संपत्ति रखने वाले 182 में से 31 यानि 17 प्रतिशत विधायकों ने आयकर रिटर्न नहीं भरे होने की घोषणा की है उनमें — जडेजा कंधलभाई सरमनभाई (निर्वाचन क्षेत्र कुटियाना/एन.सी.पी) की संपत्ति सबसे ज्यादा ₹0 28.29 करोड़ है इसके बाद विटठलभाई हंसराजभाई रडाडिया (निर्वाचन क्षेत्र धोराजी/कांग्रेस) की संपत्ति ₹0 5.62 करोड़ है और दिलीप कुमार विराजीभाई ठाकूर (निर्वाचन क्षेत्र चनासामा/भाजपा) की संपत्ति ₹0 4.73 करोड़ है।
- ☞ अधिकतम संपत्ति रखने वाले विधायक जिन्होंने आयकर रिटर्न भरे होने की घोषणा की है उनमें — सोलंकी हीराभाई ओधवजीभाई (निर्वाचन क्षेत्र रजूला/भाजपा) ने अपने आयकर रिटर्न में सबसे ज्यादा ₹0 3.41 करोड़ वार्षिक आय घोषित की है, इसके बाद पबुभा विरम्भा मानेक (निर्वाचन क्षेत्र द्वारका/भाजपा) ने ₹0 3.25 करोड़ और रडाडिया जयेशभाई विटठलभाई (निर्वाचन क्षेत्र जेतपूर/कांग्रेस) ने ₹0 2.53 करोड़ की वार्षिक आय घोषित की है।
- ☞ गुजरात विधानसभा चुनाव 2012 में 182 में से 5 विधायकों ने अपना पैर विवरण घोषित नहीं किया है। 2007 में 54 यानि 30 प्रतिशत विधायकों ने अपना पैर विवरण घोषित नहीं किया था।
- ☞ कुल 82 यानि 45 प्रतिशत (182 विश्लेषित विधायकों में से) स्नातक अथवा इससे अधिक शिक्षित हैं।
- ☞ 182 में से 16 यानि 9 प्रतिशत विधायक महिला हैं। 2007 में भी 16 यानि 9 प्रतिशत महिला विधायक थी।
- ☞ विश्लेषित 182 में से 43 विधायकों की आयु 61 वर्ष से अधिक है।

राजनीतिक दलों में वृद्धि

गुजरात विधानसभा चुनाव 2012 में 52 राजनीतिक दलों का प्रतिनिधित्व करने वाले कुल 1666 उम्मीदवारों ने चुनाव लड़ा। 2007 में 39 दलों का प्रतिनिधित्व करने वाले कुल 1268 उम्मीदवार थे। राजनीतिक दलों की संख्या में 33 प्रतिशत और चुनाव लड़ने वाले उम्मीदवारों की संख्या में 31 प्रतिशत की वृद्धि हुई। विधानसभा चुनाव 2012 में 52 में से केवल 5 दल (भाजपा, कांग्रेस, एनसीपी, जीपीपी और जेडीयू) ही चुनावों में विजयी हो पाये

विधायकों द्वारा घोषित आपराधिक मामलों का विश्लेषण

गुजरात इलेक्शन वॉच द्वारा विधानसभा चुनाव 2012 में 182 विधायकों का विश्लेषण किया गया। इन 182 में से 57 यानि 31 प्रतिशत विधायकों ने अपने विरुद्ध आपराधिक मामलों की घोषणा की हैं। आपराधिक मामलों वाले 57 में से 24 यानि 13 प्रतिशत ऐसे विधायक हैं जिनके खिलाफ गंभीर आपराधिक मामले दर्ज हैं।

घोषित आपराधिक मामलों वाले विधायकों का दल आधारित विवरण

57 विधायकों ने अपने विरुद्ध आपराधिक मामलों की पुष्टि की है। इनमें कांग्रेस के 61 में से 20 (33 प्रतिशत), भाजपा के 115 में से 32 (28 प्रतिशत), एन.सी.पी के 2 में से 2 (100 प्रतिशत) और जे.डी.यू के 1 में से 1 (100 प्रतिशत) विधायकों ने अपने विरुद्ध आपराधिक मामलों की पुष्टि की है। नीचे की तालिका में विधायकों का दल आधारित विवरण दिया गया है—
