The information is based on the affidavits submitted by the candidates prior to 2022 Gujarat Assembly Elections.

# **Criminal Background**

- Ministers with Criminal Cases: 4(24%) ministers have declared criminal cases against themselves.
- Ministers with Serious Criminal Cases: 1(6%) minister has declared serious criminal case against himself.

# **Financial Background**

- Crorepati Ministers: Out of the 17 ministers analysed, 16 (94%) are crorepatis.
- Average Assets: The average assets of 17 ministers analysed is Rs 32.70 crores.
- Minister with Highest Assets: The minister with the highest declared total assets is Balvantsinh chandansinh Rajput from Sidhpur constituency with assets worth Rs. 372.65 crores.

#### Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- Offences that are assault, murder, kidnap, rape related
- Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 3. Crimes against women.
- Minister with Lowest Assets: The minister with the lowest declared total assets is Khabad Bachubhai Maganbhai from Devgadhbaria constituency with assets worth Rs. 92.85 lakhs.
- <u>Liabilities:</u> A total of **14** ministers have declared liabilities out of which the minister with the highest liabilities is **Balvantsinh chandansinh Rajput** of **Sidhpur** constituency with **Rs. 12.59 crores** of liabilities.





# Other Background details (Education, Gender, Age)

- <u>Ministers' Education</u>: 6(35%) ministers have declared their educational qualification to be between 8<sup>th</sup> and 12<sup>th</sup> standard while 8(47%) ministers have declared having an educational qualification of graduate or above. 3(18%) ministers are Diploma holders.
- Ministers' Age: 3(18%) ministers have declared their age to be between 31 and 50 years while 14 (82%) ministers have declared their age to be between 51 and 80 years.
- Women Ministers: Out of 17 ministers, 1(6%) is a woman.
