Summary and Highlights

Association for Democratic Reforms (ADR) and **Haryana Election Watch** have analyzed the criminal, financial and other background details of **87** out of **90** sitting MLAs. In the current assembly 3 seats are vacant.

This analysis is based on the affidavits submitted by the candidates prior to the 2019 Assembly elections and bye elections conducted thereafter.

The following 3 constituencies are vacant:

CRIMINAL BACKGROUND

- **MLAs with criminal cases:** Out of **87** sitting MLAs analysed, **12 (14%)** Sitting MLAs have declared criminal cases against themselves.
- **MLAs with serious criminal cases:** **6 (7%)** Sitting MLAs have declared serious criminal cases.
- **Party wise sitting MLAs with criminal cases:** **3 (7%)** out of **41** MLAs from **BJP**, **4 (14%)** out of **29** MLAs from **INC**, **1 (10%)** out of **10** MLAs from **Jannayak Janta Party**, **1 (100%)** MLA from **INLD**, **1 (100%)** MLA from **Haryana Lokhit Party** and **2 (40%)** out of **5** Independent MLAs have declared criminal cases against themselves in their affidavits.
- **Party wise sitting MLAs with serious criminal cases:** **4 (14%)** out of **29** MLAs from **INC**, **1 (100%)** MLA from **Haryana Lokhit Party** and **1 (20%)** out of **5** Independent MLAs have declared serious criminal cases against themselves in their affidavits.

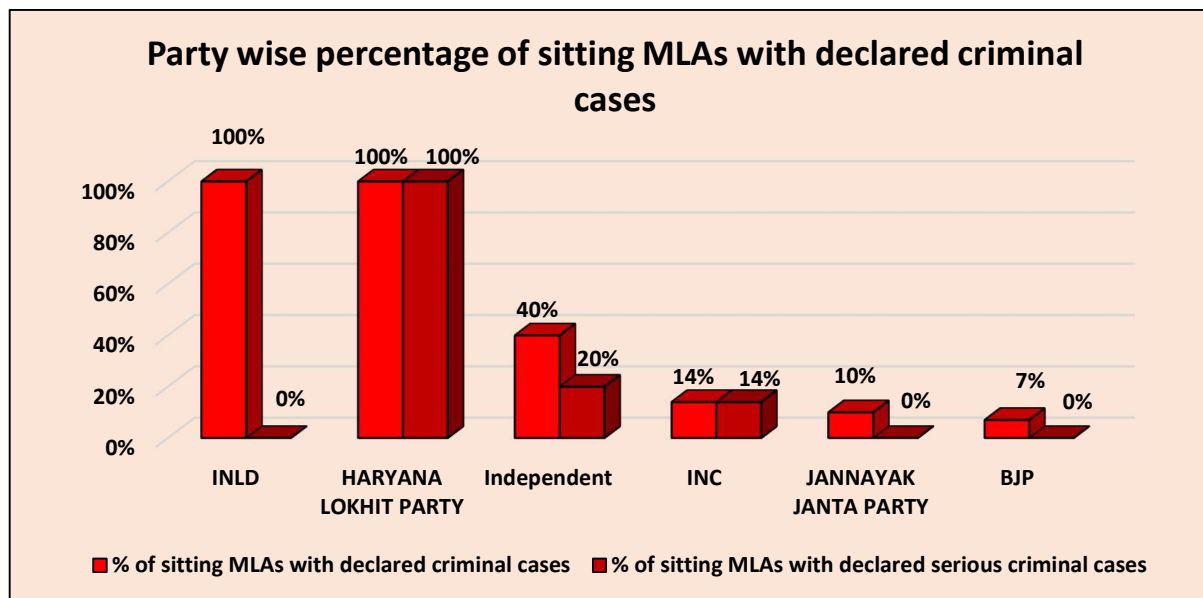
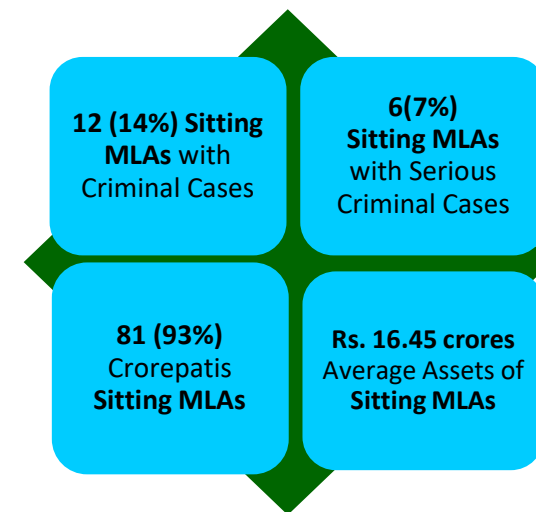


Figure: Party wise percentage of sitting MLAs with declared criminal cases

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

FINANCIAL BACKGROUND

- **Crorepati Sitting MLAs:** Out of 87 sitting MLAs analysed , **81 (93%)** are crorepatis.
- **Party wise crorepati Sitting MLAs:** **38 (93%)** out of 41 MLAs from **BJP**, **27 (93%)** out of 29 MLAs from **INC**, **10 (100%)** MLAs from **Jannayak Janta Party**, **1 (100%)** MLA from **INLD**, **1 (100%)** MLA from **Haryana Lokhit Party** and **4 (80%)** out of 5 **Independent** MLAs have declared assets valued more than **Rs 1 crore**.

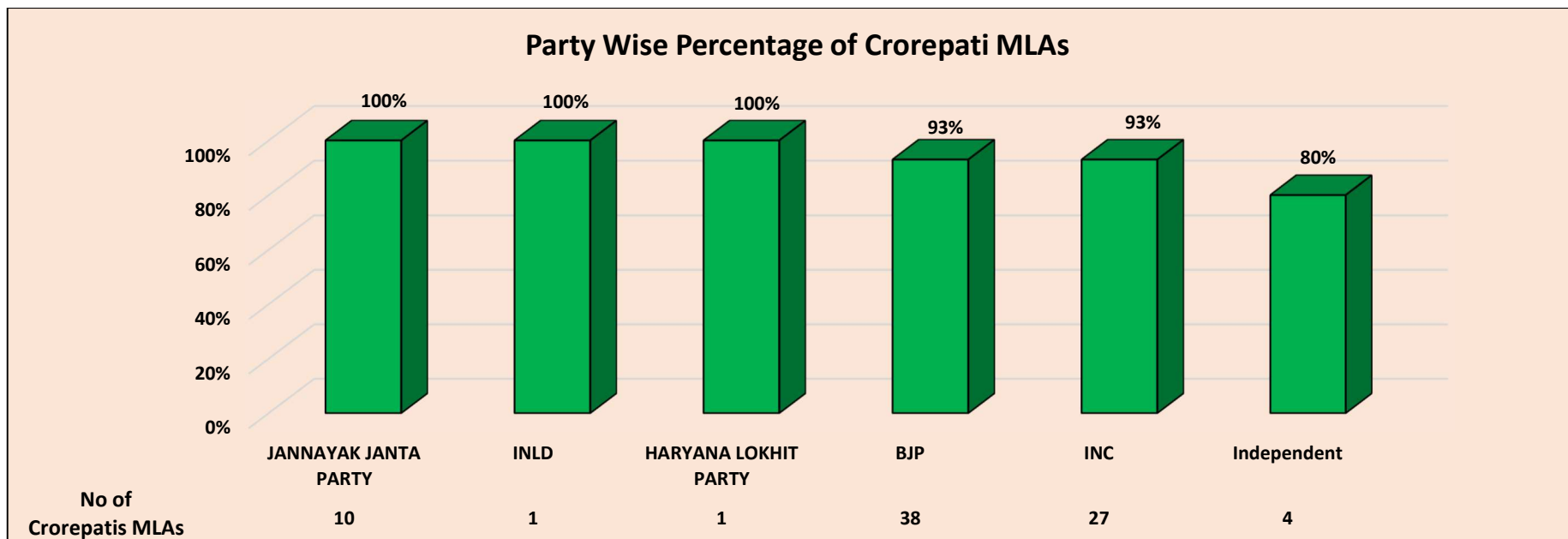


Figure: Party Wise Percentage of Crorepati MLAs

- **Average assets:** The average of assets per sitting MLA is **Rs.16.45 crore**.
- **Party wise average assets:** The average assets per MLA for **41 BJP** MLAs analysed is **Rs.12.11 crores**, **29 INC** MLAs analysed is **Rs.12.77 crores**, **10 Jannayak Janta Party** MLAs analysed is **Rs.25.26 crores**, **1 Haryana Lokhit Party** MLA analysed is **Rs.95.43 crores**, **1 INLD** MLA analysed is **Rs.65.41 crores** and **5 Independent** MLAs have average assets of **Rs.30.10 crores**.

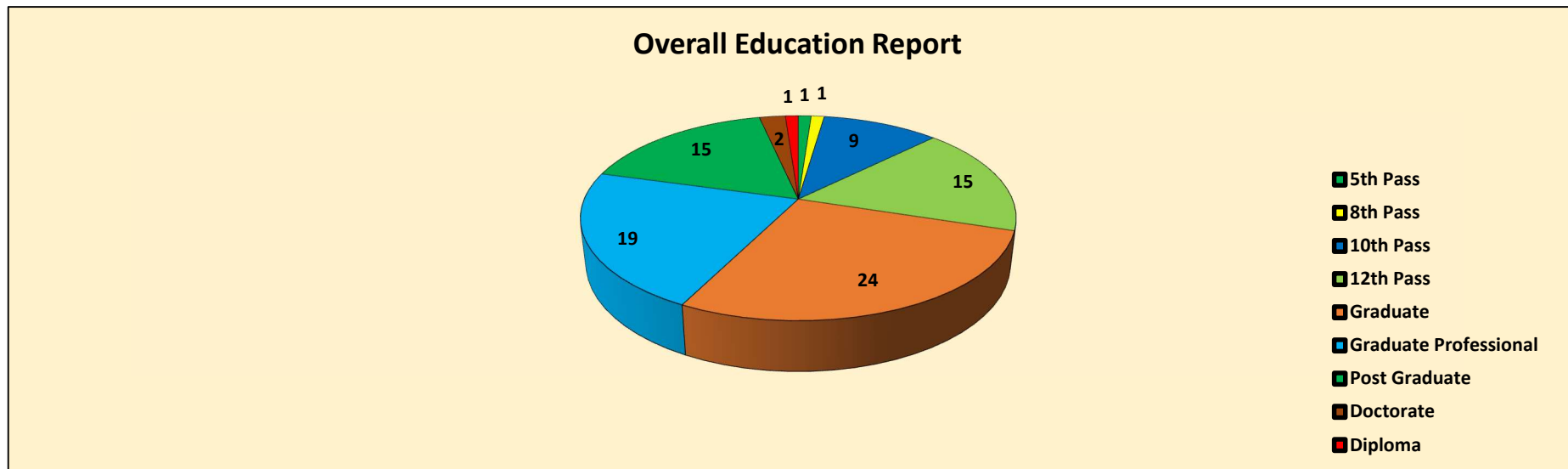


Figure: Analysis of MLAs on the basis of education

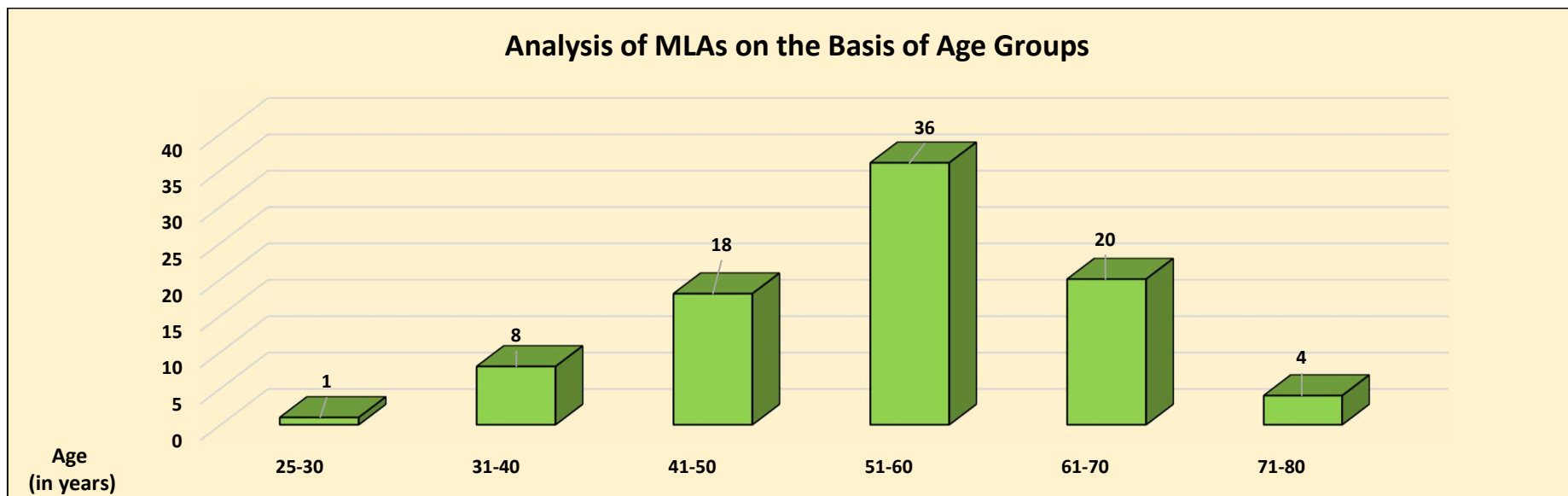


Figure: Analysis of MLAs on the basis of age groups

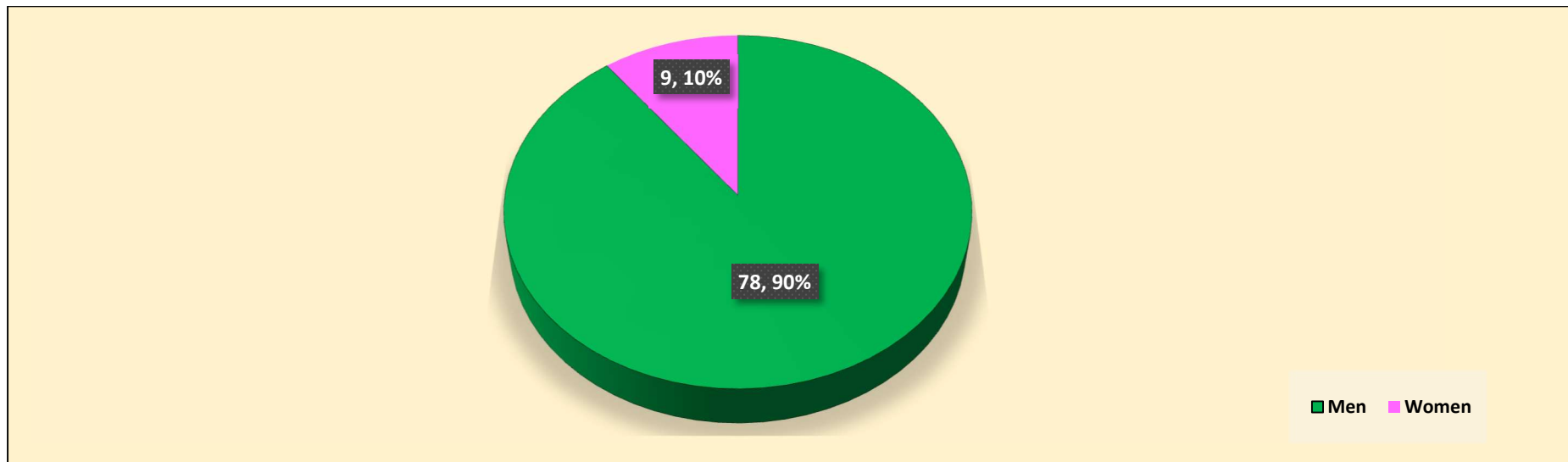

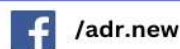
