## ***Analysis of the MLAs from Haryana***

The following report consists of the financial and criminal details of the Members of legislative Assemblies (MLAs) from Haryana and an overall comparative analysis. As mentioned before, the state has 90 seats of Legislative Assembly and it is represented by 10 seats in Lok Sabha and 5 in Rajya Sabha. The following table gives a summary of the details of all the MLAs:

- Affidavits available for MLAs - **90**
- MLAs with criminal charges - **28 (31.11 %)**
- MLAs with serious criminal charges - **13 (14.44 %)**
- Total criminal cases against MLAs - **66**
- Total serious IPC sections against MLAs - **18**
- Total crorepati MLAs - **47**
