HARYANA 2009 ASSEMBLY ELECTIONS

Haryana 2009 Assembly Elections

Haryana 2009 Assembly Elections were held on 13 October 2009 for 90 constituencies. This chapter includes the analysis of voting trends, criminalization of politics, use of money power, gender disparities etc in these elections. Information provided by the Election Commission of India and details from the affidavits filed by the candidates have been used for the analysis.

Growth of political parties

In 2005, 27 parties contested Haryana Assembly Elections, which rose to 49 in the 2009 Assembly Elections. This reflects a rise of 81% in the number of parties from 2005 to 2009 Haryana Assembly Elections.

Growth in number of candidates

A total of 1222 candidates from 49 parties contested Haryana Assembly polls in 2009 as compared to 983 candidates who represented 27 parties in 2005. This shows a growth of 24% in the number of candidates who contested the Assembly Election in 2009.

Out of 1222 candidates in 2009, 1153 were men and 69 (i.e.6%) were women. In 2005, out of 983 candidates, 923 were men and 60 (6%) women. Hence, the percentage of women and men candidates in 2005 and 2009 Haryana Assembly Elections have remained the same.

Executive summary of Candidates and MLAs

Summary of Candidates

- Haryana Election Watch (HEW) analyzed affidavits of 855 candidates out of 1222 who contested 2009 Assembly Elections.
- Out of these 855 candidates analyzed, 91 candidates i.e 11% declared pending criminal cases against them. HJC (BL) had 14 out of 87 (16%) candidates with pending criminal cases, INC had 14 out of 90 (16%), INLD had 12 out of 88 (14%), BSP had 12 out of 86 (14%) candidates with pending criminal cases.
- Out of these 91 candidates with pending criminal cases, 33 candidates had serious pending criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc against them. These include 6 from INC, 3 each from HJC (BL) and BJP, 7 independent candidates and 7 candidates from BSP.





- There were 354 candidates analyzed from 4 major parties (BJP, INC, INLD & BSP) 90 from BJP, 90 from INC, 88 from INLD and 86 from BSP. Out of these 354 candidates, 46 (13%) candidates had pending criminal cases against them. Comparing this with Haryana 2005 Assembly Elections, there were 154 candidates of these major parties (INC, INLD, BSP & BJP) out of which 29 (19%) candidates had pending criminal cases against them.
- There were 45 IPC cases of heinous nature on these candidates which included murder, attempt to murder, kidnapping, extortion, etc.
- A total of 333 candidates out of 855 candidates analyzed i.e. 39% were crorepatis.
- A total of 4 out of 855 candidates analyzed declared zero assets.
- A total of 202 candidates out of 855 candidates analyzed declared liabilities above 5 lakhs.
- Among the major parties, the average asset per candidate for INC was Rs. 5 crores, for INLD was Rs 3 crores, for HJC (BL) was Rs. 3 crores and for BJP & BSP was Rs. 2 crores each.
- A total of 54% of candidates (458 of 855 analyzed) had not furnished their PAN card details.
- Women candidates were just 69 (6%) as compared to 1153 men (94%).
- Around 39% candidates (334 of 855 candidates analyzed) were graduates & above.

Summary for MLAs

- HEW has analyzed the affidavits of all the 90 MLAs from Harayan 2009 Assembly Elections.
- Out of these 90 MLAs, 15 have pending criminal cases against them. Comparing this to Haryana 2005, 28 MLAs had pending criminal cases against them.
- Out of the 15 MLAs with pending criminal cases, there are pending serious criminal cases against 2 MLAs (2%). Contrasting this with 2005 Haryana Assembly, 13 MLAs (14%) had serious pending criminal cases.
- The number of crorepati MLAs has increased from 47 in Haryana 2005 Assembly Elections to 65 in Haryana 2009 Assembly Elections.
- Among major parties, the average asset per MLA for INC was Rs. 7.99 crores, for INLD Rs. 3.59 crores, for BSP Rs. 6.60 crores, and for HJC (BL) Rs. 4 crores.
- Average asset for a MLA from Haryana was Rs 655 lakhs.
- Out of these 90 MLAs analyzed, 19 had not declared their PAN details.
- Out of 69 women candidates, only 9 won. Hence, only 10% of MLAs from Haryana are women.





Voting and winning trend

There are 90 constituencies in Haryana. The % of votes polled for major parties clearly show that none of them got anywhere close to the 50% mark. INC managed approx 42 % of the votes cast. INLD managed just 16 % and BJP managed just 12% of the votes cast.




Figure: Percentage of total votes cast: party-wise




Figure: Candidates vs MLAs- party wise





Analysis based on pending criminal cases

Analysis based on pending criminal cases- candidates

Affidavits of 855 candidates were analyzed by Haryana Election Watch (HEW) for Assam 2009 Assembly Elections. Out of these 855 candidates analyzed, 91 candidates declared pending criminal cases against them. Out of these 91 candidates with pending criminal cases, 33 candidates had pending serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc.

Party-wise break up of candidates with pending criminal cases

As mentioned above, 91 candidates had criminal cases pending against them. The table below gives the party wise breakup of candidates with pending criminal cases:




Figure: Comparison of pending criminal cases and serious pending criminal cases for candidates of main parties





Two parties with highest number of candidates with pending criminal cases were HJC (BL) and INC, with 14 candidates each. They were followed by INLD and BSP, each with 12 and BJP with 8 candidates having pending criminal cases. The highest number of candidates with pending serious criminal cases were from BSP with 7, INC with 6 and BJP and HJC (BL) with 3 candidates each.

Serious crime distribution –serious IPC counts of major parties candidates

The table below shows the breakup of serious IPC sections for candidates of major parties. Serious crimes have been distributed in categories of violent crimes, theft related crimes, finance related crimes and other serious crimes.

Party-wise comparison of pending criminal cases of candidates in Haryana Assembly 2005 vs 2009

A comparison between candidates with pending criminal cases in Haryana Assembly Elections held in 2005 and 2009 respectively shows that for major parties like INC & BJP the percentage of candidates with pending criminal cases has decreased while for INLD it has increased in Assembly 2009 Elections. Details are given in the table below.

Analysis based on pending criminal cases – MLAs

Out of 90 MLAs from Haryana in 2009, 15 MLAs have pending criminal cases against them. Out of these 15 MLAs, there are pending serious criminal cases against 2 MLAs (2% of total MLAs). Contrasting this with 2005 Assembly Elections, out of 28 MLAs with pending criminal cases, 13 MLAs (14 % of total MLAs) had serious pending criminal cases.

Party wise break up of MLAs with pending criminal cases

The table below gives the information about the MLAs with respect to pending criminal cases against them. A total of 15 MLAs in 2009 Haryana Assembly have pending criminal cases against them, out of which 2 (each from INLD and IND) have serious pending criminal cases against them-




Figure: % MLAs with pending criminal cases

Out of 855 affidavits analysed for candidates in Haryana 2009 Assembly Elections, 332 were crorepatis. 80% of candidates of INC were crorepatis and 64 % of INLD candidates were crorepatis.




Figure: Crorepati candidates from major parties




Figure: Average assets of candidates- Party-wise

The table given below presents a comparison based on assets of MLAs. From Assembly 2005 to Assembly 2009, the number of crorepati MLAs has increased by 38%. Average asset of a MLA has increased by 230% when compared to Assembly 2005.




Figure: Comparison Assembly 2005 and 2009 based on assets

Chances of winning based on assets

As can be seen from the table, the higher the assets the more are the chances of winning of a candidate. A total of 33% of the candidates who declared assets of Rs 5 crore and above won. On the other hand, 2% of candidates with assets less than Rs 10 lakhs won. The election results seem to be highly influenced by the money power of the candidates.




Figure: Number of crorepati MLAs out of total MLAs- party- wise.




Figure: Comparison average assets for candidates and MLAs in Assembly Elections, 2009




Figure. Total winners based on asset positio




Table: Party wise female representation analysis

Analysis of the first list of council of ministers

Pending criminal cases details

Haryana Election Watch has analysed affidavits of 10 ministers from the first list of council of ministers. A total of 3 out of 10 ministers from the first list of Council of Ministers have pending criminal cases. These ministers are:

- 1. Randeep Singh Surjewala (INC)
- 2. Gopal Kanda (IND)
- 3. Sukhbeer (IND)

Randeep Singh Surjewala (INC) has declared that there are pending criminal cases of "rioting (armed with deadly weapon), "voluntarily causing hurt to deter public servant from his duty" and "assault or criminal force to deter public servant from discharge of his duty pending against him".

Gopal Kanda has declared that there are pending criminal cases such as "rioting (armed with deadly weapon)", "voluntarily causing hurt to deter public servant from his duty" and "assault or criminal force to deter public servant from discharge of his duty".

Sukhbeer has declared that there are serious pending criminal cases of "injuring or defiling place of worship with intent to insult the religion of any class", "voluntarily causing hurt by dangerous weapons or means" and "theft" pending against him.

Financial details

All the analysed ministers in the Council of Ministers from Haryana are crorepatis. Out of these 6 are from INC and 4 contested elections as independents. Maximum assets have been declared by Gopal Kanda (IND) followed by Sukhbeer (IND) and Mahender Pratap (INC). The details of all crorepati ministers are given below:


