

विश्लेषण के आधार पर उम्मीदवारों द्वारा घोषित आपराधिक विवरण (हिमाचल प्रदेश विधानसभा चुनाव 2012)

उम्मीदवारों का सारांश

- ☞ हिमाचल प्रदेश इलेक्शन वॉच ने 459 में से 445 उम्मीदवारों का विश्लेषण किया है जो हिमाचल प्रदेश विधानसभा 2012 में चुनाव लड़ने जा रहे हैं।
- ☞ हिमाचल प्रदेश विधानसभा चुनाव 2012 में 445 उम्मीदवारों में से आपराधिक मामलों वाले 69 यानि 16 प्रतिशत उम्मीदवारों ने अपने विरुद्ध आपराधिक मामले घोषित किये हैं। हिमाचल प्रदेश विधानसभा 2007 में 18 प्रतिशत उम्मीदवारों ने अपने विरुद्ध आपराधिक मामले घोषित किये थे।
- ☞ मुख्य दलों के बीच, सभी ने ऐसे उम्मीदवारों को टिकट दिया है जिन्होंने अपने विरुद्ध आपराधिक मामले घोषित किये हैं। इनमें कांग्रेस के 68 में से 16 (24 प्रतिशत), भाजपा के 67 में से 7 (10 प्रतिशत), बसपा के 62 में से 8 (13 प्रतिशत), एच.एल.पी 32 में से 6 (19 प्रतिशत), ए.आई.टी.सी के 26 में से 2 (8 प्रतिशत), सी.पी.एम. के 16 में से 10 (63 प्रतिशत) और निर्दलीय उम्मीदवारों के 98 में से 9 (9 प्रतिशत) ने अपने विरुद्ध आपराधिक मामलों की पुष्टि की है।
- ☞ आपराधिक मामले घोषित करने वाले 69 में से 30 उम्मीदवारों ने अपने विरुद्ध गंभीर आपराधिक मामले घोषित किये हैं जैसे— हत्या, हत्या का प्रयास, अपहरण, डकैती, जबरनवसूली आदि। इनमें सी.पी.एम के 5, भाजपा के 4, एच.एल.पी का 1 और बसपा के 5 उम्मीदवार शामिल हैं।
- ☞ आपराधिक मामले घोषित करने वाले 69 में से 41 उम्मीदवार ऐसे हैं जिन पर आरोप तय किये गये हैं जैसे अपहरण, डकैती, चोरी आदि।
- ☞ 69 उम्मीदवारों में सबसे ज्यादा आपराधिक मामले घोषित करने वालों की श्रेणी में प्रथम स्थान में निर्वाचन क्षेत्र शिमला से सी.पी.एम. के उम्मीदवार तिकेन्द्र पंवार (2 मामले, हत्या, और हत्या का प्रयास) हैं, द्वितीय स्थान पर निर्वाचन क्षेत्र जोगिन्दरनगर से सी.पी.एम. के ही उम्मीदवार कुशल भारद्वाज (3 मामले, 1 गंभीर, हत्या का प्रयास) है, और तृतीय स्थान पर निर्वाचन क्षेत्र शिमला से कांग्रेस के उम्मीदवार हरीश (4 मामले, धोखाधड़ी और जालसाजी) है।
- ☞ 445 में से 248 उम्मीदवार यानि 56 प्रतिशत उम्मीदवार स्नातक और इससे अधिक हैं।
- ☞ हिमाचल प्रदेश विधानसभा 2012 में 445 में से कुल 27 यानि 6 प्रतिशत महिलाएँ चुनाव लड़ने जा रही हैं।

विश्लेषण के आधार पर उम्मीदवारों द्वारा घोषित आपराधिक मामले

हिमाचल प्रदेश इलेक्शन वॉच द्वारा विधानसभा चुनाव 2012 के लिए कुल 445 उम्मीदवारों का विश्लेषण किया गया। इन 445 में से 69 उम्मीदवारों ने यानि 16 प्रतिशत ने अपने विरुद्ध आपराधिक मामलों की घोषणा की हैं। आपराधिक मामलों वाले 69 उम्मीदवारों में से 30 ऐसे उम्मीदवार हैं जिनके खिलाफ गंभीर आपराधिक मामले दर्ज हैं जैसे कि हत्या, हत्या का प्रयास, चोरी, जबरन वसूली आदि।
