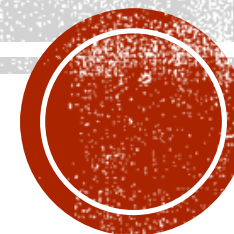
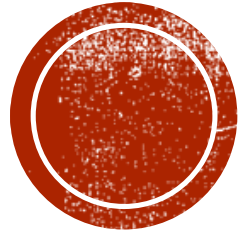

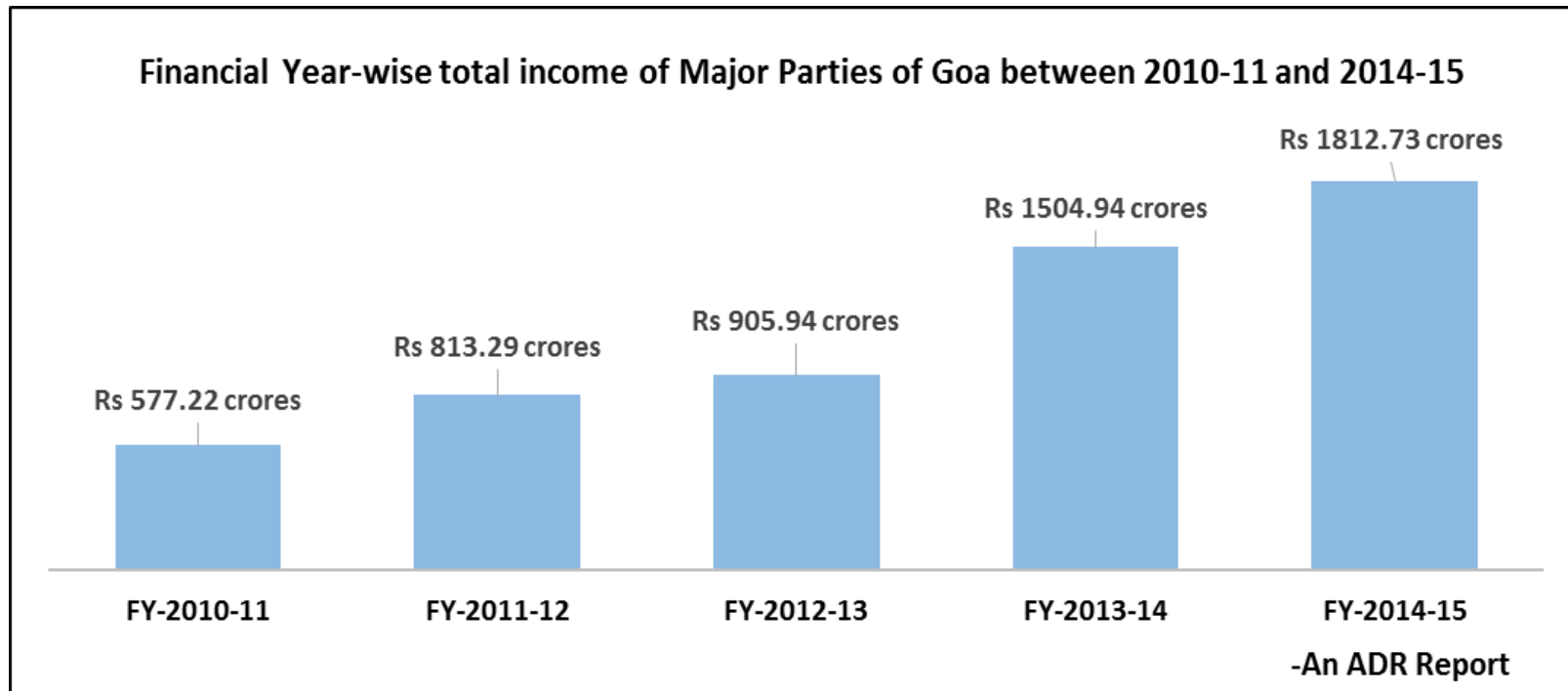
INCOME AND EXPENDITURE OF GOA'S POLITICAL PARTIES FY-2010-11 TO 2014-15

Total Income Of Political Parties During 5 Years (From All Over India)

- The income of political parties between FY 2010-11 and 2014-15 are calculated from their IT returns filed annually with the Income Tax Department.
- **BJP** has the **highest total declared income of Rs 2445.87 crores** between FY 2010-11 and 2014-15
- Total income of **INC** during the same period was **Rs 2280.43 crores**.
- **MGP** declared total income **Rs 1.81 crores** while **AAP** declared **Rs 110.05 crores** as income from all over India in last 5 Financial Years.



Total income of political parties of Goa – FY 2010-11 to 2014-15

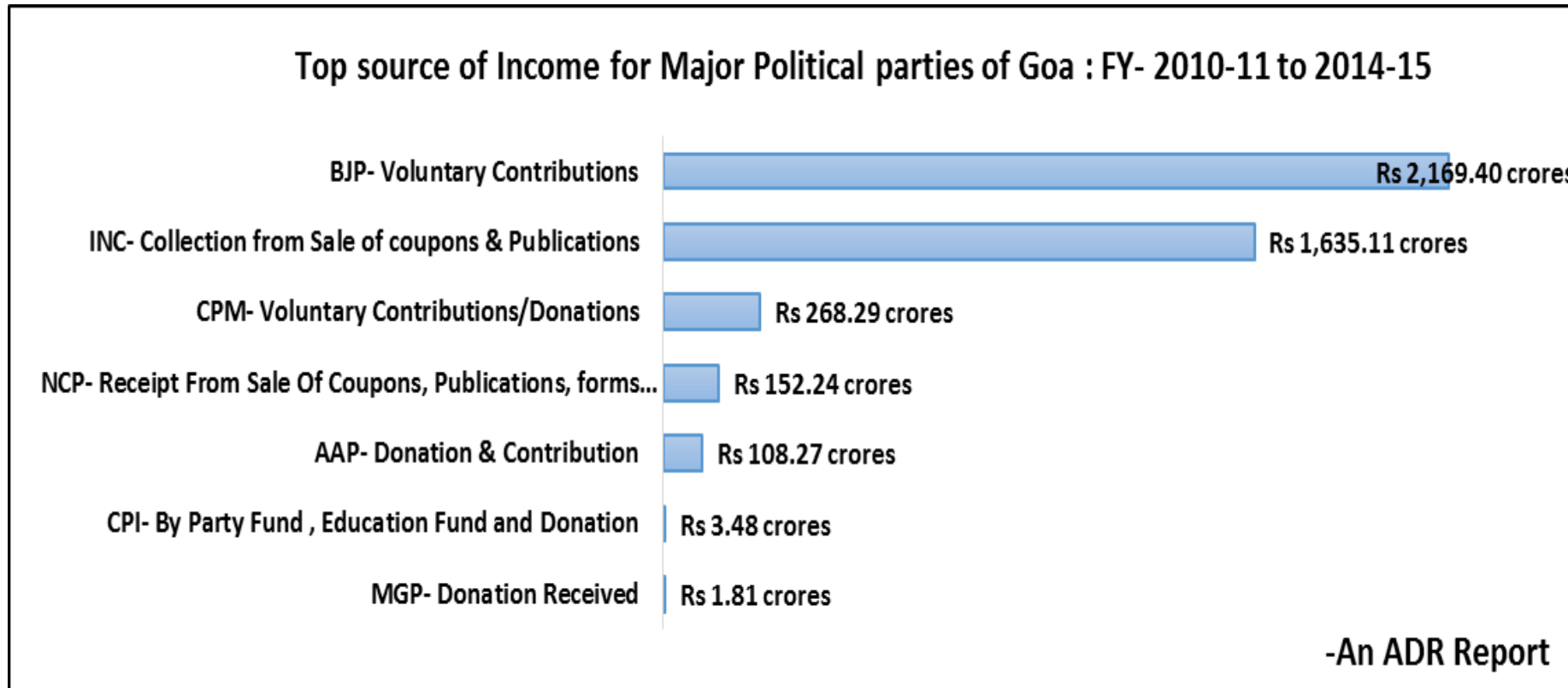


Top sources of income of political parties of Goa- FY 2010-11 to 2014-15

- Income from **Donations/Voluntary Contributions** are the **most common** and the **top most source of income** for all the 6 political parties of Goa.
- **Donations/Voluntary Contributions** which totally amount to **Rs 2,998.75 crores**, constitutes **53.42%** of the total income of all political parties of Goa, in 5 FYs.
- In the 5 financial years, **MGP is the only party of Goa, which has declared 100% (Rs 1.81 crores) of its income from donations received.**
- **AAP** has declared **98.38%** (Rs 108.27 crores) of its total income from **donations**.



Top source of income of Goa's parties

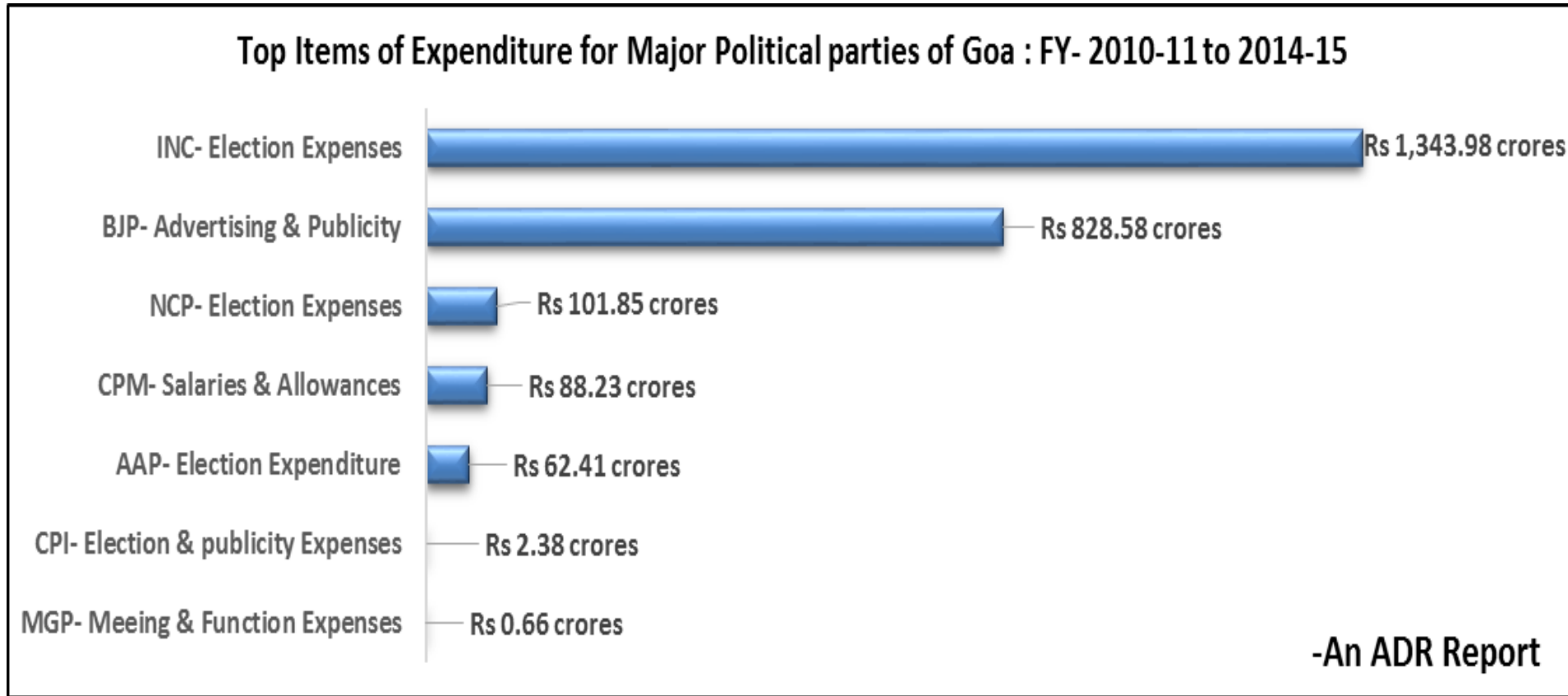


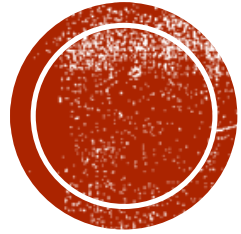
Top items of expenditure of Political parties of Goa- FY 2010-11 to 2014-15

- The most common items of expenditure across parties include expenses towards **Elections, meetings and salaries & allowances.**
- The maximum expenditure was declared under elections (Rs 1,557.98 cr) followed by advertisement & publicity expenses (Rs 882.55 cr) and admin expenses (Rs 561.46 cr).
- The maximum expenditure of BJP has been towards Advertisement & Publicity which constitutes **46.46%** (Rs 828.58 crores) of its total expenses.
- **It is to be noted that INC has written off Rs 89.71 crores between FY 2010-11 and 2014-15** which is one of the top 3 items listed under expenditure by the party.
- **MGP** has declared maximum expenditure of **Rs 66 lakhs on meeting & function expenses.**

VOLUNTARY CONTRIBUTIONS RECEIVED BY GOA'S POLITICAL PARTIES FY-2010-11 TO 2014-15

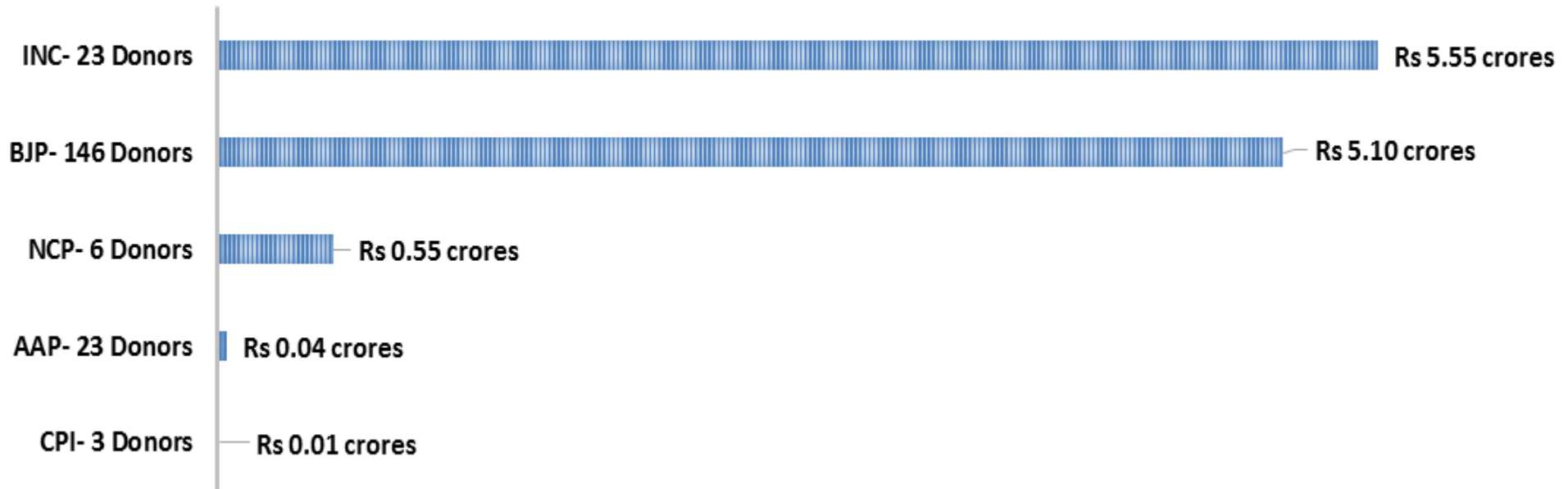
Total amount of Donations received from Goa by Political Parties

- Of all the donations declared by parties as received from Goa, INC has declared maximum donations from Goa above Rs 20,000 aggregating to Rs 5.55 crores from 23 donations, between FY 2010-11 and 2014-15.
- BJP has declared collecting donations of Rs 5.10 crores above Rs 20,000 from Goa between FY 2010-11 and 2014-15
- MGP has not declared its donations statements for 4 years between FY- 2010-11 & 2013-14. Party submitted its donations details (above Rs 20,000) to the ECI for only one financial year.
- AAP has declared that the party received Rs 4 lakhs via 23 donations from Goa in the past two financial years.

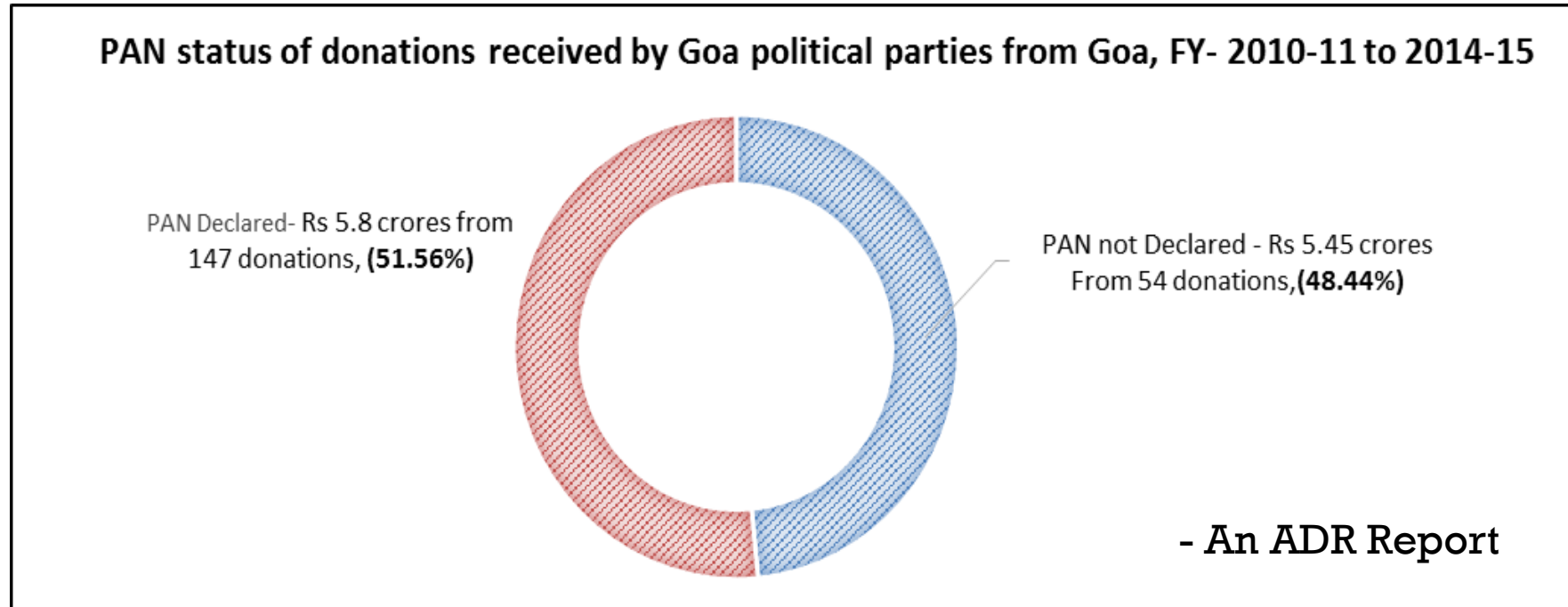


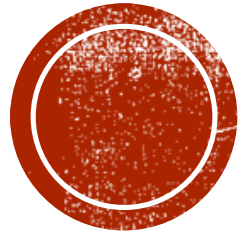
Sector-wise Analysis Of Donations To Major Political Parties of Goa

- 201 donations were made from Goa for a total of Rs 11.25 cr to BJP, INC, CPI, NCP and AAP of which 139 donations (Rs 10.64 cr) were made by corporates, 58 donations (Rs 60 lakhs) by individuals and Rs 1 lakh via 4 undeclared donations.
- **BJP, INC and NCP** have received 94.58% (Rs 10.64 crores) of their total contributions above Rs 20,000 from **139 Corporate/Business Houses**. INC received Rs 5.55 crores, BJP Rs 4.54 crores and NCP received Rs 55 lakhs from corporate or business houses of Goa.
- MGP has received Rs 3 lakhs (18.58%) in donations from only a single corporate/business house, **Vasantrao Mehta & Co Vasco**.
- The party received 81.42% (Rs 13.15 lakhs) of its total donations from 34 individual donors.



Declaration Of PAN Details In Donations Received From Goa

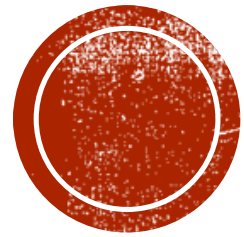




RECOMMENDATIONS OF ADR

- The ECI had **issued guidelines** to the political parties in order to **promote transparency** in the parties' functioning and to aid the Commission to **conduct free and fair elections**. Those parties playing a decisive role at the national political arena should **lead by example** in **promoting and practicing** the desired quality of transparency and accountability in its functioning.
- The Supreme Court gave a judgment on September 13, 2013 declaring that no part of a candidate's affidavit should be left blank. Similarly, **no part of the Form 24A submitted by political parties providing details of donations above Rs 20,000 should be blank**.
- Full details of all **donors should be made available for public scrutiny under the RTI**. Some countries where this is done include Bhutan, Nepal, Germany, France, Italy, Brazil, Bulgaria, the US and Japan. In none of these countries is it possible for **80% of the source of funds to be unknown**, but at present it is so in India.
- **The National and regional political parties must provide all information on their finances under the Right to Information Act**. This will only strengthen political parties, elections and democracy.
