## Summary and Highlights

**Kerala Election Watch** and **Association for Democratic Reforms** have analysed the self-sworn affidavits of **20 out of 21 Ministers** including Chief Minister from Kerala State Assembly 2021. A **CPI (M)** Minister namely **V.Sivankutty** has not been analysed due to the unavailability of his complete and properly scanned affidavit on the ECI website while making the report.

The information is based on the affidavits submitted by the candidates prior to 2021 Kerala Assembly Elections.

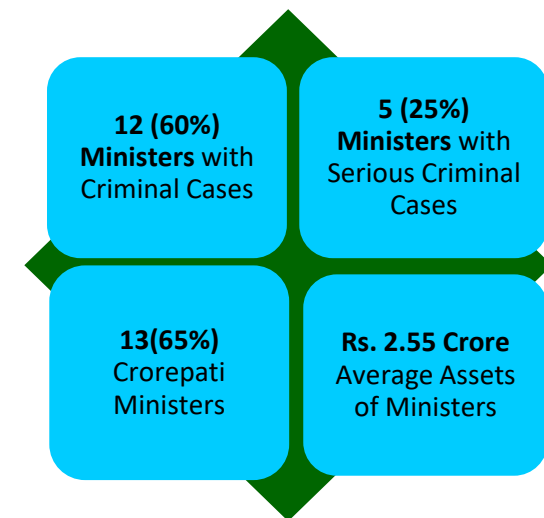

### ***Criteria for serious criminal cases***

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Average Assets:** The average assets of **20** ministers analysed is **Rs 2.55 crores**.
- **Minister with Highest Assets:** The minister with the highest declared total assets is V.Abdurahiman from Tanur constituency with assets worth Rs. 17.17 crores.
- **Minister with Lowest Assets:** The minister with the lowest declared total assets is P Prasad from Cherthala constituency with assets worth Rs. 14.18 lakhs.
- **Liabilities:** A total of 13 ministers have declared liabilities out of which the minister with the highest liabilities is V.Abdurahiman of Tanur constituency with Rs. 7.26 crores of liabilities.

## Other Background details (Education, Gender, Age)

- **Ministers' Education:** **8 (40%)** ministers have declared their educational qualification to be between **8<sup>th</sup> and 12<sup>th</sup>** standard while **12 (60%)** ministers have declared having an educational qualification of **graduate or above**.
- **Ministers' Age:** A total of **13(65%)** ministers have declared their age to be between **41-60 years** while **7(35%)** ministers have declared their age to be between **61- 80 years**.
- **Women Ministers:** Out of 20 ministers, **3** are women.
