## Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **28** candidates, who are contesting in the **Biennial election** to the **Maharashtra Legislative Council** from 6 local authorities' Constituencies, scheduled to be held in 6 districts, on **19<sup>th</sup> November, 2016**. Due to some missing information and unavailability of candidate affidavit, ADR could not analyse background details of **2** candidates for this election.

MLC Biennial Elections are being held for only 6 seats, details of which are as follows –

## Criminal Background

- **Candidates with Criminal Cases:** **7 (25%)** out of 28 candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **4 (14%)** out of 28 candidates have declared serious criminal cases against themselves like **culpable homicide not amounting to murder, attempt to murder, bribery, dacoity, robbery, etc.**
- **Party wise Candidates with declared Criminal Cases:**  
**2 (67%)** out of **3** candidates analysed from **BJP** and **2 (67%)** out of **3** candidates analysed from **NCP** have declared **criminal cases** against themselves in their affidavits.

### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party wise Candidates with declared Serious Criminal Cases:** 1 (33%) out of 3 candidates analysed from NCP, has declared serious criminal cases against himself in his affidavit.

## Financial Background

- **Crorepati Candidates:** Out of the 28 candidates analyzed, 20 (71%) are crorepati, of which 11 belong to major parties.
- **Party-wise Crorepati Candidates:** 4 (100%) out of 4 candidates analysed from INC, 3 (100%) out of 3 candidates analysed from BJP, 3 (100%) out of 3 candidates analysed from NCP, and 1 (100%) out of 1 candidate analysed from Shiv Sena are crorepati.

- **Average Assets:** The average assets per candidate analyzed for the biennial election to the Maharashtra Legislative Council from 6 local authorities' Constituencies, is Rs. 16 Crores +.
- **Party-wise Average Assets:** Among major parties, the average assets per candidate for 4 analyzed INC candidates is Rs 26 Crores+, 3 NCP candidates have average assets of Rs. 36 Crores+, 3 BJP candidates have average assets of Rs. 17 Crores+, and 1 Shiv Sena candidate has highest average asset of Rs. 115 Crores+.


