

## संक्षेप आणि ठळक मुद्दे

असोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स (एडीआर) आणि महाराष्ट्र इलेक्शन वॉच यांनी विधानसभा सदस्यांद्वारे निवडून दिलेल्या सर्व ९ विजेते उमेदवारांच्या शपथपत्रांचे विश्लेषण केले आहे. मे २०२० मध्ये महाराष्ट्र विधानपरिषद द्विवार्षिक निवडणूक लढणारे सर्व उमेदवार बिनविरोध विजयी झाले आहे.

### गुन्हेगारी पार्श्वभूमी

- **गुन्हेगारी प्रकरण असलेले विजेते उमेदवार:** विश्लेषित केलेल्या ९ पैकी ७ (७८%) विजेते उमेदवाराने त्याच्या विरोधात गुन्हेगारी प्रकरण दाखल असल्याचे घोषित केले आहे.
- **गंभीर गुन्हेगारी प्रकरण असलेले विजेते उमेदवार:** विश्लेषित केलेल्या ९ पैकी २ (२२%) विजेते उमेदवाराने त्याच्या विरोधात गंभीर स्वरूपाचे गुन्हे दाखल असल्याचे घोषित केले आहे. बलात्कार, हत्या आणि हत्याचा प्रयत्न इत्यादी.

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
