# Madhya Pradesh Legislative Assembly: Bye -Elections 30<sup>th</sup> October, 2021 Criminal Background, Financial, Education, Gender and other details of Candidates

Association for Democratic Reforms and Madhya Pradesh Election Watch have analyzed affidavits for all **32 candidates** contesting in Madhya Pradesh Assembly Bye-election to be held in 3 constituencies namely **Jobat, Prithvipur and Raigaon on 30<sup>th</sup> October, 2021.** 

- There are 5(16%) candidates who have declared criminal cases against themselves. Out of these, 4(13%) have declared serious criminal cases against themselves.
- > 9(28%) candidates are crorepati.
- > The average assets per candidate contesting in the bye election from Madhya Pradesh is **Rs. 1.37 crore.**
- > There are 7 candidates who have declared liabilities.
- Out of 32 candidates, 5 are women.


