## **Analysis of Criminal, Financial and Other Background details of Candidates from Maharashtra (7 constituencies) for Lok Sabha 2014**

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analyzed the self-sworn affidavits of 140 out of the 142 candidates contesting from Maharashtra (Phase – 3) for Lok Sabha Election 2014 contesting from the following 7 constituencies:

1. Mumbai North
2. Mumbai North Central
3. Mumbai North East
4. Mumbai North West
5. Mumbai South
6. Mumbai South Central
7. Thane

The following candidate has not been analysed due to unavailability of affidavits or incomplete affidavits at the time of making this report:

## Executive Summary

### Criminal Background

- **Candidates with Criminal Cases:** Out of the 140 candidates analysed, **23 candidates (16%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 116 candidates, **18 candidates (13%)** have declared serious criminal cases
- **Party wise Candidates with Criminal Cases:** INC has **1 (20%)** out of 5, AAP has **1 out of 7 (14%)** and BJP has **2(67%)** out of 3 candidates with declared criminal cases.
- **Party wise Candidates with Serious Criminal Cases:** AAP has **1(14%)** out 7, **2 (67%)** out of 3 candidates from BJP and INC has **1 (20%)** out of 5 candidates who declared serious criminal cases against themselves.
- **Red Alert Constituencies\***: 5 constituencies out of the 7 analysed have at least 3 candidates with declared criminal cases *\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections (including independents)*

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

### Financial Background

- **Crorepati Candidates:** Out of the 140 candidates analysed, **56 (40%)** are crorepatis.
- **Party-wise Crorepati Candidates:** All 5 INC candidates, all 3 BJP candidates and **6 (86%)** out of 7 AAP candidates are crorepatis.
- **Average Assets:** The average assets per candidate contesting in the 7 constituencies analysed is **Rs. 4.77 crores**.
- **Party-wise Average Assets:** Among major parties, the average asset per candidate for 3 BJP candidates was **Rs. 41.62 crores**, for 5 INC candidates was **Rs. 32.67 crores** and for 7 AAP candidates was **Rs. 11.73 crores**.
- **High Asset Candidates:** **21** candidates have declared more than **Rs. 5 crore worth of assets**. Total assets include assets of self, spouse and others. Top 3 candidates with highest assets are:

- **Candidates who have not declared Income Tax Details\*:** 48 (34%) candidates out of 140 analyzed have not declared income tax details. \* Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details:** 8 candidates out of 140 analysed have declared assets of more than Rs 50 lakhs but have not declared Income Tax Details.
- **Undeclared PAN:** 7 (5%) out of 140 candidates analysed have not declared their PAN details.

### **Other Background details (Education, Gender, Age)**

- **Candidates' Education:** 68 (49%) out of 140 candidates have an education qualification of 12 pass and below. 61 (43%) out of 140 candidates have declared an education qualification of graduate and above. 4 candidates have declared that they are illiterate

- **Candidates' Age:** 97 (69%) out of 140 candidates have declared their age to be between 25 to 50 years. 48 (34%) out of 140 candidates have declared their age to be between 50 to 80 years.
- **Gender representation:** Of the 140 candidates analyzed, only **14 (10%)** are women.
