 1.60 करोड़ घोषित की हैं।
- देनदारी घोषित करने वाले मंत्री: 39 मंत्रियों ने अपनी देनदारी घोषित की है, जिसमें से निर्वाचन क्षेत्र मालाबार हिल से मंगल प्रभाल लोढ़ा ने ₹ 306.22 करोड़ के साथ सबसे ज़्यादा देनदारी घोषित हैं।

- शैक्षिक योग्यताः 13 (31 प्रतिशत) मंत्रियों ने अपनी शैक्षिक योग्यता 8वीं और 12वीं के बीच घोषित की है, जबकि 25 (60 प्रतिशत) मंत्रियों ने अपनी शैक्षिक योग्यता स्नातक और इससे ज़्यादा घोषित की हैं। 4 मंत्रियों ने अपनी शैक्षिक योग्यता डिप्लोमा धारक घोषित की है।
- ङ <u>मंत्रियों की आयुः</u> 13 (31 प्रतिशत) मंत्रियों ने अपनी आयु 31 से 50 वर्ष के बीच घोषित की है, जबकि 29 (69 प्रतिशत) मंत्रियों ने अपनी आयु 51 से 80 वर्ष के बीच घोषित की हैं।
