मंत्रिमंडल के पुनर्गठन के बाद, महाराष्ट्र इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने महाराष्ट्र राज्य विधानसभा 2019 से मुख्यमंत्री सहित सभी 20 मंत्रियों के शपथपत्रों का विश्लेषण किया।

यह विश्लेषण 2019 के विधानसभा चुनावों और उसके बाद हुए उपचुनावों में उम्मीदवारों द्वारा प्रस्तुत शपथपत्रों पर आधारित हैं।

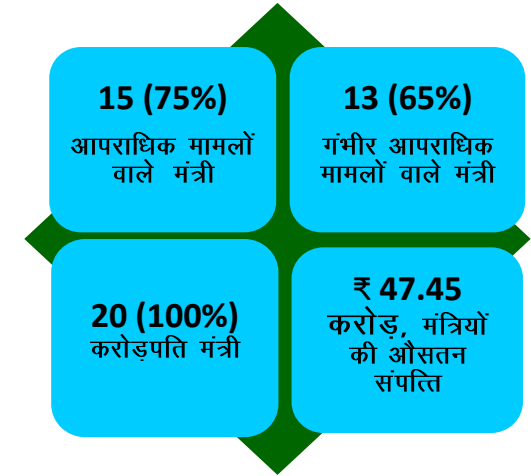

☞ अधिकतम संपत्ति वाले मंत्री: अधिकतम संपत्ति घोषित करने वाले मंत्रियों में निर्वाचन क्षेत्र मालाबार हिल से मंगल प्रभात लोढ़ा ने सबसे अधिक संपत्ति ₹ 441.65 करोड़ घोषित की हैं।

- ☞ सबसे कम संपत्ति वाले मंत्री: सबसे कम संपत्ति घोषित करने वाले मंत्रियों में निर्वाचन क्षेत्र पैठण से भूमरे संदीपानराव आसाराम ने सबसे कम संपत्ति ₹ 2.92 करोड़ घोषित की हैं।
- ☞ देनदारी घोषित करने वाले मंत्री: कुल 18 मंत्रियों ने अपनी देनदारी घोषित की है, जिसमें निर्वाचन क्षेत्र मालाबार हिल से मंगल प्रभात लोढ़ा ने ₹ 283.36 करोड़ के साथ सबसे ज़्यादा देनदारी घोषित हैं।

अन्य पृष्ठभूमि की जानकारी (शैक्षिक योग्यता, लिंग और आयु)

- ☞ शैक्षिक योग्यता: 8 (40 प्रतिशत) मंत्रियों ने अपनी शैक्षिक योग्यता 10वीं और 12वीं के बीच घोषित की है, जबकि 11 (55 प्रतिशत) मंत्रियों ने अपनी शैक्षिक योग्यता स्नातक और इससे ज़्यादा घोषित की हैं और एक मंत्री ने अपनी शैक्षिक योग्यता डिप्लोमा धारक घोषित की हैं।
- ☞ मंत्रियों की आयु: 4 (20 प्रतिशत) मंत्रियों ने अपनी आयु 41 से 50 वर्ष के बीच घोषित की है, जबकि 16 (80 प्रतिशत) मंत्रियों ने अपनी आयु 51 से 70 वर्ष के बीच घोषित की हैं।
- ☞ महिला प्रतिनिधित्व: 20 मंत्रियों में से कोई भी महिला मंत्री नहीं हैं।
