

Summary and Highlights

Manipur Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all 60 newly elected MLAs in the Manipur 2017 Assembly Elections.

Criminal background

- **MLAs with criminal cases:** Out of the **60** MLAs analysed, **2(3%)** MLAs have declared criminal cases against themselves. Out of 60 MLAs analysed during **Manipur Assembly elections in 2012**, no MLAs had declared criminal cases against themselves.
- **MLAs with serious criminal cases:** **2(3%)** MLAs have declared serious criminal cases including cases related to attempt to murder, criminal intimidation etc.




Figure: Comparison of MLAs with declared criminal cases in 2012 and 2017

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **MLAs with cases related to murder and attempt to murder:** 1 MLA namely Soibam Subhachandra of BJP from Naoriya Pakhanglakpa constituency has declared 1 charge related to Attempt to Murder in his affidavit.
- **Party wise MLAs with criminal cases:** 1(4%) out of 28 MLAs from INC and 1 (5%) out of 21 MLAs from BJP have declared criminal cases against themselves in their affidavits.
- **Party wise MLAs with serious criminal cases:** 1(4%) out of 28 MLAs from INC and 1 (5%) out of 21 MLAs from BJP have declared serious criminal cases against themselves in their affidavits.




Figure: Share of wealth among MLAs





- **Party wise average assets:** The average assets per MLA for **28 INC** MLAs analysed is **Rs 3.33 crores**, **21 BJP** MLAs have average assets of **Rs 1.25 crore**, **4 Naga Peoples Front** MLAs have average assets of **Rs 1.17 crore** and **4 National Peoples Party** MLAs have average assets of **Rs 1.08 crore**

- **Number of re-elected MLAs:** Number of re-elected MLAs analysed in the assembly elections of 2017 is 28
- **Average assets of re-elected MLAs in 2012:** The average assets of re-elected MLAs in 2012 was Rs. Rs 1.39 crore
- **Average assets of re-elected MLAs in 2017:** The average assets of re-elected MLAs in 2017 is Rs 1.96 crore
- **Average growth in assets of re-elected MLAs from 2012 to 2017:** The growth in average assets of re-elected MLAs is Rs 56.99 lakhs i.e. by 41%.

- **Education Details of MLAs:** 14 (23%) MLAs have declared their education qualification to be between 5th pass and 12th pass while 42 (70%) MLAs have declared having an educational qualification of **graduate or above** and 1 MLA has declared to be an **illiterate**.
- **Age details of MLAs:** 27 (45%) MLAs have declared their age to be between 25 and 50 years while 33 (55%) MLAs have declared their age to be between 51 and 80 years.
- **Gender details of MLAs:** Out of 60 MLAs, 2 (3%) MLAs are women. In 2012, out of 60 MLAs, 3 (5%) MLAs were women.








