




Summary and Highlights

The information is based on the affidavits submitted by the candidates prior to 2023 Nagaland Assembly Elections.

Criminal Background

• Ministers with Criminal Cases: None of the ministers have declared criminal cases against themselves.

Financial Background

- Crorepati Ministers: Out of the 12 ministers analysed, 11 (92%) are crorepatis.
- Average Assets: The average assets of 12 ministers analysed is Rs 10.58 crores.
- Minister with Highest Assets: The minister with the highest declared total assets is Neiphiu Rio from Northern Angami-II (ST) constituency with assets worth Rs. 46.95 crores.
- Minister with Lowest Assets: The minister with the lowest declared total assets is P. Paiwang Konyak from Tizit (ST) constituency with assets worth Rs. 67.84 lakhs.

Other Background details (Education, Gender, Age)

- Ministers' Education: 8 (67%) ministers have declared their educational qualification to be between 8th pass and 12th pass, while 4 (33%) ministers have declared having an educational qualification of graduate.
- Ministers' Age: 4 (33%) ministers have declared their age to be between 41 and 50 years while 8 (67%) ministers have declared their age to be between 51 and 80 years.
- Women Ministers: Out of 12 ministers, 1 is a woman.


