Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analyzed the self-sworn affidavits of **77** out of 81 winners who had contested in the **20** multiple member wards of the **Nanded Waghala Municipal Corporation Elections**, held on **11th October, 2017** in Maharashtra. The rest of the affidavits were not analysed as they were not available at the time of making this report.

Criminal Background

- **Winners with Criminal Cases:** **24 (31%)** out of **77** analyzed winners have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases:** **18 (23%)** out of **77** analyzed winners have declared serious criminal cases against themselves like **attempt to murder, rape, culpable homicide not amounting to murder, assault or criminal force to woman with intent to outrage her modesty, extortion, robbery, dacoity, criminal intimidation, forgery, cheating, etc.**
- **Party wise Winners with declared Criminal Cases:** **22 (32%)** out of 69 winners from **Indian National Congress** and **1 (17%)** out of 6 winners from **Bhartiya Janata Party**, have declared criminal cases against themselves in their affidavits.
- **Party wise Winners with declared Serious Criminal Cases:** **17 (25%)** out of 69 winners from **Indian National Congress** have declared **serious** criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act



- **Winners with PAN details-** A total of **68** (88%) winners have declared their PAN details whereas **9** (12%) winners have not declared their PAN details.




Other Background Details




