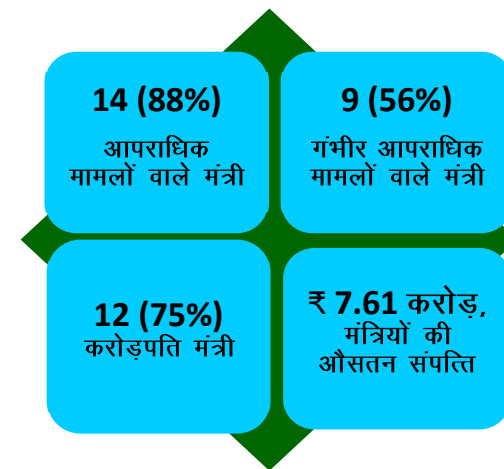

- ☞ औसतन संपत्ति: 16 मंत्रियों की औसतन संपत्ति ₹ 7.61 करोड़ है।
- ☞ अधिकतम संपत्ति वाले मंत्री: अधिकतम संपत्ति घोषित करने वाले मंत्रियों में निर्वाचन क्षेत्र पटनागढ़ से कनक वर्धन सिंह देव ने सबसे अधिक संपत्ति ₹ 67.30 करोड़ घोषित की है।
- ☞ सबसे कम संपत्ति वाले मंत्री: सबसे कम संपत्ति घोषित करने वाले मंत्रियों में निर्वाचन क्षेत्र धामनगर से सूर्यवंशी सूरज स्थितप्रज्ञ ने सबसे कम संपत्ति ₹ 60.49 लाख घोषित की है।
