## Executive Summary

### Criminal Background

- **Candidates with Criminal Cases:** Out of all 150 candidates analysed, **23 candidates (15%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **13 candidates (9%)** have declared serious criminal cases including cases related to kidnapping, criminal intimidation, extortion etc.
- **Candidates with multiple serious IPC counts:** **Maresh Gori** of **BJP** from **East Delhi** Constituency has declared the highest count of serious IPC charges i.e. **4**. He is followed by **Sunil Chhikara** an Independent candidate from **North West Delhi** Constituency and **Mahabal Mishra** of **INC** from **West Delhi** Constituency, with **3 IPC Counts** each.
- **Party wise Candidates with Criminal Cases:** **5 (71%)** out of **7** candidates fielded by **BJP**, **2 (29%)** out of **7** candidates from **INC**, **2(29%)** out of **7** candidates of **BSP**, **2 (67%)** out of **3** candidates of **SHS**, **1 out of (14%)** **7** candidates of **AAP**, **1** candidate each from both **Agar Jan Party** and **Rashtriya Ekta Party** and **9 (16%)** out of **58 Independent** candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **4 (57%)** out of **7** candidates fielded by **BJP**, **2 (29%)** out of **7** candidates of **BSP**, **2 (67%)** out of **3** candidates of **SHS**, **1(14%)** out of **7** from **INC** and **4(7%)** out of **58 Independent** candidates have declared serious criminal cases against themselves in their affidavits.
- **Candidates with Crimes against Women:** One candidate, **Mohammad Shakeel Saifi** of **BSP** from **East Delhi** constituency has declared a case related to **assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)** and **word, gesture or act intended to insult the modesty of a woman (IPC Section-509)**
- **Candidates with cases related to Kidnapping:** **2** candidates have declared cases related to Kidnapping

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

**Red Alert Constituencies\*:** **2** constituencies have at least 3 candidates from political parties with declared criminal cases.

## Financial Background

- **Crorepati Candidates:** Out of all 150 candidates analysed, **49 (33%)** are crorepatis.
- **Party-wise Crorepati Candidates:** All **7** candidates of **INC**, **6 (86%)** out of 7 candidates in **BJP**, **6 (86%)** out of 7 candidates in **AAP**, **4 (80%)** out of 5 candidates in **AITC** and **3 (43%)** out of 7 candidates in **BSP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the third phase of 2014 Lok Sabha Elections from Delhi is **Rs.3.09 Crores**.
- **Party-wise Average Assets:** Among major parties, the average assets for **7 INC** candidates is **Rs 28.29 crores**, **7 BJP** candidates have an average assets of **Rs.12.60 crores**, **7 AAP** candidates have average assets of **Rs. 3.01 crores**, **7 BSP** candidates have average assets of **Rs. 1.75 crores** while **5 AITC** candidates have average assets of **Rs. 2.17 crores**.
- **High Asset Candidates:** **11** candidates have more than **Rs. 10 crores worth of assets**. Total Assets includes Self Assets and Others Assets. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of all 150 candidates who are contesting, a total of **43** candidates have declared assets **less than Rs.10 Lakhs**. The three candidates with lowest assets are as follows:

- **Candidates who have not given value for Immovable Assets:** 20 candidates have not given value for atleast one immovable asset declared in their affidavits.
- **Candidates who have dues to Government Departments:** 4 candidates have declared that they have dues to Government Departments.
- **Candidates with Liabilities:** A total of **50** candidates out of all 150 contesting candidates have declared liabilities. **Manoj Tiwari** of **BJP** from North East Delhi constituency has declared liabilities worth **Rs. 3.46 crores** followed by **Parvesh Sahib Singh** of **BJP** from West Delhi constituency with liabilities worth **Rs. 2.66 crores** and **Ashutosh** of **AAP** from Chandni Chowk constituency with liabilities worth **Rs. 1.11 crores**
- **Candidates with High Income:** **23** candidates have declared total annual income of **over Rs. 10 Lakhs**.

- **Candidates who have not declared Income Tax Details\***: 59 (39%) candidates out of all 150 contesting candidates have not declared income tax details. \* Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details**: 6 candidates with assets worth more than Rs. 1 crore, have not declared their Income Tax Details.
- **Undeclared PAN**: 16(11%) out of all 150 candidates have not declared their PAN details.

### **Other Background details (Education, Gender, Age)**

- **Candidates' Education**

77 candidates (51%) have educational qualification of class 12 or below while 65 (43%) candidates are graduates or have higher degrees. There are four illiterate candidates in fray.
