Association of Democratic Reforms (ADR) and Jharkhand Election Watch (JEW) have analyzed the selfsworn affidavits of 60¹ out of 62 candidates (as given by the ECI) who are contesting the 3rd Phase of Lok Sabha 2014 elections from Jharkhand.

Executive Summary

Criminal Background

- <u>Candidates with Criminal:</u> Out of the 60 candidates analysed, 14 candidates (23%) have declared criminal cases against themselves.
- <u>Candidates with Serious Criminal Cases</u>: Out of 14 candidates with criminal charges, **8** candidates have declared serious criminal cases including cases related to **murder, crimes against women, dacoity, robbery etc.**
- <u>Candidates with multiple serious IPC counts:</u> Kameshwar Baitha of AITC from Palamau constituency has declared the highest number of serious IPC counts, i.e. 109, followed by Keshwar Yadav of SP from Chatra constituency i.e. 20. They are followed by Ramnaresh Singh of CPI(ML)L from Chatra constituency with 9 serious IPC counts.

Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- 3. If it is an electoral offence (IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.
- <u>Party wise Candidates with Criminal Cases</u>: 1 (25%) out of 4 candidates fielded by JVM, 2 (50%) out of 4 candidates from AITC, 2 (67%) out of 3 candidates fielded by JD(U), CPI(ML)(L) and SP have declared criminal cases against themselves in their affidavits.
- <u>Party wise Candidates with Serious Criminal Cases:</u> 2 (50%) of 4 candidates fielded by AITC, 2 (67%) out of 3 candidates from SP and CPI(ML)(L) have declared serious criminal cases against themselves in their affidavits.
- <u>Candidates with cases related to Murder</u>: 6 candidates have declared cases related to murder. Kameshwar Baitha of AITC from Palamau constituency with 16 charges of murder, 25 charges related to attempt to murder and 2 charges related to kidnapping or abducting in order to murder, Keshwar Yadav of SP from Chatra constituency with 1 charge of murder, 1 charge related to dacoity with murder and 6 charges related to attempt to murder.
- <u>**Red Alert Constituencies*:**</u> 3 constituencies have at least 3 candidates from political parties with declared criminal cases. These are the following:

*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting for elections. This analysis excludes independent candidates with criminal cases.





Financial Background

- <u>Crorepati Candidates</u>: Out of the 60 candidates analysed, 10 (17%) are crorepatis.
- Party-wise Crorepati Candidates: 3 (75%) out of 4 candidates of BJP, 2 (67%) out of 3 candidates of JD(U), 1(50%) out of 2 candidates from INC, 1 (25%) out of 4 candidates of JVM have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the 1st phase of 2014 Jharkhand Lok Sabha Elections is **Rs. 1.45 crores**.
- Party-wise Average Assets: Among major parties, the average assets for 4 BJP candidates is Rs. 5.47 crores, 4 JVM candidates have average assets of Rs. 71.66 lakhs, 3 JD(U) candidates have average assets of Rs. 2.03 crores, 2 INC candidates have average assets of Rs. 13.37 crores and the average assets of 4 BSP candidates is Rs. 67.54 lakhs.
- <u>High Asset Candidates</u>: 10 candidates have more than **Rs. 1 crore worth of assets**. Total assets include self assets and others assets. The top three candidates with highest assets are given below:

 Low Asset Candidates: Out of 60 candidates analysed, a total of 9 candidates have declared assets less than Rs. 10 lakhs. The top three candidates with lowest assets are as follows:

- **Candidates who have not given value for Immovable Assets:** 3 candidates have not given value for atleast one immovable asset in their affidavits.
- <u>Candidates with Liabilities</u>: A total of 29 candidates out of 60 analyzed have declared liabilities out of which 7 have declared more than Rs. 10 lakhs worth liabilities. Mahesh Singh Yadav of JD(U) from Chatra constituency has declared Rs. 32.81 lakhs worth of liabilities, followed by Manoj Kumar of RJD from Palamau comstituency with Rs. 23.50 lakhs of liabilities and Sundhanshu Suman an Independent candidate from Chatra constituency with liabilities worth Rs. 22.58 lakhs.
- <u>Candidates with High Income (as declared in ITR)</u>: 7 out of 60 candidates analyzed have a declared income of more than Rs. 10 lakhs. Vishnu Dayal Ram of BJP from Palamau constituency has declared the highest income of Rs. 39.89 lakhs followed by Rameshwar Oraon of INC from Lohardaga constituency with an income of Rs. 25.24 lakhs and Nagmani of AJSUP from Chatra constituency with income of Rs. 16.57 lakhs.





- <u>Candidates who have not declared Income Tax Details*</u>: 30 (50%) candidates out of 60 analyzed have not declared income tax details.* Some candidates may be exempted from filing Income Tax Returns.
- *Candidates with High Assets who have not declared Income Tax Details:* 8 candidates with assets worth more than Rs. 30 lakhs, have not declared Income Tax details.
- Undeclared PAN: 21 (35%) out of 60 candidates analysed have not declared their PAN details.


