Analysis of Criminal, Financial and Other Background Details of Candidates from Odisha (Phase – 1) for Lok Sabha 2014

Association of Democratic Reforms (ADR) and Odisha Election Watch (OEW) have analyzed the self-sworn affidavits of 97 out of the 98 candidates (as given by the ECI) who are contesting the 3rd Phase of the Lok Sabha 2014 elections from Odisha. *The affidavit of Das Charan Majhi of Jharkhand Discom Party from Sundargarh constituency was not analysed due to unclear affidavit available on ECI site.*

Executive Summary

Criminal Background

- **Candidates with Criminal Cases:** Out of 97 candidates analysed, **19 candidates (20%)** have declared criminal cases against themselves.

- **Candidates with Serious Criminal Cases:** Out of 97 candidates analyzed, **13 candidates** have declared serious criminal cases including cases related to murder, attempt to murder, dacoity, criminal intimidation etc.

- **Candidates with multiple serious IPC counts:**
Narendra Mohanty of AAP from **Kandhamal** Constituency has declared the highest count of serious IPC charges i.e. **28**. He is followed by **Lambodar Kanhar** an Independent candidate from **Kandhamal** Constituency with 7 serious IPC Counts and **Sangeeta Kumari Singh Deo** of BJP from **Bolangir** Constituency, with **3 IPC Counts**.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party wise Candidates with Criminal Cases:** **4 (40%)** out of **10** candidates fielded by **BJP**, **1 (10%)** out of **10** candidates from **INC**, **2 (20%)** out of **10** candidates of **BJD**, **3 (38%)** out of **8** candidates of **AAP**, **1(10%)** out of **10** of **BSP**, **1 (100%)** out of **1** candidate of **CPI(M)**, and **2 (12%)** of **17 Independent** candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **2 (20%)** out of **10** candidates fielded by **BJP**, **2 (20%)** out of **10** candidates from **BJD**, **3 (38%)** out of **8** candidates of **AAP** and **2(12%)** out of **17 Independent** candidates have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Murder and Attempt to Murder:** **Narendra Mohanty** of AAP from **Kandhamal** constituency has declared **3 charge related to Murder (IPC Section-302)**, **1 charge related to Attempt to Murder (IPC Section-307)** and **1 charge related to Dacoity with Murder(IPC Section-396)**. **Lambodar Kanhar** an Independent candidate from **Kandhamal** constituency has declared **2 charges related to attempt to murder(IPC Section-307)**
- **Candidates with cases related to Crimes Against Women:** 3 candidates have declared cases related to crimes against women. **Lambodar Kanhar** an Independent candidate from **Kandhamal** constituency and **Sukanta Kumar Panigrahi** of **BJP** from **Kandhamal** constituency have declared **cases related to Assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)**. **Ashok Bisi** of **CPI** from **Bargarh** constituency has declared a case related to **Husband or relative of husband of a woman subjecting her to cruelty (IPC Section-498A)**
- **Red Alert Constituencies*:** **2 constituencies Kalahandi and Kandhamal** have at least 3 candidates from political parties with declared criminal cases.
**Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections. This analysis excludes independent candidates with criminal cases.*

Financial Background

- **Crorepati Candidates:** Out of the 97 candidates analysed, **26 (27%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **8(80%)** out of 10 candidates from **INC**, **7(70%)** out of 10 candidates from **BJD**, **4(40%)** out of 10 candidates from **BJP**, **1(13%)** out of 8 candidates from **AAP** and **1(10%)** out of 10 candidates from **BSP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the 2014 Lok Sabha Elections from Odisha (Phase 1) is **Rs.1.62 Crores**.
- **Party-wise Average Assets:** Among major parties, the average asset for 10 **INC** candidates is **Rs 3.28 crores**, 10 **BJP** candidates have an average assets of **Rs.1.72 crores**, 10 **BJD** candidates have average assets of **Rs. 8.32 crores** , 8 **AAP** candidates have average assets of **Rs. 20.34 Lacs** while 10 **BSP** candidates have average assets of **Rs. 39.13 Lacs**.
- **High Asset Candidates:** **8** candidates have more than **5 crores worth of assets**. Total Assets includes Self Assets and Others Assets. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of the 97 contesting candidates analyzed, a total of **17** candidates have declared assets **less than Rs.2 Lakhs**. The three candidates with lowest assets are as follows:

- **Zero Asset Candidates:** 1 candidate, Ashok Mittal of AITC from Bargarh constituency has declared that he has zero assets
- **Candidates who have not given value for Immovable Assets:** **10 candidates** have not given value for atleast one immovable asset declared in their affidavits.
- **Candidates who have dues to Government Departments:** **2 candidates** have declared that they have dues to Government Departments.
- **Candidates with Liabilities:** A total of **15** candidates out of the 97 contesting candidates analyzed have declared liabilities above **Rs. 10 lakhs**. **Kalikesh Narayan Singh Deo** of **BJD** from **Bolangir** constituency has declared liabilities worth **Rs. 2.44 crores** followed by **Dhanada Kanta Mishra** of **AAP** from **Berhampur** constituency with liabilities worth **Rs. 56.62 Lacs** and **Hemendra Chandra Singh** of **BJD** from **Kandhamal** constituency with liabilities worth **Rs. 47.86 Lacs**.

- **Candidates with High Income:** 11 candidates have declared total annual Income of over 10 Lakhs. Amarnath Pradhan of INC from Sambalpur constituency has declared the highest total income of Rs. 44.33 Lakhs followed by Balabhadra Majhi of BJD from Nabarangpur constituency with Rs. 19.89 Lakhs and Kalikesh Narayan Singh Deo of BJD from Bolangir constituency with Rs. 18.85 Lakhs of total income.
**Total income includes income of self, spouse and dependents*
- **Candidates who have not declared Income Tax Details*:** 53 (55%) candidates out of the 97 contesting candidates analyzed have not declared income tax details. ** Some candidates may be exempted from filing Income Tax Returns*
- **Candidates with High Assets who have not declared Income Tax Details:** 5 candidates with assets worth more than Rs. 1 crore, have not declared Income Tax Details.
- **Undeclared PAN:** 25(26%) out of the 97 contesting candidates analyzed have not declared their PAN details.

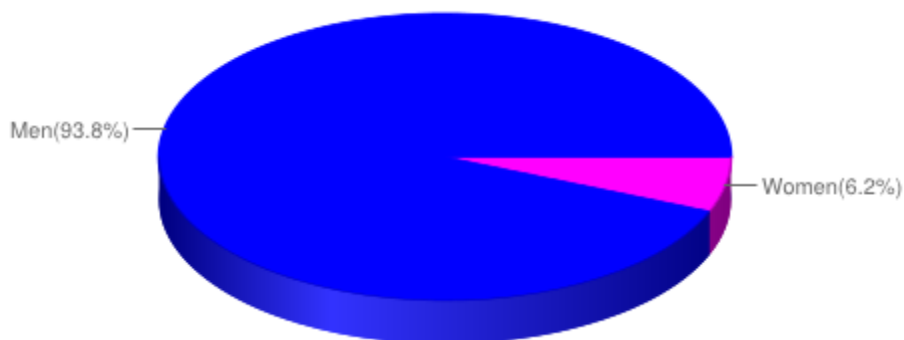
