Executive Summary – Phase 1

Criminal Background

- **Candidates with Criminal Cases:** Out of the 146 candidates analysed, **33 candidates (23%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 146 candidates, **26 candidates (18%)** have declared serious criminal cases relating to murder, attempt to murder, rape, kidnapping, dacoity, robbery etc.
- **Candidates with multiple serious IPC counts:** A total of 20 candidates have declared multiple serious IPC counts of which **Yogesh Kumar** of **AAP** from Saharanpur Constituency has declared the highest count of **serious IPC charges i.e. 12** followed by **Dr Himanshu Singh** of AAP from Meerut constituency with 10 serious IPC charges and **Shahnawaj Rana** of **SP** from Bijnor constituency, with 9 serious IPC charges.
- **Party wise Candidates with Criminal Cases:** **4 (67%) of 6** candidates fielded by **INC**, **6 (60%) out of 10** candidates from **BJP**, **5 (50%) out of 10** candidates from **SP** and **3 (30%)** out of 10 candidates of **AAP** have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **4 (67%) of 6** candidates fielded by **INC**, **4 (40%) of 10** candidates fielded by **SP**, **3 (30%) out of 10** candidates of **BSP** and **2 (20%)** out of 10 candidates of **AAP** have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Murder :** 2 candidates have declared cases related to murder. **Kadir Rana**, from Muzaffarnagar constituency and **Pradeep Kumar Jatav**, from Bulandshahr constituency both of whom are from **BSP** have each declared 1 charge **related to murder(IPC Section-302)**
- **Candidates with cases related to Attempt to Murder:** **6 candidates** have declared cases related to attempt to murder
- **Candidates with cases related to Rape:** **Shahnawaj Rana**, an SP candidate from Bijnor constituency has declared 1 charge related to rape (IPC Section 376).
- **Red Alert Constituencies*:** 7 out of 10 constituencies in Uttar Pradesh (Phase – 1) have at least 3 candidates with declared criminal cases. They are Ghaziabad, Saharanpur, Bijnor, Meerut, Muzaffarnagar, Kairana and Gautam Buddha Nagar.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

*Red Alert Constituencies are those which have 3 or more candidates with criminal cases standing up for elections..

Financial Background

- **Crorepati Candidates:** Out of the 146 candidates, **65 (45%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **All 10** candidates of **BSP**, **all 6** candidates of **INC**, **9 (90%)** out of 10 candidates of **BJP** and **SP**, **8 (80%)** out of 10 candidates of **AAP** and **3 (75%)** out of 4 candidates of **RLD** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average asset per candidate contesting from Uttar Pradesh – Phase 1 in Lok Sabha 2014 elections is **Rs. 7.42 crores**.
- **Party-wise Average Assets:** Among major parties, the average asset of **10 BSP** candidates is **Rs 62.23 crores**, **10 SP** candidates have an average assets of **Rs 11.11 crores**, **10 BJP** candidates have **Rs 7.56 crores** and **10 AAP** candidates have average asset of **Rs. 5.41 crores**.
- **High Asset Candidates:** **11** candidates have more than **Rs. 20 crore worth of assets**. Total assets include Self Assets and Others' Assets. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of 146 candidates analysed, a total of **13** candidates have declared assets **less than Rs 1 lakh**. The top three candidates with lowest assets are as follows:

- **Candidates who have not given value for Immovable Assets:** **24** candidates out of **146** contesting in Uttar Pradesh (Phase – 1) Lok Sabha Elections have not given value for atleast 1 immovable assets that they have declared in their affidavits.
- **Candidates who have dues to Government Departments:** **7** out of **146** contesting candidates have declared dues to various Government departments
- **Candidates with Liabilities:** A total of 58 candidates out of 146 have declared liabilities **out of which 15** candidates have declared liabilities **above Rs 50 lakhs**. **Satish Kumar** of **BSP** from Gautam Budhha Nagar constituency has declared liabilities of **Rs. 20.14 crores** followed by **M.Shahid** of **BSP** from Meerut constituency with liabilities of **Rs 10.38 crores** and **Shahnawaj Rana** of **SP** from Bijnor constituency declaring total liabilities of **Rs 5.43 crores**
- **Candidates with High Income:** A total of 83 candidates have declared their income tax details **out of which 9** candidates have declared a total income of more than **Rs 50 lakhs**. **Malook Nagar** of **BSP** from Bijnor constituency has declared the highest total income of **Rs 13.11 crores** followed by **Zafar Alam** of **SP** from

Aligarh constituency with a total income of Rs 2.08 crores and Mahesh Sharma of BJP from Gautam Budhha Nagar constituency with a total income of Rs. 1.83 crores.

- **Candidates who have not declared Income Tax Details*:** 63 (43%) candidates out of 146 analyzed have not declared income tax details. *Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details:** 16 candidates out of 146 candidates have declared asset value of more than Rs 50 lakhs but have not declared Income Tax Details.
- **Undeclared PAN:** 34 (23%) out of 146 candidates analysed have not declared their PAN details.


