Executive Summary (Phase 2)

Criminal Background

- **Candidates with Criminal Cases:** Out of 50 contesting candidates, **5 candidates (10%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 50 contesting candidates, **3 candidates (6%)** have declared serious criminal cases including cases related to forgery, cheating and criminal intimidation.
- **Party wise Candidates with Criminal Cases:** **2 (67%)** out of **3** candidates fielded by **INC**, **1 (33%)** out of **3** candidates from **GGP**, **1 (100%)** out of **1** candidate of **Apna Dal**, and **1 (100%)** out of **1** candidates from **CPI**, have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **1** candidate each from **INC**, **GGP** and **Apna Dal** have declared serious criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepati Candidates:** Out of the 50 contesting candidates, **11 (22%)** are crorepatis.
- **Party-wise Crorepati Candidates:** All **3** candidates from **BJP**, **2(67%)** out of 3 candidates from **INC**, **1(100%)** out of 1 candidate each from **SP** and **Apna Dal**, **1(33%)** out of 3 candidates from **AAP** and **BSP** and **2(8%)** of **26 Independent** candidates have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the second phase of elections from Chhattisgarh for Lok Sabha 2014 is **Rs.77.58 Lakhs**.
- **Party-wise Average Assets:** Among major parties, the average assets for 3 **BJP** candidates is **Rs 2.94 crores**, 3 **INC** candidates have average assets of **Rs.2.91 crores**, 3 **BSP** candidates have average assets of **Rs. 1.67 crores** while 3 **AAP** candidates is **Rs. 50.48 Lakhs**.
- **High Asset Candidates:** **7** out of the 50 contesting candidates have more than **Rs. 2 Crore worth of assets**. Total Assets includes Self Assets and Others Assets. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of the 50 contesting candidates analyzed, a total of **8** candidates have declared assets **less than Rs.2 Lakh**. The three candidates with lowest assets are as follows:

- **Candidates with Liabilities:** A total of **14** candidates out of the 50 contesting candidates analyzed have declared liabilities above **Rs. 2 lakhs**. **Bhaskar Dwivedi** of AAP from Rajnandgaon constituency has declared liabilities worth **Rs. 48.14 Lakhs** followed by **Chandu Lal Sahu** of BJP from Mahasamund constituency with liabilities worth **Rs. 27 Lakhs** and **Ajit Pramod Kumar Jogi** of INC from Mahasamund constituency with liabilities worth **Rs. 15 Lakhs**.
- **Candidates with High Income:** **6** candidates have declared total annual Income of **over Rs. 5 Lakhs**. **Abhishek Singh** of BJP from Rajnandgaon constituency has declared the highest total income of **Rs. 26.49 Lakhs** followed by **Ajit Pramod Kumar Jogi** of INC from Mahasamund constituency with **Rs. 10.05 Lakhs** and **Malik Ram Thakur** of Ambedkarite Party of India from Kanker constituency with **Rs. 9.15 Lakhs** of total income. **Total income includes self, spouse and dependents*
- **Candidates who have not declared Income Tax Details*:** **35 (70%)** candidates out of the 50 contesting candidates analyzed have not declared income tax details. ** Some candidates may be exempted from filing Income Tax Returns*
- **Candidates with High Assets who have not declared Income Tax Details:** **10** candidates with assets worth more than Rs. 40 Lakhs, have not declared Income Tax Details.
- **Undeclared PAN:** **23(46%)** out of the 50 contesting candidates have not declared their PAN details.

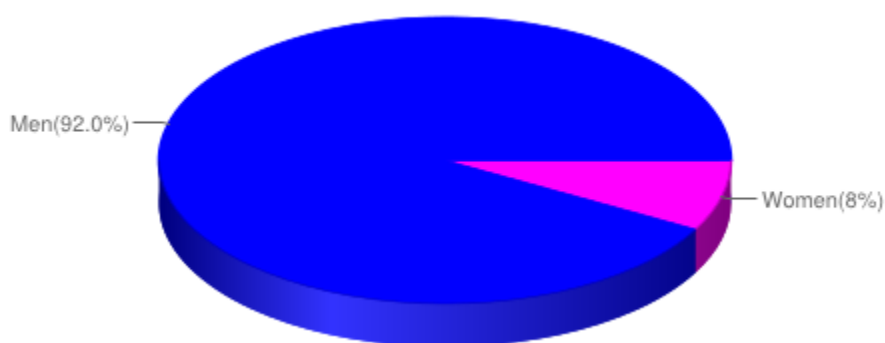
